2. Howe Sound Race

 Discussion regarding the addition of a 6th race to the Canadian National series. General discussion felt that the series would be diluted if increased to 6 races. Further discussion on the higher cost of participating in the HSI compared to other event races. Donna's concern that attendance will be lower if HSI is not included in the series and perhaps the club hosting the National should not host an additional race included as part of the series.

Action Item: Jan will discuss with Jericho Club and Lynn of Western Canoes for next meeting

3. Insurance

All clubs hosting a CORA sanctioned event need to apply for a Certificate of Insurance. This document will be requested by the Harbour Master or governing body where the event will be hosted from.

Paddlers are covered for race practices when club is a member of Cora. If individual paddlers are not Cora members ** they are not covered ** Recreational paddlers need to be covered under separate club insurance usually purchased from All Sports.

Confirmation that Junior membership rate is \$10.00

Action Items: Lisa will follow up on Safety Guideline booklet. Cindy will contact all race directors of the need for this Certificate.

4. High School Team event for Howe Sound Iron

Lynne at Western Canoe would like to organize a High School (Junior) event at the next HSI. General discussion felt this was a good idea to promote more youth involvement and thought a short sprint race similar to the corporate race format would work well during the Saturday race day.

Action Item: All board members should challenge their local and surrounding clubs to form junior teams to participate in this race.

5. **Boat Weights**

Discussion for the need to weigh boats yearly, and who should do this. General discussion decided that boats should be weighed once a year as boat weight does change. Also decided that the yearly weigh-in should happen at the Canadian National Championship the evening prior to race day. The cost will be paid by CORA in the keeping of a Central Registry.

6. CORA Sprints Web Page

Discussion that the new web page would be ongoing for this and future sprinting event. Sometime during this year, executive will need to develop a policy to handle sponsorship requests.

Old Business

New Business

1. Sunshine Coast Team Penalties – A invoice in the amount of \$300 was received from the New Zealand Waka Ama Association in relation to a no show for 3 races set for the Sunshine Coast Team. The penalty has been paid by Cora and a letter sent to each member of the Sunshine Coast Team asking for reimbursement. The letter indicated that racing in Cora sanctioned events would be jeopardized from non-payment.

2. 2006 World Sprints

- * Debriefing of 2006 Donna has offered to canvass sprint races for input and comments on 2006 races covering all aspects related to attending such an event. This information can be used to assist future volunteers for upcoming World events. To be presented at next meeting.
- * Cora's future role How to move forward for strong Canadian team for 2008 thru to 2012. Promotion of Sprints, formation of Sprint committee with

a liaison on the Cora board and candidates for the IVF/AC Rep are now being discussed. John Roberts has submitted a comprehensive working paper discussing how Canada can build sprint racing from now until 2012. Neda Joss who will be on the Penticton committee for 2012 has also asked for Cora's involvement.

It was decided the first step to promote would be a poster and information talk at some of the major race venues. First venue to be Duel in the Desert. Steve Palmier has offered to create a poster to make racers aware. Dave Del Rizzo will speak with John on further ideas. It was suggested we ask the membership who would be interested in forming a sprint committee to work together on development.

Old Business

Sprints Initiative – Formation of new Sprint Council. Dave, Jan, Florida and Jan attended a teleconference with John Roberts, Lynda Roberts, Nancy Botting (Wai Nui Canoe Club), and Wendy Perkins (Wai Nui Canoe Club). The core group will be: John – Chairman, Donna – Cora Liaison, Sheila Kuyper. A representative from each area will communicate to area clubs and other committees will be tasked. Hugh and Florida are spear heading Junior Development. John will have a full report of the council's direction ready for the AGM.

• Coaching Clinics Waters Edge was hired to perform the steering clinic on Sunday after Bridges race. The maximum size for the clinic would need to be 18 paddlers. Since the costs were higher than Cora's clinic budget allowed (\$50 / paddler), it was decided to discount the rate to \$35 / paddler. Cora's cost will be \$270 (\$15 x 18). Canoes, coach boat and meeting room was also required and supplied by Ocean River. Cora to reimburse for the cost of the coach boat if needed.

There followed a group discussion regarding the intent of Cora sponsored clinics. Original intent was to offer free clinics to as many paddlers as possible. Because this clinic was on water as well as classroom. Waters Edge gave a maximum of 18 paddlers. This created a waiting list of paddlers who wished to attend. It was felt that there may have been other options to provide a steering clinic that did not require so much effort from the club or cost to paddlers.

It was decided that future clinics may involve costs and/or maximum attendance, but should be discussed by the board before advertising.

- Race Survey There were approximately 35 responses to the survey. As
 there were several responses to each question, Jan will give each board
 member a question to summarize. The survey will then be complied for
 deliver to race directors to assist with their 2007 race schedules.
- Annual General Meeting Donna will produce the agenda's for the AGM and Technical meeting based on last years format and the addition of agenda items as discussed. Change of bylaws to extend board members terms to 2 years will be added as well as a proper resolution vote for last year's change to the number of Directors required for the board.
- **Featured Paddlers** Donna provided 2 feature paddler interviews taken at the Lotus Sprints. Dave will do the same at the Bridges race.

New Business

Financial Report – Jan reported we have \$12,000 currently in the account. It has been recommended that we purchase (2) \$5,000 term deposits to reestablish the contingency fund. Money was needed last year from the reserves to pay for increased insurance costs. Insurance costs did not increase this year.

Penticton 2012 Committee - Dave will arrange an online meeting with the principal people for this committee prior to the AGM. Brent Bagnell, Alan Carlsson, Neda Jos, and Donna Harrison to attend. The 2012 committee would like prior confirmation from Cora to proceed with funding and sponsorship. Cora would like to ascertain the goals and intentions of the committee prior to commitment. Donna will draft a reporting structure.

Eastern Regional Cora Rep – Donna has asked members of the Eastern clubs to canvass for someone to sit on next year's Cora board.

Junior Development – Florida is talking with schools on the possibility of introducing outrigger canoe. There are many factors that need to be explored and Florida will provide a short report on progress at the AGM.

Technical Meeting Topics – Donna will provide an agenda for this meeting. There was discussion regarding overlapping races for the 2007 schedule and how the board would determine which race to sanction. Jan will review the race requests prior to the meeting and if needed discuss with the board online.

Old Business

Membership Report – Jan has updated all online forms to reflect the new daily fee and the overdue fee for club fees paid after May 1st. Jan has also provided some Cora Notes that are valuable for new executives.

ACTION ITEM: Need to locate someone from the Interior to help record membership fees for this area. Donna will ask Kathyrn Ginther and Dave Del Rizzo

Communication Report – Donna will be adding a Featured Paddler form for download by anyone wanting to approach paddlers during races or club meetings.

New Business

A new teleconference number has been obtained specifically for Cora's use. The invoice will be sent to Cora directly from Telus. The cost is currently .25 per minute. A contract rate of 10 cents per minute is available but we must commit to spending \$2000 per year. We do not intend on spending this amount.

ACTION: Donna will contact Telus to determine if the invoice can be autodebited. Carmen would just need to confirm date and time for monthly statements.

Malia Mold - The mold being stored at the Calmar site will be moved to Lotus's clubhouse for storage. Doug was able to find some good history on the origin of the Malia mold and it was determined it should be preserved.

The history will be confirmed and shared with all Cora members.

Insurance coverage for clinics - Lotus has been asked to provide proof of insurance by the City of Coquitlam for water clinics hosted by Lotus.

ACTION: Donna will contact AllSport and ask they send a letter confirming proof of insurance

Doug asked question regarding Cora providing insurance for Dragon Boats. This was discussed at previous meetings and during the AGM. It was confirmed that Dragon boats are not covered under the Outrigger Canoe policy.

CKC Opportunity - There is an opportunity for major funding if we have some tie to CKC. It has been suggested to the Sprint Council to pursue this with a conversation between Cora and CKC. It is understood there may be some negative member history from wanting Cora to become a National Sports Organization under CKC umbrella. This is not the intent of discussions.

ACTION: Donna will be contacting the CKC B.C. Rep for opportunity discussions in the New Year.
