Safety Report

Doug Mancell provided the backgrounder and overview for the building and evolution of the safety manual.

Policy for Future Boards Regarding the Safety Manual

In order to prevent future boards from revising the safety manual to reflect lesser standards, it was agreed all revisions should be vetted using legal advice.

Sprint Report: Donna Harrison

Review of Results 15 medals 1 gold (which was also a WR) 8 silver 6 bronze

The national selection process allowed for national boats and club crews to be able form the strongest Team Canada.

34 Finals

The goal is to continue to build a strong sprint contingency as we build into 2012. New Caledonia is 2010 with the time trials/Nationals in October 2008. Goal forward is Penticton 2012 with the Penticton coming online and have offered resources to assist with the development and promotion of the event.

Insurance

Discussion

In September, All Sport approached CORA wanting to update its records to get a firmer picture of "what they were protecting." This led to the questionnaire on the 2009 Club Membership form. It also came to light that All Sport had little understanding on how CORA actually operated which led to All Sport reconsidering the risk that CORAs operations presented, namely the issue of Clubs reporting only "racing" members and <u>what the risk "non-members"</u> presented to them (primarily from clubs without secondary insurance). They see the recreational paddler who may belong to a CORA club, but individually is not a CORA members, as an unnecessary risk. Unfortunately, there has been a pervasive assumption (which is incorrect) in the paddling community that you do not have to personally belong to CORA if you do not race, and the vocal complaints to All Sport by recreational paddlers has caused All Sport concern.

As a result, All Sport presented three options to CORA:

- Option 1: CORA purchase an insurance policy with protection limits as shown above. The policy defends only the 8 Board Members for their Organizational & Administrative duties and does not include the operation of any Paddling activity. All Sport Insurance have minimum policy premiums. The minimum on \$5M is \$3,500.
- Option 2: CORA purchase an insurance policy with protection limits as shown above. The policy defends the 8 Board Members for their Org & Admin duties and INCLUDES the operation of 39 Outrigger Races annually with approx 200 Paddlers at each. The 200 Paddlers at each Race consist only of the 1,000 "Members" listed on the current policy we have with you. Calculated premium: \$3,900.

 Option 3: CORA purchase an insurance policy with protection limits as shown above. The policy protects CORA & its Board along with the 28 Member Clubs and each of their Boards. Protection extends to the 39 annual Races with 200 Paddlers per (comprised of the current 1,000 Racing Paddlers currently listed on the policy) for a total of 7,800 Racing Paddlers (Bodies). Protection also extends to the 28 Member Clubs with an estimated 200 "Recreational Paddlers" each for an additional 5,400 Bodies. The Operations budget for CORA is estimated at \$19,00, with an average estimate of \$15,000.00 operating budget per club. Estimated cost based on average number of "recreational paddlers: \$15,000.

The issue is that any option other than option 3 leaves the clubs vulnerable by forcing them to either cease operations or purchase their own individual insurance at considerable cost.

CORA and the members at the AGM accept the Option #3 put forth by All Sport to provide liability insurance for CORA Board, Clubs and Individual paddlers for the year 2010: Cindy Wright Seconded: Shane Martin Discussion Carried unanimously

Discussion

Meghan Macdougall in discussion with Adrienne Scott via telephone, was able to clarifiy some of the budget items. The budget for 2009 is based on no growth, should we approve the budget as is as it includes an increase in membership fees for individuals and for clubs and that a second increase next year. The new board will be tasked with determining how the future increases should be clarified to the membership and administered in order to allow for a recouping of the insurance premiums from the fees and also address the enforcing of clubs on their paddlers to pay their CORA Individual membership fees.

Motion to increase of \$5.00 (from \$20.00 to \$25.00) for individual membership and \$50.00 (from \$75.00 to \$125.00) for club membership fees: Meghan Megdougall Second: Doug Mancell Carried unanimoustly Motion: To accept the revised tabled budget presented by Meghan Mac. for the 2009 fiscal year.
