#### **CORA Grants**

During April an RME grant was received from the Maple Bay Canoe Club for \$750. This grant was approved via email during the month.

## **Financials**

Sharon presented financials for the first 3 months of 2012. As most of the income for the year is coming in now with few expenses the financials look very good. CORA paid out 1 clinic grant last month and there are 3 approved RME grants to be paid out upon receiving the expense receipts from the Clubs.

# **Memberships**

#### **Sprint Update**

Tourism Burnaby has given CORA a grant for holding our time trails at Burnaby Lake. A cheque for \$500 has been received with thanks.

CORA will be collecting the uniform fees for the Canadian paddlers who are going to the World Sprints. This money will flow through CORA to Calgary who is fronting the cost of the uniforms for us. There may be a small profit for CORA by doing this.

# Outrigger videos

A member brought to forward a question of paddlers using video cameras on their boats and privacy concerns where these may be published. The Board agreed that since this video was being taken in a public place we have no way to deal with such cases.

### **CORA Website maintenance and cost**

Our website is requiring constant maintenance and updating. Colleen the website developer is going to be retained to keep the site up to date. A final monthly cost will be determined and presented for next month. This new cost will come under our marketing budget.

# 2012 Team Canada and Calgary Sprint Report – by Donna Harrison (Sept 2012)

**Time Trials** in June were held over 2 days. The venue and race course were well suited for our event and should be used for future time trials. Permits for use of the pavilion, and waterway were obtained through the City of Burnaby, and help from the Burnaby Canoe Kayak group to setup the race course was well worth it. The total cost to hold the time trials with permits and setup was \$2,073.00. This was offset by charging the participants \$15 to attend time trial and \$10 IVF initial fee. We had ~ 275 people attend which gave revenue of \$4,125.00. We had a great team of experienced volunteers from many CORA clubs.

Kimberley Hanson setup a food booth in the pavilion and provided food and drink on both days. This was well received.

Course flags and motor boats were provided, while Calgary Canoe club generously provided excellent, boat numbers, timing gear and walkie talkies. We used personal binoculars and video cameras, which were a 'must'.

V1's were provided by CCC and the Worlds Organizing committee as well as Pogue sports. OC1's were provided by False Creek Canoe Club and a couple personal boats. OC1's and V1's were pre-weighed.

Kamini created the trial format to allow racers to have semi and finals, which gave a better overall look at performance. Kamini, Graham Smith and Hugh Fisher then used the results to create the National crews. Most racers did time trial regardless if they were part of a pre-established crew. This was a good choice as it provided them the opportunity to also be in a National crew if they wanted.

**Team Canada Uniforms** - Calgary Canoe club generously purchased our jerseys by ordering a surplus. We were able to hand out uniforms within 6 weeks of determining our final team. This was necessary as our time trials were held quite late to assure everyone had time to train on the water. (Interior, Alberta and Ontario regions)

CORA purchased the team hats, with a surplus that we were able to sell at a larger profit (\$25 to team - \$35 to public). We collected payment from each member mostly through our CORA Pay pal account with a small profit that covered off a transaction charge of 1.5% by Pay pal, and in some cases, it was necessary to ship uniforms via courier. Several extra hats and jerseys were purchased by team members by cash and cheque. In the end, a few too many large jerseys were sold to Vancouver members, and left Calgary members short changed. It was necessary to do a few refunds and have those people supply their extra shirt to the Calgary member. In the end, we sold 594 uniforms and the remainder was sold to the public by CCC at a larger profit. It was agreed to share our profit with CCC as they took the risk in purchasing the 815 jerseys. We are repaying them \$34.50 per jersey

Some pre-established crews did dissolve to create stronger National crews, while other PE crews remained in tack as the fastest crews. Some PE crews who lost members struggled to replace and used paddlers who did not make top crews. This was not the purpose of PE crews and we will look at a clearer definition of the purpose of a PE crew. There was no need for a race off of V6 as there were less than 5 PE crews per category (4 was the max)

The final Team Canada consisted of 250 paddlers with 89 women, 91 men and 70 juniors. This was the 3rd largest contingency attending Calgary. 316 – Hawaii, 262 – New Zealand, 250 – Canada.

The final IVF fees of \$50 per paddler were collected and the total \$60 x 250 was issued to Calgary Canoe Club. The total event race fees are split \$15 IVF / \$45 HOST and therefore all monies collected by Canada were issued to CCC to offset the IVF due.

**Team Canada Camp** – was run by Right Angle Performance with a CORA subsidy of \$1000 for the paddlers to attend at a reasonable cost. Over 100 team members attended and became familiar with sprint rules and turn strategies. It is important to provide our racers the resources to develop and improve.

2 junior camps were held by Pemberton and Penticton clubs with Hugh Fisher attended both. We agreed to pay expenses to the club who hosted the camp.

**Calgary World Sprints** – was a huge success. The attendance was one of the largest to date with over 1200 paddlers. The venue was well setup and the race course was fair with even depth across all lanes. IVF officials were available for timing, protest and appeals committee. The IVF timing and check in system was utilized and provided undisputed race video, as well as real time posting and race streaming video for the world to watch real time.

Many countries such as New Zealand remarked on how well and on time the event was run. Although many did understand CCC was running the event, many of the countries credit CORA for providing this world class event.

There were some unusual and sad events. A Hawaiian Kupuna paddler passed during the final race, which was handled extremely well by the race director and volunteers, and brought all the countries together to honor this paddler in a way that has never been seen. Also, Tahiti was unable to attend because of an airline strike. This did play a factor on medal count, but overall, Canada still shows as a world contender.

The awards were staggered over the 5 days, with the cultural night and free Paddler BBQ mid-way. The closing ceremonies was the only event that suffered due to the final races having to run up until 8 PM, and most countries collecting medals and leaving to attend the after party.

**2014 Rio De Janeiro World Sprints** - The next Worlds will be held in Rio 3rd week of August 2014, with the Rio Va'a distance race to run immediately afterwards.

The format has changed to give higher validity as a World Event. The first 2 days will be for performance paddlers only, with each country allowed (1) V1 paddler per category and (1) V6 per category. We will need to focus on our elite paddlers to field a strong contingency.

The last 3 days are formatted more of a club crew idea. We will still have national crews, but they will be more focused to developing and participating type paddlers. Over the next few months the Sprint Council will be discussing how to re-format our selection process.
