Race and Event

The event was well organized with a traditional Opening Ceremony and parade, and Cultural Night event. The product and clothing vendors and food outlets were good. The race venue was great for spectators and paddlers. Event volunteers did a great job assisting paddlers throughout the event.

Unfortunately, the officiating and race course caused some issues. The course lane width was approved at 11/22m, which is technically less than the IVF rules width of 12.5/25m. However,

the course did not have buoys at regular intervals (requested for 50m) therefore paddlers did go out of their lanes more often and officials were very tough on calling this infraction. There were a higher number of disqualifications for all countries. There were a few other issues with the officials that have been noted with IVF.

Lynda will be discussing this and the intent is for IVF to have more responsibility in regards to working with the host and setting clear guidelines that must be followed at the October IVF meetings in Honolulu. We will also vote on the 2020 bid at this meeting. Canada is now a Group B voting member and we have a larger voice to make positive changes with IVF. Lynda plans to stay involved on the Race and Rules Committee, if not more of a Director role.

Elite and Team Events

With the additional days for Elite racing, the event was much longer for all paddlers as we arrived early for practice days. In future, we would not encourage club teams to come as early as practices were very minimal with only ½ hour for each crew. This was due to the increase of the Elite teams also requiring practice. Although this allowed some paddlers to have days off for sightseeing, it did increase the costs to our paddlers who were budget minded. In total there were 3 practice days and 8 racing days including Elite racing.

Club Crews vs Elite

Going forward, CORA may need to address how to promote and motivate paddlers to attend as an Elite Crew or participate as Club crews. The concept has been modified with separating Country teams (Elite) from Club teams. This makes it harder for countries that have smaller clubs.

Although a time trial is required for V1 and Elite, there may be better ways to time trial for club crews as those who time trial often drop out diminishing the strength of the crews.

One example that was explored in the past is to create "Regional Designated" clubs. Example Fairway Gorge has a good sprint location, and coaches that CORA could 'help out' with developing sprint teams. If you live on Vancouver Island, this could be the club to practice with and build stronger sprint teams. A similar club would be designated for Mainland, Interior, Alberta and Eastern Canada. This would allow for individual paddlers to have a viable way to practice with crews, belong to the club and encourage larger, stronger groups to participate under that club name.

2017 IVF Long Distance Team Selection Update

Almost 50 paddlers have showed interest as of today. The selection committee consists of Lynda assisted by James Hill and Kamini Jain. A \$20 nonrefundable commitment fee has been proposed to continue with selection and participation. The organizers in Tahiti need commitment from the countries by June 15, 2016. Time trials are being considered for the same weekend as Gibsons, on the Friday. Lynda will send additional information to the board shortly.

IVF AGM, Honolulu Oct 10-12, 2016 Lynda will attend.

b. Financials/Treasurer Update - Rob
