Change – Travel Grant for CORA CUP races only, Approved with change.

D) Insurance Update

Rob met with All Sport, managed to get better coverage for less money. When someone steps their foot in an outrigger and goes out, they should be insured. In the past you needed to sign a waiver and pay \$25, this protects all paddlers, guest paddlers included (practices only). Blanket coverage for over 1,300.

CORA sanctioned event is an event that this board and/or future board agrees is a real race. If you are traveling and it's a sanctioned race, and you inform CORA you are travelling out of the country there is coverage. If you go to Hawaii or California and it's a real race, send a list of paddlers to CORA and you will be covered under the All Sport coverage (CORA will forward list to All Sport). Concern for out of country races where conditions may be rough, what if there was a claim that would increase overall rates for Canadian racers for an out of country race? May be easier to pay \$10 and get separate individual coverage. One of the reasons for CORA is to protect the paddlers. Third party liability insurance – you have to prove negligence.

Alcohol at events – we were covered to have social events that included award banquets. (50 table at hotel with podium) They have re-worded to include social

events wherever they happen, if there is going to be alcohol present and served, we must get a separate insurance policy from All Sport. Clarification needed for awards held at licensed premises.

If clubs have not taken out insurance, can your paddlers be insured? Yes, it is considered individual membership regardless of the club. Prepaying the insurance ensures coverage; possible idea brought up to have all clubs pre pay next year membership dues at the AGM.

a. Strategic Plan

What does CORA look like in 10 years? Leanne to start off with a few thoughts and we will build on.

b. CKC

If you are over the age of 24, you are not required. They are looking for young Olympic athlete potentials. They want our membership but they don't know what to do with us. Focus is on Olympic development.

Paralympics are now bringing outrigger sprints as a demonstration sport. This will gives us access and credibility. Is this something we should take on? If partnering with CKC we bring a great deal of knowledge to them. We could possibly use B, provincially, to determine what both sides could gain. (i.e. – couching modules) Prior stumbling block with BC-CKC was our safety policies.

What legacy do we want to leave for future boards - we have in the past tried to have conversations with CKC and this is where we should continue, this can determine territories (who does what.) Need to start communication with Donna to get kids excited about Calgary! We must have a junior team for Calgary. We need an affiliation with a NSO to get kids involved. We need this to get funding to support junior programs.

Rob is going to call BC CKC and start a conversation with Mary Jane regarding this model and the possibility in other provinces.

H) Sprint Updates (Attachment from Donna)

Regional Sprint Development = Discussion with regards to how the \$4,000 budget was created? Looked at prior year's expenses and came up with an amount. Donna does not have a bank card; money will be given to Donna once expenses are submitted. Discussion took place with having Donna create a budget to justify this amount; however, with control over the account, full details will be accessible by the board so this is not necessary.

Calgary 2012 World Sprints = 10,000 seed money - 5,000 grant and 5,000 forgivable loan (Only paid back if event is profitable.) End of the games 5,000 chq should be paid back as well as 50% of any additional profit.

Need to find a copy of the signed agreement between Calgary and CORA.

Wording clarification sent to Donna to ensure a concise cohesive document is created to reduce any misunderstandings from readers.

Updates from Calgary regarding the 2012 Sprints was discussed, we will see what comes from the meeting in May and then request updates specifically closer to the event.

N) Interesting Insurance Conundrum

OC1's are usually covered under her home insurance for theft and damage, attached as a rider on the policy. Boats are insured if you move it to a club, but not insured if you are racing. CORA does not cover boat insurance; it is only third party liability.

E) Financials

- Membership fees went up \$3,000 on the Income Statement resulting from an excel sheet error
- Sprint negative amounts will be cleared out in 2011 now that we have a separate Sprint account. \$4,000 transferred into that account, and a \$10,000 cheque being sent to Calgary for the Sprints.
- Discussion about possibly doing short term cashable term deposits

Rob motioned to approve the Financial Statements for the year ending December 2010 as revised, seconded by Cindy.

- 748 paddlers paid, 27 Clubs
- Discussion took place about creating a policy document for new clubs to inform them of the rules and regulations of being a CORA member

G) Sprint Update - E-mail was sent out prior to meeting (March Report attached)

- 1. VF Meeting in Calgary last weekend of May, Donna is looking for approval for her and either Rob or Leanne to attend. Included in the \$4,000 sprint budget. Rob would only be able to attend the Sunday due to the Jericho race, Leanne does not know if she is able to attend.
- **2.** Move Western Championships (junior time trials) to Calgary October 1-2. Idea to have a dry run through before hosting the Nationals.

This is just a sprint regatta with the junior time trials. Official team trial will be in May and is determined by the amount of paddlers in each region. There are some negative responses to one time trial; however, it was discussed and concluded that different time trials in different regions are too difficult to compare.

Discussion took place with regards to CORA not being in the loop of the ideas and decisions of the Sprint Counsel. It was agreed that the ideas are good, but the ideas need to be vetted by 3 or 4 regional paddlers to ensure paddlers are supporting their decisions.

We need to have the Sprints promoted!

Rob motioned to move the Western Championships to Calgary, seconded by Leanne.

3. Training opportunities, regional Sprint Training Proposal turned down by prior board, instead of regional training centres; we will give a grant for people who do not have access to those clubs that have the boats.

No one knows about the \$500 grant, people are confused at this time. Cindy is going to draft up a form. \$500 per club for those clubs who have non-club CORA members using their boats for training purposes. To subsidize repairs and damage to those boats used for sprint training. This will be distributed accordingly, it is not a flat \$500 grant to each club with the race boats.

H) Strategic Plan - Summary of Meeting

Rob, Leanne, Aileen and Sharon (Grace and Doug from Lotus sat in for the first part of the meeting)

1. Coaching Development

CORA should develop a coaching module to develop a consistent standard level of coaching. Most National Associations own the certification process; we need to ensure that whoever writes this it must result in CORA owing the certification

process. Whoever writes it is under contract to develop a national certifiable standard.

NSO - If we become affiliated with one, we will have access to their coaching modules.

2. Youth Development

This needs to be promoted as a 'Sport for Life,' it needs to be strategic, we can not just throw money at the clubs to encourage them to develop youth programs. If we had certified coaches, we could eventually be able to better strategically plan this. A review of the demographics will be conducted to see the avg. ages of NEW paddlers.

3. National team program for Distance Paddlers

Outrigger is built on the backs of the club; club input is required before further consideration. It could result in internal strife within the clubs for taking top paddlers to go race with the National distance team.

4. Public Presence

CORA needs a public presence to inform the public of what we do and who we are. How do we increase exposure? Local papers notified of events, club signs? A post will go up on the CORA page looking for someone with Marketing and Public Relations experience to assist CORA in increasing their public awareness.

Challenge to promoting the sport includes different club challenges:

- Lack of novice programs
- Resources and Infrastructure
- Coaching

I) CKC

• Coaching Module

Cindy contacted Alan Carlson who was meeting MJ the next day. Initial hesitation was a result of CKC not knowing what to do with CORA as an entity. Now with the Paralympics CKC and CKVC are looking very positively at the ability to form some sort of alliance with CORA.

With respect to the Victoria Youth Paddling Club, Entry Level Competitive Coach (ELCC) has a sprint component. Alan is coming to teach an ELCC with a slightly bigger focus on Outrigger. Cindy will sit in and audit the training in May. Rob will contact Rod and/or MJ to continue communication.

March 2011 - Team Canada 2012 Sprint Report

Budget Breakdown - \$4,000 was slotted for the 2011 budget and to be deposited to the new sprint account. The account will allow better records of money deposited and expenses paid. All revenues collected for time trial registrations, racing fees and team uniforms will be deposited to this account by the assigned depositor. All expenses approved for payment will be written against this account. PayPal deposits from sprint revenue will also be directed to this new account.

\$10,000 donation/loan is a separate item approved and should have been sent to Calgary Canoe Club.

CORA has usually sent an IVF representative to the IVF AGM's as Canada has one vote. As we are hosting next year, I would like to recommend that we also have either the President or Vice attend.

Junior Time Trials - To save the traveling costs in 2012 to time trials and world sprint event, we would like to hold the junior time trials during the Championship races. This will give juniors the opportunity to train and plan longer for August 2012. All other categories will have their time trial in May 2012.

Top Eastern and Western Juniors will be assigned to their national teams during the practice days prior to the world event based on times. Any juniors who wish to stay with a pre-established team may also do so and forgo being in the top national boat.

I will be contacting individual clubs who have a junior programs for outrigger, sprint canoe or dragon boat. Marketing posters will be sent to encourage junior coaches to consider the 2012 world event.

Western Canadian Championship - Currently set for October 2nd weekend. Venue has not been confirmed, but 2009 was held in False Creek at Science world and worked well hosting many out of town paddlers. This will be a CORA hosted event with OC1 and OC6 sprints as well as junior time trials.

Boats may possibly be supplied by the 2012 World Sprint committee, and also help from Pogue Sports and False Creek Canoe Club.

Eastern Canadian Championship – Currently working with Kim Prince from Wai Nui to find a suitable venue and date. Once we decide on venue and date, (soon) marketing posters will be sent to clubs in Ontario, and Quebec as well as clubs with junior programs. If numbers show not large enough to hold a 2 day event, I have suggested we have Wai Nui host a Sprint clinic the day prior to the race.

V1's will be available to the 2012 World Sprint Committee this May and it was agreed that some boats could be shipped to Toronto for junior time trials or training if the interest was there. Pogue Sports may also help source out suitable boats for the CORA event.

Intent to Compete - Online registration has been open since January and has 66 paddlers registered. Additional marketing posters will be sent to CKC clubs throughout the year.

Sprint Clinics – As there is a Cora Clinic grant, I will be encouraging clubs to hold an open sprint clinic for new sprinter this spring.

2012 Time Trials - We feel May 2012 is a suitable time to hold the trials. At this point it would be in Vancouver based on the largest amount of registered paddlers. I hope to encourage Eastern paddlers to register in large number. Who knows! Maybe we all have to go to Toronto next year :)
