O CORA Cup race registration form - Ron

- Ron prepared a template and emailed it out Feb 28
- ■Club name and team name need to be separated on the form so that both are filled in
- ■Don will send the form to CORA Cup race directors to get feedback on template when he distributes the 2017 CORA Cup rules (inclusive of a highlight of this year's rule changes)

CORA small boat numbers

- ■We are out of numbers to hand out at races and there is no objection to printing more.
- ■Gralin will check with PNWORCA to see which number range they are using for their small boats to ensure CORA #s are unique.

Unlimited canoes – Don

- In CORA races unlimited canoes only race open men, open women, open mixed, which may change in time
- ■Staggered starts may be considered so that Unlimited canoes get a head start or held back
- ■t is desired to encourage more unlimited canoes to participate in racing: challenge other clubs to send teams in the same category throughout the season

■Knowing how many unlimited canoes registered for the race before you get there would be helpful to clubs to decide which canoe to bring/race
