### 2022 Race Sanctioning Proposals Given COVID PHO

Crazy 8s and March Madness have been cancelled.

FGPC moving forward and taking risk to prepare for race registrations (Kan-U-Hakit, may resurrect Brotchie race).

No need to post something on the CORA website regarding Jericho PNWORCA Winter Series race that mentions restriction to solo racers due to COVID restrictions as Jericho Winter Series event was canceled.

PNWORCA (CORA) Winter Series Event #2 replacing the canceled Jericho Winter Series event (virtual) available to racers across the border (as opposed to a physical race available only to Canadian paddlers). Want to preserve a minimum of 2 races in Canada.

### **MOVED** by Graeme:

WHEREAS Jericho Paddle Club has canceled PNWORCA Winter Series Race #2 and declined to host a virtual race in lieu thereof;

AND WHEREAS it has been proposed that CORA host a virtual small boats race to replace the canceled PNWORCA Winter Series Race #2;

AND WHEREAS the Executive of the PNWORCA has approved the replacement of the canceled PNWORCA Winter Series Race #2 with a CORA-hosted virtual race;

#### BE IT RESOLVED THAT:

- 1. CORA host a virtual small boats race to replace PNWORCA Winter Series Race #2 having the following particulars:
  - (a) the race will be open to solo participants only, in compliance with applicable British Columbia Provincial Health Order restrictions, with categories available for V1, OC1, C1, K1, surfski single, marathon canoe single, SUP, kayak, Concept2 erg and KayakPro erg in CORA age and gender divisions;
  - (b) participants must be CORA members (annual or day fee);
  - (c) a race fee of Cdn\$15 for adults and Cdn\$10 for juniors will be applied through WebScorer, with WebScorer receiving a processing fee;
  - (d) participants must agree to the CORA race waiver;
  - (d) the race course will be an "out and back" long course of 10km or short course of 5km;
  - (e) registration and race data submissions will be open from Saturday, February 12, 2022 to 5:00pm Sunday, February 20, 2022;
  - (f) GPS distances must meet or exceed the distance in order to qualify; and
  - (g) there will be draw prizes in lieu of any placings prizes, drawn from existing inventories of draw prizes on hand and any additional donations.
