2022 Eastern Canada CORA Cup Series & Waterway Series (Mony & Val)

• Eastern group have agreed to meet once Wendy from Wai Nui is back after Feb. 10th

2022 Event Sponsors (Graeme / Rob M)

- Rob Magus and I have been collaborating on an informal "Sponsorship Agreement" as per a suggestion several
 months ago. There was a tentative New Business item to discuss / review the first draft, but there has been far too
 much going on with the Burnaby Pavilion / Parking Lots / Race Course to have adequate time to bring this forward
- Rob Magus arranged an introduction with Bob Putnam (Coast Outdoors) and we have had several rounds of discussion on sponsorship / prizing
- Visited Bob Putnam at Coast Outdoors mid-March and they agreed to fully support the CORA Sprints (in-person) and other BC Lower Mainland CORA events
- Matt Kelly with Predator keen to support all CORA events going forward, but "quality" Swag will become available as the year progresses
- Sand Point PNWORCA Winter Series Championship race had impressive awards / prizes table (wearables; booze; coffee; chocolate; gift cards), so looked locally for similar merchandise
- Have commitments from Purdy's (chocolate) and Steamworks (beer) to support CORA events with merchandise / gift certificates as part of the CORA Cup Series Swag Grant
- Kai with Oddball Workshop working on CORA Sprints Commemorative jersey design at cost. Limited number to be provided at the race, additional orders possible.
- Recognition for all sponsors will be on the website. Will ask Emcee to promote during the event as well. Suggestion of putting this on Facebook, social media venues, etc.

2022 BC Lower Mainland Sprints Regatta Planning (Graeme / Rob M)

- Clarification on Pavilion contract Pavilion access is a separate contract (7AM-6PM both days); Parking access is a separate contract (sunrise-sunset both days); Course / Dock / Officiating Platform access is a separate contract (sunrise-sunset both days)
- No payments made to anyone at Burnaby yet as awaiting confirmation of viability of event given low uptake
- Visited Burnaby Lake Pavilion Feb-24 and distributed pluses / minuses of situation
- Visited Burnaby Lake Pavilion Mar-8 for walkthrough of venue / parking / logistics
- Visited Burnaby Lake Apr-5 for an on-water look at the course / platforms Shelter from weather beneath perch deck. Platforms appear to be safe; any concerns will be addressed by the City of Burnaby.
 - Suggestion of including in communique that you might want assistance in getting into V1
- Rob Varnel visited Burnaby Lake for an assessment of OC6 trailer access
 - Boats should be loaded on Thursday night.
 - Rob Varnel will drop off canoes on Friday evening and would prefer to use the False Creek trailer.
 - Sunday night boats will be loaded for unloading on Monday.
- Spoke with Fortis Public Relations Rep about construction schedule and shuttle from overflow parking lot, will follow up with Fortis to ensure shuttle provided.
- We should distribute a parking communique to everyone who has registered shortly after registration closes

- Burnaby Lake Pavilion contract approved by the City of Burnaby at \$1540 for 2 days (vs. expected \$3000 for 2 days);
 Contract signed / delivered; Pavilion tables / chairs will be setup as per floor plan by Friday (Apr-29) evening; Need to get Pavilion key into the hands of someone who will be at the venue early Saturday @ 7:00 AM to open the doors
- CORA Sprints Insurance document provided to the City of Burnaby on April 1st.
- Burnaby Lake Parking at no charge (vs. \$200/day) due to Fortis construction chaos
- Burnaby Lake Race Course cost at \$4600 for 2-days plus setup/takedown by BLRC
- Race Course cost includes two 10'x10' canopies setup on Officiating Platform by BLRC
- Pontoon safety boats (non-tinniest) offered at \$75/boat/day by BLRC (top-off end-of-day with 90 Octane)

- Burnaby Lake Rugby Club offers their parking lot as overflow should there be 100+ vehicles. We don't know if a shuttle will be provided.
- Burnaby Lake Race Course contract in the works Site visit after April 13 (course to be setup for April 24 event) to see laned race course & "perches", as Fortis supposedly burying pipe April 9-12
- Burnaby food / coffee vendors proposal distributed lost Surrey coffee vendor due to fuel costs; working on Plan B
- Coast Outdoors offering to be "Premier Sponsor" and will be on site both days and will provide swag and they visited the venue Mar-30
- The Flag Feather Banners deal with VanBanner fell through. We communicated that graphic design would be to them shortly and then they said all fabric orders were on-hold due to delivery issues from China. We had contacted Oddball to do the graphic design and they mentioned that they also did Flag Banners and would meet or beat the VanBanner price, so Oddball will provide the Flag Banners as well as the graphic design
- The CORA Sprints Juniors medal deal with Kerr Recognition fell through. They communicated that the medals requested were unavailable to the Ontario Canada vendor due to delivery issues from China. Kerr Recognition arrived at a Plan B, but the Junior uptake is far below the best-case scenario of 114 medals. The medals will be reusable, but the unused ribbons will be a write-off.
- Please note that all of the estimates for parking / medals / awards photos / Pavilion capacity were based on expectations of crew participation that started with 50 crews, went to 75 crews, went to 90 crews, and is now looking like less than 30 crews (180 attendees).
- Dragon Zone Bradley Lightning sold to Okanagan / Interior club / individuals mid-2021 and looking for the new owner;
 Consider option of Clipper with Bradley Lightning ama / iakos; Reached out to Kamloops / Vernon / Kelowna /
 Penticton to see who might now own that Bradley Lightning, but it is not a CORA club
- Plans will be to weigh the canoes at the event. If it can be done before this would be better, however, Rob Magus pointed out the older canoes may run differently due to age as opposed to weight. False Creek is lighter.
- Rob Varnel would like to use the FCRCC trailer. Loading on Thursday night at FCRCC/VOS, trailering to Burnaby Lake on Friday. Rob M will enquire with FCRCC. Rob V. will need a trailer insurance certificate.
- Someone should have available sandbags at least 20 lbs. each. Rob Magus will bring the sandbags.
- Dragon Zone rep (Dominic) confirmed likely minimal uptake by DZPC DB crews.

- Cons: Minimal uptake (Participation; Memberships); Minimal Swag Reduction; Minimal Canadian / US Peter Forand participation (golden opportunity missed); Beau Whitehead will not repeat as Champion
- Pros: POC on WebScorer low-cost standard / shareable CORA Long Distance Race Rules compliant event template proven; Canadians scored Peter Forand points in multiple Age (40s; 50s; 60s) / Gender (Female; Male) Divisions; Race Fees + Memberships revenue > WebScorer License expenses

New Business

- a. CKBC Public Expansion Erik
 - i. Social media pieces including an invitation to register for surfski paddlers, basically sum up that you as a paddler can register and be insured as a paddler for a year. Overtime we intend to incorporate ocean paddling. CKBC is flexing their muscles and indicating to the public that they intend to incorporate sports like outrigger.
 - ii. Did we want to respond to this? There is a concern that we could become irrelevant.
 - iii. Is CKBC reflecting what CKC is stating?
 - iv. There is an international claim by CKBC for legitimacy.
 - v. It appears that CKBC is the only provincial body interested in ocean paddling.
 - vi. Leanne advised -
 - Ongoing issues with ICF and IVF with regard to para canoe, a concession was achieved.
 - ICF and ICA are still in a disagreement
 - Concerns that individual groups want to maintain ownership, ongoing fight with international organizations.
 - vii. Rob Varnell
 - IDF and ICF issues, most paddlers want to go where the best paddlers are.
 - Concern that it is a veiled "fluff", a needle but not a weapon
 - viii. Rob Magnus
 - Part of CKBC, FCRCC was split into two portions in order to accommodate. Flat water under CKBC.

ix. Jonathan

Would our position be stronger if we were the NSO?

x. Erik

- CKBC wants the table at provincial level. Outrigger has grown without any provincial funding. CKBC wants to be able to indicate to funders that there is legitimacy and will allow them to expand.
- Surfski paddlers are having backroom discussions.
- If CKBC is playing dirty they could maneuver to have sanctions and do a short run around CORA and affect insurability.
- Do we want to put ourselves at the table to have a discussion with CKBC and formalize our concern? If we go, we should go soon.
- CKBC is doing the right thing in organizing membership, insurance, grants, etc.
- We do not want to be sidelined by CKBC. We have earned legitimacy in our sport in Canada. Our group is the only group standing to represent our group.
- CKBC being larger has a stronger position and is multi-sport, CKBC has not demonstrated interest in the outrigger sport. CKBC has a claim to paddle sports overall.
- Of concern is that any club who is with CKBC and CORA, insurance from CKBC would cover races, and thus the need for CORA would be gone.
- Suggestion of playing hard ball we note your comments but we want you to know that we are pushing back against and do not invite you to participate in expanding your mandate to include outrigger.
- Erik will start a rough draft of the letter; this letter must stay within the Board.
- Did we trigger a problem after the Squamish surfski champs?
- The flip side of the coin is fire a shot or here is a talented Board of directors to merge with CKBC

Rob V:

- CORA was trying to feather bed with CKBC a few years ago. CKBC opted not to pursue.
- What do we do?
- Of note is that we increase our numbers by CORA day members
- If we do a letter to CKBC then it would be helpful to have all the clubs sign it
- Suggest to CKBC that we need a certain number of boats, small and large and need at least \$2.6 M in order to grow the outrigger clubs.
- Outrigger is a club-based system.
- Sprint Kayak and Canoe needs a club system for coaching.

xi. Ron

- Noted Erik's concern of regulating races, how would they run the races, etc.
- CKBC is requiring that members in clubs must be CKBC members, which increases CKBC member
- All members racing must be CKBC members.
- Not one organization is monopolizing racing. CKBC for instance can get a multitude of water craft in for a race.

- Suggestion that CKBC would have difficulties hosting a distance race.
- Of note is that the CKBC memo is aimed at surfski
- IVF doesn't recognize CKBC but they do recognize CORA
- You cannot be co-sanctioned through both CORA and CKBC for races.
- NSO though would be a lot of work, as we are a volunteer Board. We would need lobbyists.
- We have no objection to small boat races being sanctioned through CKBC
- xii. Marianne
 - Has found CKBC to be very aggressive
- xiii. Jonathan
 - Saw new boats at the local FLCC club.
 - CKBC granted them money for purchase
- xiv. Leanne
 - All members have to be CKBC members
 - We want NSO not PSO
