\$10,000.00 seems like a lot of money for strategic planning, what is this going to be spent on.

Strategic Planning - it has been 30 years since the inception of CORA. We are working toward having a vision to engage the membership, hire someone to facilitate the strategic plan process. We would like to look ahead and be proactive as opposed to reactive.

This process will be handled over a period of time, in order to address each task.

The Board will be deciding the process as we go into next year, this is an enabling amount of money in order to go ahead with the process.

As members of the CORA Board are not experienced in this, we will be seeking outside help. One of the first steps will be to be transparent with the membership, part of the expense will be consultation with the members. This will be a community engagement process.

There are no facilitators in mind at this point.

CORA is recognizing that we need to spend money and is looking for a vision on how to spend the money.

We will be looking to members to envision how the money can be invested into CORA paddlers, needs, growth of clubs, contact with the East, senior games, etc. There are many places to be influential but need to determine where to spend the money.

Outside 3rd party stakeholders will also be consulted on how to help CORA members and clubs.

#### 15. Insurance & Safety Report (Ronald Chin)

- c. We have switched insurance providers to BFL Canada, BFL Canada is more familiar with paddling sports, they are also the provider with Dragon Boat Canada. The policy, including the wording has remained the same.
  - i. Insurance covers 3rd party claims only. For example - bodily injury to a swimmer you have coverage.
  - ii. The types of events covered are - CORA sanctioned events, including races and training at the event. Also covers day to day operations for each club - Activities are covered for claims that arise from sanctioned activities.
    - 1. CORA sanctioned races and events are covered, including IVF time trials and training program
    - 2. Club activities - CORA will be developing a procedure manual whereby all CORA clubs will submit to CORA, not for approval but for information, to inform CORA of the types of activities that your club uses. A questionnaire will be done outlining your programs and your training.
    - 3. Recreational paddling is covered as long as it is included in your club activities.
    - 4. You can paddle or do dryland training away from your club premises.
    - 5. You can have guest paddlers as long as it is a sanctioned activity.
    - 6. Paddling training or paddling can be done off site as long as it is in the club operation outline.
    - 7. Members who train on their own time as long as they are training under a sanctioned activity. For example - written training program issued by a program within the club.

8. Plain language regarding our insurance coverage will be posted on the CORA website.
9. Unaffiliated members - self directed training which is not covered under a club program, or a CORA sanctioned event or program is not an insurable activity.
  - a. Unaffiliated members will be apprised of this when they register.

You will need to send this into a CORA Board member on the insurance committee. This must be done just prior to the AGM.

## CORA PRESIDENT'S AGM ADDRESS 2021

2021 started off with continued COVID restrictions on crew paddling. CORA implemented a couple of virtual initiatives – a virtual small boats series – one in Winter to replace the popular PNWORCA Winter Series and a follow-up in the Spring, as well as an overwhelmingly popular off-the-water video conference series.

As vaccinations increased, restrictions on crew paddling loosened, with a resumption of OC6 paddling, at least in British Columbia, in or about late June as the Spring virtual small boats series ended.

In person racing picked up over the summer, in small boats and in OC6s, with the first long distance race in over a year and a half hosted by Comox at the end of August. The Fall has allowed the race schedule to settle back into its familiar form with the Poker Paddle, Bridges and Wetdasche.

I'd like to thank each of the CORA directors, officers and volunteers who have donated their time to make the organization run smoothly. Our finances are in check thanks to Jonathan Wilkins and we have budgeted to spend more next year. Leanne Stanley and the IVF Committee for their responding to the changing COVID landscape to prepare our athletes for IVF World Sprints in London. We have an ongoing debt of gratitude to Erik Ages and his team at Fairway Gorge for their work in managing the CORA website, the virtual small boats series, video conferencing and other technical issues. Bob Woodman, who joined us as a Director last year has decided to step down, and we thank him for his contributions to the Board, including work on the historical committee.

## CORA COVID RESPONSE REPORT (AGM) 2021

With the increase in vaccinations and the loosening of COVID-19 restrictions on sporting activities we've seen limits on outdoor gatherings lifted, freeing up our Members' abilities to train in OC6s and our Member Clubs' ability to host both small boats and OC6 races.

However, despite widespread vaccination, the prospect of infection remained with highly transmissible COVID-19 variants.

As proof of vaccination became an increasingly common requirement to participate in non-essential activities, the CORA Board developed and issued the following policy statement on September 17, 2021 urging CORA Member Clubs to consider implementing a full vaccination requirement for their members participating in outrigger group or crew activities.

- 1. CORA supports the recommendations of the Public Health Agency of Canada regarding the health benefits of vaccination in preventing severe illness, hospitalization and death from COVID-19 and its variants.*
- 2. CORA supports the full vaccination of those recommended to get the vaccine by federal, provincial and territorial public health authorities.*
- 3. As paddlers gather and train together in physically close environments, Member Clubs have a duty to protect their members and enhance the safety of their training environment. As a result, CORA supports full vaccination of those participating in outrigger group or crew activities for the safety of their members and to mitigate the risk of future infection events at Member Clubs and in our communities at large.*
- 4. In order to achieve the above, the CORA board strongly encourages Member Clubs to consider amending their COVID-19 policies to require full vaccination of those participating in outrigger group or crew activities, accounting for demographics, location and relevant specific vulnerabilities with respect to COVID-19. CORA also recommends the continued implementation of longstanding risk mitigation measures such as physical distancing and the use of masks where physical distancing cannot be maintained.*
- 5. Member Clubs continue to be bound by the Orders of applicable provincial and territorial public health authorities in respect of all gatherings, events and activities.*

Last night [on November 20, 2021], at its Pre-AGM Board Meeting, the CORA Board passed a resolution requiring that all participants in 2022 CORA-sanctioned events be fully vaccinated against COVID-19.



## **AGM 2021 Treasurer's Report**

I am pleased to present the financial statements for the year to December 31, 2020 and the 10 months to October 31, 2021.

2021 has, of course, been another challenging year for us all - as individuals, as paddlers, as clubs and as a volunteer association. Although the CORA Board worked hard to create a meaningful budget to present to the 2020 AGM, none of us could foresee the continuing impact of Covid.

Our projections for the income were a little high – about \$5k high, but it is the expenditure that we seriously overestimated. This was predominately because we were unable to make the usual grants to items such as the National Sprint Championships, the CORA Cup, canoe trailering and some of the clinics. Also, we did not put any funds into the National Team Development program.

Together, this means that although the Board had budgeted to make an operating loss of around \$16k, I forecast that CORA will make a small surplus this year. The forecast figures for the full year can be seen on page five of the pack – the 2021 year to date and the 2020 full year figures are on page four.

The intention to make a loss might seem surprising, but the Board has been very aware of an increasing bank balance. Although it continues to plan forward, the Board does not believe that we should hold an excessive amount of money, which of course was contributed by the membership.

Balance sheets are shown for both the General Account and the IVF Account.

The IVF Account is the funds contributed by the National Team participants and a grant from the General Account. These funds are then reserved for the specific event, with each campaign expected to, more-or-less, break even. The budget presented on page 5 is a draft, on which the Board invites comments. The Board will finalise its 2022 budget at the Board meeting to be held at the beginning of January.

I would like to highlight a couple of the items in that draft budget which contribute to the very significant projected shortfall in 2022. - The reintroduction of the grants to the National Team Development program, Coaching Education, Coach the Coaches are all there to improve the skills and performance of paddlers – particularly as the sport of Outrigger Racing grows in popularity across the country.

- The cost of insurance has been increasing rapidly over the last few years. -
- An in-person strategic planning session is allowed for. It has been several years since the Board was been able to step away from the day-to-day and look forward to where the sport appears to be going and also to where it might be possible for it to go. Again, this is particularly relevant when we look at the growth of sport across the country from an historical position that was principally British Columbia focussed.

A couple of other points to note: -

CORA does not currently hold any GIC investments as the rates are so incredibly low.

The reconciled bank statements are provided to the board each month.

Online registration for 2021 was opened in December 2020. The Coronavirus COVID-19 pandemic resulted in many changes in the 2021 race schedule, with numerous events being cancelled and introduction of virtual races.



## **CORA OUTBOUND COMMUNICATIONS REPORT (AGM) 2021**

### **OVERVIEW**

CORA'S board and supporting volunteers worked carefully to communicate COVID updates in a manner that reflected changes across communities and sport organizations at regional, provincial and national levels. This was achieved, in part, by restricting the frequency of communications updates to prevent "noise" for our members.

When we did send out COVID-specific communications, we communicated clearly to members clubs and paddlers in a manner that sought to simplify rather than complicate decision-making on the part of clubs and member paddlers. We intend to continue with this approach as we head into the 3rd year of Canada's response to COVID, including anticipated announcements regarding vaccination status at CORA-sanctioned events.

### **SOCIAL MEDIA & INTERACTIVE BROADCASTING**

CORA actively engaged with both members and non-members, both within and beyond Canada, through a variety of interactive townhall and clinic sessions over the year. Based on feedback from participants and audience members, these sessions met a number of objectives, including keeping our members connected and communicating with each other through discussions relevant to our sport, and by selecting topics that were relevant to various stages of our sport in the context of COVID-specific restrictions to training and competition.

The CORA board intends to continue with these interactive video-based townhalls and clinics going forward.

### **COMMUNITY OUTREACH**

In the event that the CORA board puts a 30th-year strategic planning process in place, CORA's outbound communications initiatives will include a variety of targeted and general community outreach mechanisms to solicit comment, feedback and insight from our members and members of the larger sport community.

### **COMMUNICATIONS INFRASTRUCTURE**

CORA's overall communications infrastructure has adapted and grown, and has evolved in accelerated fashion in its response to COVID restrictions to our sport. In light of this, the CORA board will continue to invest in improvements to speed, responsiveness and security of our platforms (web, direct email, social media) over the coming year.



## CORA INBOUND ENQUIRIES REPORT (AGM) 2021

### OVERVIEW

There was a time when the CORA Email Inbox necessitated constant monitoring due to the volume of enquiries for CORA Board activity that flowed through this channel.

The adoption of Google Workspace (formerly G Suite) with Gmail, Calendar, Meet, Chat, Drive, Docs, Sheets, Slides, and Forms has simplified internal / external communications. The migration to a new CORA website with many self-service capabilities has also reduced the workload on the CORA Board.

- RME / Trailing / Coaching / Clinic Grant Applications that had previously been submitted to the CORA Email Inbox and then forwarded to the Grants Officer are now sent directly to the Grants Officer via online forms.
- Event Sanctioning Applications that had previously been submitted to the CORA Email Inbox in the weeks prior to the AGM and then forwarded to the Race Committee are now managed directly by CORA Club Reps through the CORA Website Race Calendar.
- Enquiries for CORA Membership Lists by Race Directors prior to Sanctioned Events are now readily available from the Membership Officer.

There are presently two Board Members who receive notifications when messages flow into the CORA general enquiries email address. The COVID pandemic of 2020/2021 substantially reduced the historical volume of inbound messages where the majority of enquiries would involve:

- Enquiries for event CORA insurance coverage certification
- Enquiries to post Race Results
- Enquiries for CORA Cup status
- Enquiries to postpone / cancel sanctioned events
- Paddlers / Teams looking for Teams / Paddlers / Canoes

### CORA EMAIL MESSAGE DISTRIBUTION

All of the "unsolicited" inbound messages that arrived at the CORA general enquiries email address, as well as enquiries that were put forward by individual Board members which they had received from within the membership were categorized to provide an overview of the various enquiries from the CORA Board. In a "normal" (non-COVID) season, the number of non-COVID enquiries would be double / triple / quadruple the number of current season number enquiries. Some of these enquiries for information do not necessitate action by Board Members or Club Reps, and could be addressed by **providing a website page of FAQs to commonly asked questions**. The WordPress site may provide some intrinsic FAQ capability (plugins) or there are many websites that offer examples of how this functionality could be provided as per the screenshot below.



CORA will be sending out a survey to all Junior clubs in an effort to engage and begin a dialogue to see how CORA can assist Junior clubs in growth, on water skills, clinics, coaching and connecting with other Junior clubs.

Of note is that CORA has made strides to encourage new, both young and old paddlers, to racing. Most host clubs for a race, include in their race packages:

- 1) A start time for the short course race, designed for Junior and Novice paddlers, that will accommodate a ferry schedule;
- 2) Provide canoes for the short course race, particularly when the ferry prevents teams from arriving with enough time to unload canoes and then rig; and
- 3) Fee reduction for Junior teams.

We are fortunate to have several clubs in BC that have Juniors or are dedicated Junior clubs.

## **2021 CORA AGM IVF Director Report**

### **SPINTS – London 2022:**

The 2022 IVF Va'a World Sprint Championships have been scheduled for August 7 to 16th at Dorney Lake, Windsor, England.

The Team Canada selection documents were published in the spring of 2021 with the plans of a trials in September in Calgary. Over the course of the summer, it became apparent that the COVID situation was going into a fourth wave and it was announced at the end of August that the September trials would be canceled. Registrations were extended and once closed, there were a number of crews and individuals that were able to be named to the team based on Canada's quotas and the number of registrations.

Currently, trials for categories still to be contested are scheduled for May 14/15, 2022 in Calgary. All free agents, Women's 50s crews, V1 competitors in categories not yet decided and any paddler trying out for the Elite V6/12 will need to attend.

The IVF and London organizing committees have asked countries to submit their intended entries starting in January 2022 and they will make the call by early March 2022 if the event is to be canceled based on the pandemic projections and/or number of entries.

### **DISTANCE – Samoa 2023:**

With the ongoing pandemic, the 2021 World Va'a Distance Championships were postponed to 2023. It is unknown at this time if the event will go ahead as planned. There are no dates associated with the event yet.

Paddlers interested in contesting for Team Canada 2023 should watch the CORA website for team selection information early 2022. Currently the weekend of October 15/16, 2022 is scheduled for Samoa Time Trials to take place at Jericho in Vancouver.

### **IVF NEWS:**

Victoria paddler, Miles Krakowec Tickner, was nominated to sit on the IVF Sport Development Committee. Calgary's Lynda Roberts is on the IVF Events and Technical Committee. CORA is grateful to have these two individuals representing CORA, the interests of Canadian paddlers at the IVF level, and to help our the sport worldwide.

## CORA INSURANCE AND SAFETY REPORT (AGM) 2021

There have been no incidents or insurance claims to report.

For 2021, CORA switched its insurance broker from SBC Insurance Agencies to BFL Canada Insurance Services.

The underwriter remains Markel Canada.

CORA maintains a Commercial General Liability Policy providing coverage for CORA Member Clubs ("CORA Clubs") and individual members against claims by third parties for bodily injury or damage third party property when participating in "sanctioned events". Coverage is for up to \$5M per occurrence. The interpretation of "sanctioned events" has always been somewhat vague. In the past year we have sought clarification on the scope of coverage, particularly for the day-to-day practices and training activities of CORA Clubs who rely solely on CORA insurance ("full member clubs"). We have received some clarification from BFL Canada and CORA will be implementing a process (written procedure manual) to "sanction" the operations and activities of CORA Clubs.

Provided that they are "sanctioned", activities may include:

- CORA-sanctioned races
- CORA-hosted practices, training, time trials and races
- CORA Club practices, training, time trials and races
- CORA Club recreational paddling activities
- CORA Club activities at locations other than the club, so you may paddle out from the club or launch from a remote location
- CORA Members training on their own time, but only if the training is sanctioned by their CORA Club. Coverage does not apply if the training is not sanctioned by a CORA Club or by CORA itself (ie. self-directed or independent training by unaffiliated CORA Members is not covered).
- Use of CORA Members' own equipment
- CORA Clubs may invite "guests" to activities (ie drop-in events) without charging a CORA "day fee" but these numbers should be reported to CORA for inclusion in the "day fee" numbers reported to BFL Canada (CORA is charged a premium for each day fee).

We have requested a "plain language" explanation of the liability coverages and are awaiting this document from BFL Canada.

In early 2020, CORA's insurance underwriter, Markel, unilaterally invoked a "Contagion Exclusion Endorsement" so that any insurance claims arising from COVID-19-related claims would not be covered – this continues to apply.

CORA also purchased Directors' and Officers' Liability insurance.

## Contagion Exclusion Endorsement

READ THIS ENDORSEMENT CAREFULLY AS IT MAY EFFECT COVERAGE UNDER THE POLICY

This Insurance Policy provides no coverage for any **Claim** in any way caused by, arising out of or resulting from any disease or contagion, including that designated as such by any of the following:

- A. a Federal, Provincial, Territorial or Municipal authority or agency;
- B. a Minister of the Federal, Provincial or Territorial Crown;
- C. a person occupying the position of Chief Medical Officer of Health (or similar position) of a Province, Territory or Municipality;
- D. the World Health Organisation;
- E. the Center for Disease Control/Centre for Disease Control of
  - i) Canada or any Canadian Province or Territory;
  - ii) the United Kingdom of Great Britain and Northern Ireland; or
  - iii) of the United States of America and any American State or Territory.

For purposes of this Endorsement, disease or contagion so designated shall include:

- a) any derivative, mutation or variation of the disease or contagion;
- b) any fear or threat of the spread of the disease or contagion;
- c) any failure to prevent, contain or eradicate the disease or contagion.

For purposes of greater clarity the following are diseases or contagion that are excluded pursuant to this endorsement:

- 1) Coronavirus disease (COVID-19);
- 2) Severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2);
- 3) Ebola;
- 4) Avian Influenza (Avian Bird Flu); and,
- 5) Legionella (Legionnaire's Disease).

# CORA CANOE REGISTRY REPORT (AGM) 2021

## OVERVIEW

This initiative began in 2020 as an exercise 1) to capture an inventory of CORA "big-boats" (much like the SCORA / OHCRA / HCRA Registries) and 2) to capture details (names / IDs / colours / weights) of CORA "big-boats". This initiative continued in 2021 with data quality improvements to the Canoe Registry and a photograph catalogue based on information collected by the Historical Committee and Awards Committee on the movement of OC6s between CORA clubs.

## SUMMARY

- We have been able to identify 169 "big-boat" canoes within Canada
- New / used big-boat acquisitions since the previous Canoe Registry update in Autumn 2020 were minimal with 1 new Puakea Malolo acquired by FCRCC from an Ozone distributor, 2 used Canadian Malias acquired by Pearson College from Powell River, 2 new ARE Matahinas acquired by Powell River from a Canadian distributor, 1 used Outrigger Connection Mirage acquired by Haunani from Wai Nui, 1 new Puakea Malolo acquired by Rideau Valley from an Ozone distributor, 1 new Bradley Lightning (3-piece) acquired by H2O Outrigger from a Florida distributor, 2 used Clipper Advantages acquired by Toronto from Vernon, and 1 used Clipper Advantage acquired by Sunnyside from Pacific Reach
- There were some tragic big-boat losses with the only Bradley Striker in Canada (TSCC) being wrecked and a Wai Nui Bradley Lightning being severely damaged at the Toronto International Outrigger Challenge (TIOC)
- We have been able to capture current pictures of 98% (167/169) of the "big-boat" canoes within Canada
- We have identified that one former CORA club (COMMOC / MOPC) has left CORA and their single OC6 is now privately-owned
- We have only recently learned that there may be even more OC6s/OC4s in Canada at non-CORA clubs as there may be 3 OC6s at Wiki Wiki Wa'a and 2-4 OC6s/OC4s at Outer Harbour Dragon Boat Club
- There are 7 CORA clubs and 1 ECORA club that each own at least 7 "big-boat" canoes and collectively own 41% (69/169) of all "big-boat" canoes in Canada
- 12% (21/169) of "big-boat" canoes in Canada (1 in 8) are NOT owned by clubs / teams affiliated with CORA
- Discussions with Val Simmons of Haunani noted the following 3 points: A) There continues to be a dearth of OC6s in Quebec (4 in 2020 and 6 in 2021 (Haunani; H2O; COMMOC/MOPC; Onake); B) There are NOT enough OC6s in Ontario to support the demand; Wai Nui has been supporting local clubs / events with their 8 OC6s but the other 7 Ontario clubs only have 11 OC6s between them; C) A Florida outrigger club gifted an OC6 to an unnamed Toronto club to be shared but that "sharing" has NOT happened

## INSIGHTS

This ongoing initiative to maintain the Canoe Registry has yielded these insights:

- Canadian clubs have few options for new OC6s with only the Western Canada Ozone distributor (Hana Hou Sports) the Eastern Canada Ozone distributor (Coldwater), the Florida 3-piece Bradley Lightning distributor (Canoa Havaiana), Woo Outrigger (Europe), and a Western Canada Matahina distributor (private)
- Getting new canoes to Canada is further complicated by the worldwide container (40'; 45') shortage that has resulted from ongoing COVID outbreaks
- The only remaining local Spec canoes (Clipper Advantage) were last manufactured in 2016

- Access to used canoes by Canadian clubs from the States has been impacted by the US / Canada exchange rate (80 cents/dollar) and border restrictions
- Access to used canoes between Canadian clubs is a challenge as those Canadian clubs with a large fleet are reluctant to sell older canoes as these canoes are used for all-season training and these large fleets of canoes are used for events where the host club provides the majority of canoes
- The challenge of canoe availability is even more prevalent in Eastern Canada where the growth of the sport has been constrained by the shortage of canoes
- CORA has looked at options for assisting Eastern Canada in acquiring OC6s, but a visible commitment by several Eastern Canada clubs to collectively procure used Spec OC6s could assist CORA with this effort
- It is worth noting that a fortuitous post on the CORA Discussion Forums in Autumn 2021 led to the sale of a Vernon trailer, 2 Vernon Clipper Advantages, and 1 Pacific Reach Clipper Advantage to 2 Toronto clubs via collaboration between CORA Board Members Bob Woodman & Rob Varnel

## RECOMMENDATIONS

These recommendations were put forward at the 2020 AGM and are once again put forward at the 2021 AGM:

- Consider an initiative to transfer minimally used Western Canada OC6s to Eastern Canada clubs to support outrigger canoe growth in Ontario / Quebec
- Reach out to unaffiliated Eastern Canada clubs (Onake; Ottawa River; Pickering) to join CORA
- Have a CORA issued unique canoe # decal assigned to each canoe and affixed behind seat six
- When life returns to "normal", consider an event showcasing the multitude of outrigger canoe makes in Western Canada

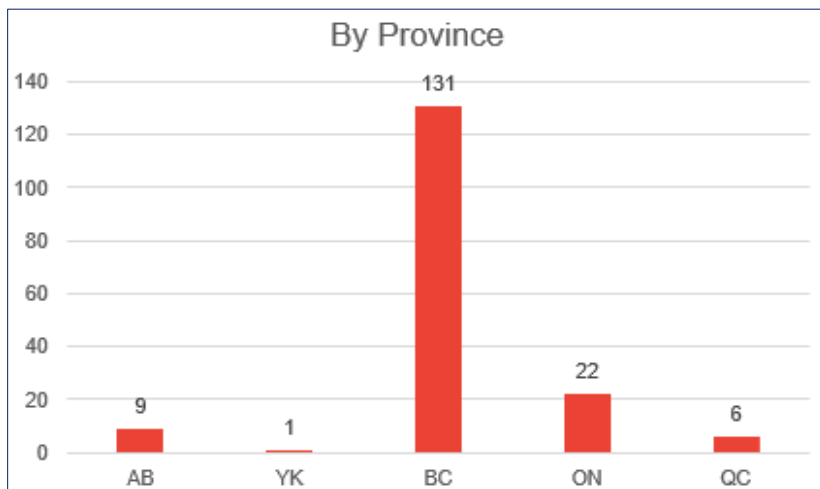

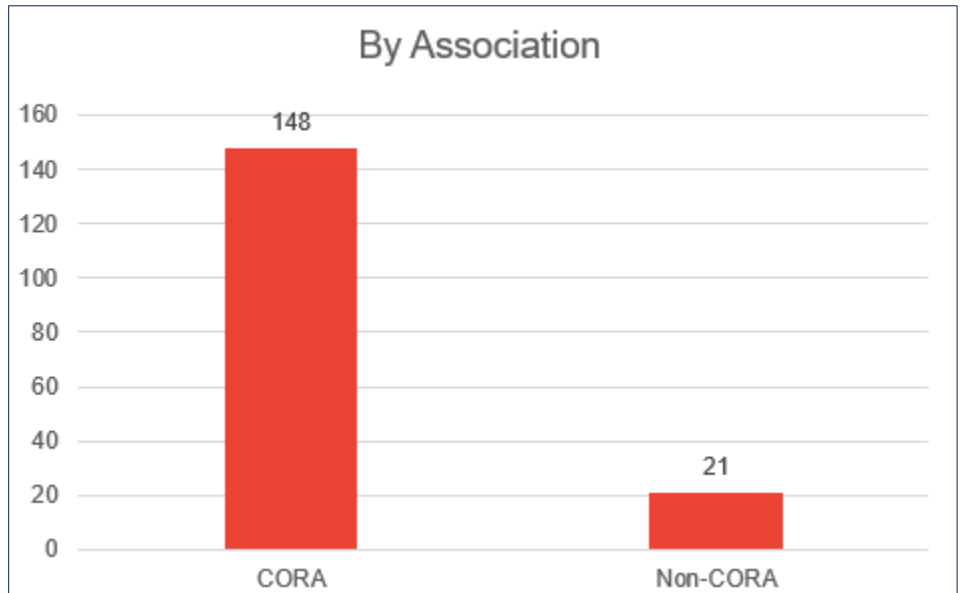

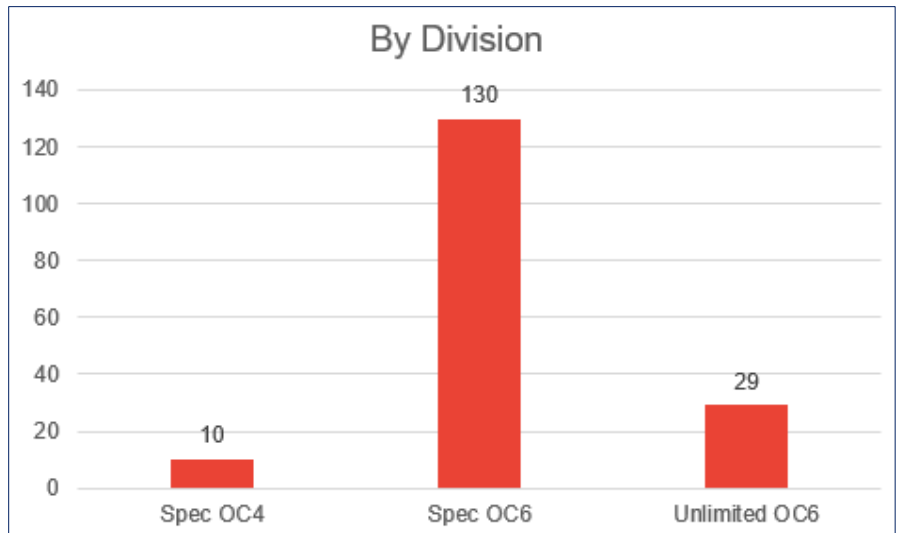

**Canoes By Division**

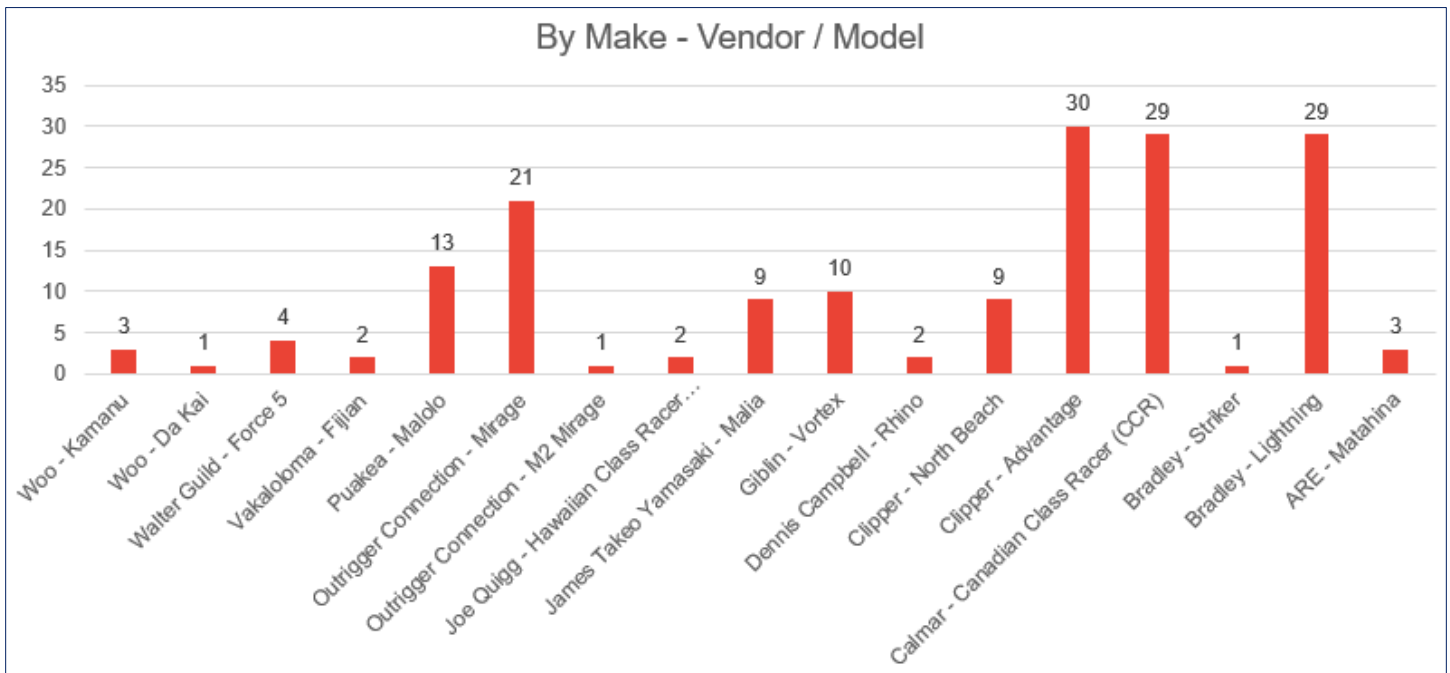

# CORA HISTORICAL COMMITTEE REPORT (AGM) 2021

## OVERVIEW

The CORA Historical Committee was officially formed in 2020 and consists of current and ex-Officio Board Members who continue to collect and curate Canadian outrigger canoeing historical records for posterity.

## LIVING DOCUMENTS

The eight reference documents published since 2020 (see below) are all to be revised shortly. All reference documents published on the CORA website were meant to be "living documents" as details continue to surface that result in additions / revisions to these documents.

## CANADIAN OUTRIGGER HALL OF FAME OUTCOMES

This topic is covered in detail in the CORA Awards Committee Report. However, it is worth noting that the 18 Canadian Outrigger Hall Of Fame 2021 Inductee Bios posted on the CORA website Hall Of Fame perpetual page contain a wealth of historical knowledge covering Canadian outrigger canoeing history from the 1970s till present day.

## THE BURRARD – FIRST OC6 IN CANADA

Many Canadian paddlers might be surprised to know that eight CORA clubs were able to launch outrigger canoe crews by virtue of an OC6 that very few Canadian paddlers know about. There were sporadic mentions of a mystery OC6 in Canada in various references, but it was not until a series of chance interviews with a group of Comox paddlers that CORA learned the true story of "The Burrard" and when it arrived in Canada and where it finally came to rest. The story of how this OC6 came to Canada in 1986 and is now "returning to the soil" back in the forest in Comox can be found on the CORA website at:

## **CLUB LEGACIES – FALSE CREEK; LOTUS; JERICHO; PEMBERTON; COMOX; PENTICTON**

CORA accumulated a wealth of history in 2020 on three of the original CORA clubs (False Creek; Lotus; Jericho). The details collected in the research of the 18 Canadian Outrigger Hall Of Fame 2021 Inductees is to be incorporated into these three existing CORA club legacies. There is a vast amount of material that has been collected on Pemberton Canoe Association and Comox Valley Canoe Racing Club and Penticton Racing Canoe Club by virtue of some of the Canadian Outrigger Hall Of Fame 2021 Inductees Bios that is to be used in draft versions for legacies of these three clubs. CORA looks forward to working with Pemberton and Comox and Penticton on these "living documents".

## **CLUB LEGACIES – EASTERN CANADA**

Interviews have been held with many individuals with knowledge of Eastern Canada outrigger canoeing. CORA hopes to publish an Eastern Canada outrigger canoeing legacy document by the end of 2021 that covers the origins of many of the Ontario and Quebec canoe clubs. CORA Board Member Val Simmons of Haunani has researched history on the foundational canoe clubs in Eastern Canada (Wai Nui and Onake) and has prepared a brief overview of the key individuals and dates of these clubs.

## **CLUB LEGACIES – BC OKANAGAN**

Interviews have been held with many individuals with knowledge of BC Okanagan / Interior outrigger canoeing to build out the history of clubs from Kamloops / Vernon / Kelowna. CORA hopes to publish a BC Okanagan / Interior outrigger canoeing legacy document by the end of 2021 that covers the origins of many of the BC Okanagan / Interior canoe clubs.

## **RESOURCES**

Fact-checking, grammar-checking, umpteen email exchanges, and endless online searches in 2020 resulted in a very definitive Canoe Registry of the vast majority of big-boats (OC4s / OC6s) throughout Canada as well as a timeline of the travels of those canoes (continuously updated through 2021).

# CORA AWARDS COMMITTEE REPORT (AGM) 2021

## OVERVIEW

The CORA Awards Committee was officially formed in 2020 and consists of current and ex-Officio Board Members who have responsibility for coordinating Canadian outrigger canoeing Awards including the **Peter Forand Masters Challenge Trophy** since 2016 and the **Hugh Town Memorial Builder Award** since 2019. The CORA Awards Committee took on additional responsibility with the introduction of the **Canadian Outrigger Hall Of Fame** in early 2021 that was an outcome of the CORA 2020 Pre-AGM.

## CHAIN-OF-CUSTODY

CORA Board recognizes the challenges in administering trophies based on experience with the CORA Cup Series trophies and various Dragon Boat BC trophies that CORA Board members have found themselves caring for over the years. CORA Board recognizes that trophies are an investment and should be tracked to avoid having to replace quite often irreplaceable mementos. CORA Board continues to maintain Chain-Of-Custody documents for the **Peter Forand Masters Challenge Trophy** and the **Hugh Town Memorial Builder Award** to ensure that the last known whereabouts can be easily determined. These Chain-Of-Custody documents are to be found on the CORA Google Drive in the Policies folder.

## PETER FORAND MASTERS CHALLENGE

Peter Forand left a lasting impression on everybody that he met during his time with Lotus Sports Club and Jericho Paddling Club and Comox Valley Canoe Racing Club (CVCRC). The Canadian Outrigger Racing Association (CORA) website has a perpetual page dedicated to the memory of Peter Forand. <https://canadianoutrigger.ca/community-2/peter-forand-masters-challenge-trophy/>



Ross Creasy of Open Ocean Outrigger had a friendship with Peter Forand that spanned many years. After the passing of Peter Forand, Ross Creasy petitioned CORA and PNWORCA to commission a trophy to be awarded after the PNWORCA Winter Series Championship race each year, to the top OC1 Masters (40+; 50+; 60+; 70+) paddler (female / male). This **Peter Forand Masters Challenge Trophy** was awarded in the first year (2017) to Peter Marcus (Kai Pana Outrigger Canoe Club), in the next three years (2018-2020) to Minnie Fontenelle (Sand Point Outrigger Canoe Club), and in the current year (2021) to Beau Whitehead (Kikaha O Ke Kai). The hand carved wooden fish hook sculpture at the top of the trophy represents the deep connection and

reverence that we have with the sea. The trophy does make an occasional appearance at a PNWORCA Winter Series race to honour the memory of Peter Forand.

2021 had been the second year where COVID led to an exceptional year for the PNWORCA Winter Series. The 2021 PNWORCA Small-Boat Races Winter Series proceeded as per the PNWORCA 2021 racing schedule with five events (Wasabi; Mountain Home; Kai Ikaika; Bellingham; Seattle Sand Point). This was the first time since 2004, when a Canadian event was added to the PNWORCA Small-Boat Races Winter Series schedule, that there were no Canadian events on the schedule. The first three 2021 PNWORCA Small-Boat Races Winter Series events were all virtual (Wasabi; Mountain Home; Kai Ikaika), were well attended by CORA and PNWORCA paddlers, but the lack of Canadian PNWORCA / CORA sanctioned virtual events meant that Canadian paddlers had two less events for the Points standings. The final two 2021 PNWORCA Small-Boat Races Winter Series events were in-person and were very well attended, but the closed USA / Canada land border crossing precluded Canadians from participating in the Bellingham and Seattle Sand Point events. The USA / Canada land border crossing has since been reopened in August 2021 to travel northbound and in November 2021 to travel southbound and hopefully there will be Canadian events on the 2022 PNWORCA Small-Boat Races Winter Series schedule.



Discussions between PNWORCA and CORA resulted in agreement that there was indeed an OC1 Masters paddler who dominated OC1 Masters paddling in all virtual and in-person events.

The 2022 PNWORCA Winter Series winner for the Peter Forand Masters Challenge was Beau Whitehead (Kikaha O Ke Kai) in the Men Masters 50+ OC1 Division. The 2021 PNWORCA Winter Series event organizers recognized Beau Whitehead as the **Peter Forand Masters Challenge** winner in accordance with guidelines as the Female or Male Masters (40+ / 50+ / 60+ / 70+) paddler with the highest number of points across all age / gender brackets at the end of the PNWORCA Winter Series. Given the ongoing USA / Canada land

border crossing restrictions, a small ceremony was held on a gorgeous afternoon in October 2021 on the Washington side of Peace Arch Park with Peter Marcus (2017 Recipient) making the presentation to Beau Whitehead (2021 Recipient) and the obelisk signifying the USA / Canada border in the distance.

The CORA Board reviewed nominations received for the 2020 season and recognized Drew Mitchell, formerly of False Creek Racing Canoe Club, as the 2020 recipient of the **Hugh Town Memorial Builder Award**.

*Drew Mitchell has a 40-year legacy of selfless volunteer effort to paddlesports in general and outrigger canoe racing in particular. He has made contributions to support Canadian paddlers at the international, national, provincial, and club level. He has been part of the Burnaby Canoe & Kayak Club that was the source of paddlers for both False Creek Racing Canoe Club and Lotus Sports Club. He has been with False Creek Racing Canoe Club since its inception in 1985. He has made significant contributions to the FCRCC dragon boat and outrigger canoe programs as a head coach for 15 years. He served on the False Creek Executive for many years and was FCRCC Chairman for 1996 and possibly at least one year before / after.*

It is worth noting that the decision by the CORA Board to award the **Hugh Town Memorial Builder Award** to Drew Mitchell, an individual who had 20+ years of contributions to Canadian outrigger canoeing, yet had not been active in the Canadian outrigger canoeing for 20 years, led the CORA Board to the realization that with only a single award per year for Builders, that it might take decades to recognize those individuals from the 1980s / 1990s / 2000s / 2010s who had made "Significant and Exemplary Contributions" to Canadian outrigger canoeing. Hence, a suggestion was put forward to consider the introduction of a **Canadian Outrigger Hall Of Fame**.

As the Canadian Iron Championships had been cancelled for both 2020 and 2021, best efforts had been made to present the trophy to the 2019 recipient at a mutually convenient time / place. Given constantly changing travel / gathering restrictions, a small ceremony was finally held on a gorgeous

afternoon in September 2021 at Barnet Marine Park between Lotus Poker Paddle heats with CORA Chairman (Ron Chin) making the presentation to Grace Morissette (2019 Recipient) with the Indian Arm backdrop in the distance.

## CANADIAN OUTRIGGER HALL OF FAME

CORA gave this proposal serious consideration. CORA evaluated the policies / processes of the Major League Baseball Hall Of Fame, BC Sports Hall Of Fame, Ontario Sports Hall Of Fame, NHL Hall Of Fame, and Dragon Boat Canada Hall Of Fame to arrive at a policy / process that would make this **Canadian Outrigger Hall Of Fame** a meaningful endeavour and that those individuals inducted in the inaugural year would set the bar for nominees in future years. It took the CORA Board four months to arrive at a vision that was unanimously approved via a CORA Board Meeting Motion.

This **Canadian Outrigger Hall Of Fame** has a mandate that can be summarized as follows:

- *Canadian Outrigger Racing Association (CORA) recognized that there were many individuals who had made "Significant and Exemplary Contributions" to Canadian outrigger canoeing, but their stories had never been captured, and they had never been formally recognized. CORA spent early 2021 tracking down this history, and fact-checking as best as possible the exploits of those individuals who founded CORA, who founded CORA clubs, who were coaches / builders with CORA clubs, who inaugurated races, who excelled at IVF / Molokai / Catalina / Queen Liliuokalani events, and who designed / built / imported / distributed canoes to grow the sport.*

While the CORA Awards Committee was formulating the policy / process, a number of individuals who were known to be influential in the early days of Canadian outrigger canoeing were put forward as potential Candidates and extensive research was conducted to establish their credentials. By the time that the **Canadian Outrigger Hall Of Fame** was approved by the CORA Board, there were already 15 individuals identified with impeccable credentials. Ongoing research into the **Team Canada IVF Legacy** and "**The Burrard**" led to 3 more individuals who had been "under the radar". These 18 individuals were on the 2021 Ballot and every one of them was elected with the necessary quota of votes for induction.

It was during a "pilgrimage" to see "The Burrard" in the forest behind the home of Jackie Bell that the idea of a presentation at the Comox OC6 event for the 8 Inductees who called Comox home was proposed. CORA had yet to determine what the "commemoration" noted in the **Canadian Outrigger Hall Of Fame** policy / process would look like. Kerr Recognition in Vancouver has provided many of the CORA awards for many years and a session with the Kerr Recognition staff led to the design of the **Canadian Outrigger Hall Of Fame** plaques that have been presented to each of the Inductees or a representative for them.



The CORA website has a perpetual page dedicated to the **Canadian Outrigger Hall Of Fame** where one can view the Bios of the 2021 Inductees (Jackie Webber; Rick Nu'u; Peter Forand; Hugh Fisher; Sheila Kuyper; James Van Nostrand; Don Irvine; David Boulding; Mel Whittall; Heather Taylor; Drew



Mitchell; Garry Mancell; Bob Disbrow; Cheryl Skribe; Alan Carlsson; Jim Mancell; Ron Kaschula; Annie Boulding) that should provide the level of credentials CORA takes into consideration for nominees.

CORA was very fortunate that the inaugural year process was completed in early August 2021 several weeks before the Comox Valley Canoe Racing Club (CVCRC) OC6 event at the end of August. Comox graciously organized and hosted a Canadian Outrigger Canoeing Hall Of Fame presentation for the eight Inductees who have called Comox home.

CORA hosted an online Town Hall session in November 2021 for those Inductees spread across Canada and the rest of the world. The Inductees and Guest Speakers included Drew Mitchell, Tony Hall, Hugh Fisher, Karen Tomlinson, Alwyn Morris, Lynne van Nostrand, Mel Whittall, Sheila Kuyper, Wendy Perkins, Mallorie Nicholson, Adam van Koeverden, Alan Carlsson, Andrea Dillon, Shelley Webber, and Kamini Jain. The Town Hall session was recorded and this priceless gathering of some of the most influential individuals representing 4 decades of outrigger canoeing history may be found on the CORA website.

### **BC SPORTS HALL OF FAME (BCSHOF) & ONTARIO SPORTS HALL OF FAME (OSHOFF)**

*The BC Sports Hall of Fame and Museum preserves and honours BC's sport heritage by recognizing extraordinary achievement in sport. Since 1966, the BC Sports Hall of Fame has inducted 417 individuals and 64 teams. Once inducted, these individuals and teams become known as Honoured Members and Honoured Teams respectively and are honoured in the BC Sports Hall of Fame's Hall of Champions. Their stories of triumph, leadership, overcoming adversity, and trailblazing innovation have shaped British Columbia sport and culture for well over a century. By remembering, honouring, and celebrating these individuals and teams, the hope is their stories inspire future generations to follow their dreams in sport and life.*

CORA has had discussions with the BC Sports Hall Of Fame and they were very interested in receiving nominations for individuals from outrigger canoeing as they have only a single canoeing Inductee. CORA has nominated 7 individuals to the BC Sports Hall of Fame and 1 individual to the Ontario Sports Hall of Fame for consideration on their 2021 ballots.

We have heard back from the BC Sports Hall of Fame that their selection / induction process was paused for over a year due to the COVID pandemic of 2020/2021. Nominees received by 30-Jun-2019 were inducted as the 2020 class in a virtual ceremony in July 2021. Nominees received by 30-Jun-2020 were evaluated in September 2021 for induction as the 2021 class for a ceremony sometime in July 2022. Nominees received by 30-Jun-2021 as the 2022 class will be evaluated sometime late in 2022 at the same time as when Nominees received by 30-Jun-2022, as the 2023 class will also be evaluated sometime late in 2022.

The situation is that even though CORA nominated a stellar group of candidates for Athlete and Builder and Pioner and WAC Bennett Awards by the 30-Jun-2021 cut-off date, we will not know who might be elected as Honoured Members into the 2022 class until sometime late in 2022.

### **PETER FORAND MASTERS CHALLENGE ADMINISTRATION**

PNWORCA Executive is responsible for administering the PNWORCA Winter Series Race Results and communicating standings in each boat / gender / age division. It is important that CORA and PNWORCA Race Directors communicate PNWORCA Winter Series Race Results in a timely manner and consistent format to the PNWORCA Race Chairman. Administration of the **Peter Forand Masters Challenge** standings adds a level of complexity due to the consolidation of all female / male OC1 Masters (40+ / 50+ / 60+ / 70+) into a single division. CORA Board has taken the lead on PNWORCA Winter Series Race Points for the **Peter Forand Masters Challenge** standings and collaboration with the PNWORCA Race Chairman since 2017. There is a Series Points Template to assist with this process. There should be a knowledge transfer for this process.

### **HUGH TOWN MEMORIAL BUILDER ADMINISTRATION**

The procedure for administration and bestowing is well-documented. There is a concern that this is a novel process and has not yet become ingrained in CORA Board business-as-usual or as an expectation by the membership as to how this should happen on an annual basis. Nor is there an individual who has been tasked with ensuring that the procedures are followed.

### **CORA AWARDS VENDORS**

Note that Kerr Recognition Services Inc. in Vancouver BC has provided trophies and glass awards and medals for CORA for many years. There are many recognition services vendors that provide comparable products / services. However, the proprietor (Sae Kerr) and the designer (Ross Lawton) have collaborated with CORA for many years and provide exceptional service and maintain records of design work and invoices going back to the 1990s. A recent change in business operations for Kerr Recognition Services means that when plates / shields on trophies require engraving to commemorate the current year recipient, these plates / shields are now out-sourced to a third-party vendor and CORA must replace the existing plates / shields that are affixed with double-sided tape.

## **CORA RACE SUMMARY REPORT (AGM) 2021**

### **CORA WINTER SMALL-BOAT VIRTUAL RACES**

CORA Board anticipated in Autumn 2020 that 2021 early season big-boat (V12 / OC6) events might be in jeopardy given the uncertainty surrounding COVID going into Winter 2020 and so coordinated a 2021 CORA Small-Boat Racing Winter Series on a regional basis. The BC Provincial Health Order (PHO) that went into effect in November 2020 was still in place as CORA approached the first event of the 2021 CORA Small-Boat Racing Winter Series in January 2021. CORA responded quickly to this situation and reorganized the 2021 CORA Small-Boat Winter Races into a set of three virtual races, one in each of January / February / March with CORA Board Members doing the vast majority of the work, with the six host clubs (Jericho; Fairway Gorge; False Creek; Nanaimo Ocean; Latitude 48; Fort Langley) sharing equally in the proceeds from the virtual events.

Participation was predominantly from Vancouver Island, the BC Lower Mainland, and the Okanagan with 65 paddlers registering for 124 entries.

CORA had provided for a 2021 CORA Small-Boat Winter Races Prizing Grant that was awarded to Predator Performance Designs (XS Unified) as the sole sponsor. It was hoped that the "Apex" events on Vancouver Island and the BC Lower Mainland would be in-person and that the sponsor could distribute draw prizes to a set of random winners. Predator Performance Designs provided more than enough prizes such that every participant was a "winner" and CORA conducted a mass packaging / mail-out to send at least one prize to every 2021 CORA Small-Boat Virtual Races participant.

### **CORA SPRING SMALL-BOAT VIRTUAL RACES**

With most of Canada still under travel / gathering restrictions going into Spring 2021, CORA leveraged the experience of the 2021 CORA Winter Small-Boat Virtual Races and organized a set of 2021 CORA Spring Small-Boat Virtual Races, one in each of April / May / June with CORA Board Members doing the vast majority of the work, with the 6 host clubs (Comox; Vernon; Kelowna; VOS; Penticton; Fraser Valley) sharing equally in the proceeds from the virtual events. Participation from Comox / Vernon / Fraser Valley was notable, while participation from Kelowna was 0, Penticton was 0, and VOS was 2.

Participation was from Vancouver Island, the BC Lower Mainland, the Sunshine Coast, the Okanagan, Calgary, and Ottawa with 99 paddlers registering for 180 entries.

CORA provided for a 2021 CORA Small-Boat Spring Races Prizing Grant that was awarded to Waterfront Outfitters (Vancouver Island), Oddball Workshop (BC Lower Mainland) and various dining establishments for paddlers far-away from the two BC sponsors. CORA opted not to have another mass mail-out of prizes to winners. A one-day in-person meet-and-greet was held in Vancouver for BC Lower Mainland paddlers to collect prizes of their own choosing in-person while winners from Vancouver Island and far-away received e-Gift Cards to redeem at Waterfront Outfitters in Victoria or a dining establishment in their locale ("Eat well and prosper").

## PNWORCA SMALL-BOAT RACES WINTER SERIES

The 2021 PNWORCA Small-Boat Races Winter Series proceeded as per the PNWORCA 2021 racing schedule with 5 events (Wasabi; Mountain Home; Kai Ikaika; Bellingham; Seattle Sand Point). This was the first time since 2004, when a Canadian event was added to the PNWORCA Small-Boat Races Winter Series schedule, that there were no Canadian events on the schedule. The first three 2021 PNWORCA Small-Boat Races Winter Series events were all virtual (Wasabi; Mountain Home; Kai Ikaika), were well attended by PNWORCA / CORA paddlers, but the lack of Canadian PNWORCA / CORA sanctioned virtual events meant that Canadian paddlers had 2 less events for the Points standings. The final two 2021 PNWORCA Small-Boat Races Winter Series events were in-person and were very well attended, but the closed USA / Canada land border crossing precluded Canadians from participating in the Bellingham and Seattle Sand Point events. The USA / Canada land border crossing has since been reopened in August 2021 to travel northbound and hopefully there will be Canadian events on the 2022 PNWORCA Small-Boat Races Winter Series schedule.

There were a small number of PNWORCA paddlers who also did the 2021 CORA Winter Small-Boat Virtual Races. There was one individual who dominated OC1 Masters paddling in all virtual and in-person events. **Beau Whitehead** of Bellingham WA was recognized as the 2021 Peter Forand Masters Challenge Trophy recipient and joins Peter Marcus and Minnie Fontenelle as recipients of this award.

## CORA RETURN TO IN-PERSON RACES

Travel / gathering restrictions were relaxed to varying extents across Canada by Summer 2021 as roll-out of COVID vaccinations offered hope for return to "normal". Several races that had been on the schedule for Summer / Autumn 2021 proceeded as planned and several races on the schedule for Winter / Spring 2021 that had been cancelled were rescheduled to provide for missed racing opportunities. CORA clubs were able to host **9 in-person events**. The in-person events for the 2nd half of 2021 included:

- False Creek Round Bowen Small-Boats (July) / [Finishers = 41 Iron and 38 Change](#)
- Fairway Gorge Splash-Dashe OC1, OC2 Fairway Gorge (250M Sprints) (August) / [Finishers = 35](#)
- Fairway Gorge Splash-Dashe OC6 Fairway Gorge (250M Sprints) (August) / [Finishers = 12](#)
- Comox OC6 Iron (August) / [Finishers = 35](#)
- Comox Small-Boats (August) / [Finishers = 43](#)
- Fairway Gorge Guts and Glory 1000M, 1500M, 1200M OC6 Sprints (September) / [Finishers = 20](#)
- Lotus Poker Paddle OC6 Mid-Distance (September) / [Finishers = 26](#)
- Toronto International Outrigger Challenge (TIOC) OC6 Iron (September) / [Finishers = 5](#)
- Toronto International Outrigger Challenge (TIOC) Small-Boats (September) / [Finishers = 84](#)
- Latitude 48 (Ocean River) Bridges OC6 Mid-Distance (October) (Amalgamated May 2021) / [Finishers = 44](#)
- Latitude 48 (Ocean River) Bridges Small-Boats (October) (Amalgamated May 2021) / [Finishers = 43](#)
- Fairway Gorge Wet-Dashe OC6 Changes (November) / [Finishers = ?? \(No results posted by AGM\)](#)

It is worth noting that at the July 2021 CORA Board Meeting, several weeks before in-person events resumed, new Distance Race Rules were approved effective immediately making it:

- Compulsory upon CORA Sanctioned Event Hosts to put into place registration processes that provided for all 24 Age / Gender Divisions for Distance (not Sprints) small-boat and big-boat events

- Compulsory upon CORA Sanctioned Event Distance (not Sprints) small-boat participants to "Race Their Age"

## **CORA IN-PERSON RACES ATTENDANCE**

Another racing season impacted by COVID makes it impractical for year-over-year comparisons:

- There was no CORA Cup Series in 2020 or 2021
- Paddlers had minimal opportunities to train in big-boats for a handful of big-boat events
- Paddlers had few opportunities within their region to participate at in-person racing events
- There was much discussion in early 2021 regarding increased participation by Novice / Open paddlers / crews, yet CORA and CORA Sanctioned Event hosts did very little to encourage increased participation by Novice / Open paddlers / crews

CORA continues to support small-boat racing by providing subsidized Small-Boat Racing Numbers at zero cost to host clubs. The process for acquiring new CORA Small-Boat Racing Numbers from the long-term vendor has been documented and saved to the CORA Google Drive for Business Continuity.

## **RACE RESULTS FORMAT**

- Race Results continue to be collected and reported in various formats including PDFs and Google Sheets and WebScorer and Images and unformatted emails.
- CORA hopes to address this concern by introducing a standardized Race Results template that will facilitate CORA Cup Series Points tracking and reporting.

## **2022 PLANNING**

CORA Board is optimistic that we will return to normal by the beginning of the 2022 season. CORA Event Sanctioning requests will continue to be accepted until April 2022. However, CORA Board recognizes that the ongoing COVID concerns create uncertainty with regard to 2022 early season big-boat (V12 / OC6) events. CORA is actively pursuing an Eastern Canada CORA Cup Series to engage Ontario / Quebec clubs and paddlers. CORA is also actively pursuing a BC Lower Mainland Sprints Regatta event this coming year at the Burnaby Lake Rowing Centre that has had major renovations over this past year.

# CORA 2021 Small-Boat Winter Series Proposed Scheduling

## OVERVIEW

CORA will be coordinating a 2021 CORA Small-Boat Racing Winter Series on a regional basis, given the uncertainty of the current health crisis and the challenges regarding big boat (V12 / OC6) racing going into the 2021 season. This initiative is not meant to replace 2021 Winter big boat racing, but is meant to offer an alternative should Winter big boat racing not be feasible.

## TABLE LEGEND / NOTES

- Three Vancouver Island (VI) clubs and four Lower Mainland (LM) clubs submitted "Intent To Host" forms.
- Some clubs specified a single preferred date, some two preferred dates, and some three preferred dates.
- There have been no requests yet from Sunshine Coast or Okanagan / Interior or Alberta or the East.
- Jericho and False Creek hosted PNWORCA Winter series events in **2019** on Feb-15 and Mar-7.
- Lotus has already requested Jan-16 for Ice Breaker in 2021, although Grace has recently indicated that Ice Breaker will not likely proceed without a vaccine widely available.
- Fairway Gorge has already requested Feb-6 for V12-V21 in 2021.
- Fairway Gorge has already requested Mar-7 for Kan-U-Hak-It in 2021.
- False Creek has recently requested dates for March Madness in 2021 (3rd weekend in March is traditional) of Mar 27/28.
- Note that CORA clubs still have until April 2021 to request event dates, and March Madness is the most recent traditional pre-April event to be requested.
- Vancouver Island 4th (VI4) club is open at this time. Comox has declined. Nanaimo Ocean Paddling Club (NOPC) has offered to host two events (one on their traditional Crazy 8's weekend and one on Feb-20/21 weekend). Fairway Gorge Paddling Club (FGPC) has offered to host two events (one on their traditional V12-V21 weekend and one on their traditional Kan-U-Hak-It weekend).
- The "Recommend" Vancouver Island dates under both **Proposal A** and **Proposal B** have a 2-week gap between each of the four events, alternating weekends with Lower Mainland dates, with the final VI event on Mar-20/21 weekend. The only "wildcard" is the Mar-13/14 weekend where there is LM / VI overlap which could be NOPC Plan B or a backup for a "snow weekend". There may be an option to move Latitude 48 event between Saturday / Sunday if 2021 March Madness traditional weekend goes ahead.
- The "Recommend" Lower Mainland dates under **Proposal A** have a 2-week gap between each of the four events with the final LM event on Mar-27/28 weekend. This scenario avoids a Lower Mainland date falling on March Madness traditional weekend should False Creek request that weekend.
- The "Recommend" Lower Mainland dates under **Proposal B** have a 2-week gap between each of the four events with the final LM event on Mar-13/14 weekend. This scenario avoids a Lower Mainland date falling on March Madness traditional weekend should False Creek request that weekend.
- Note that the proposed scheduling under **Proposal A** presently has no dates in January and this would allow Ice Breaker to reschedule for a later January date should there be an opportunity to take advantage of more fortuitous circumstances.
