#### Grant Updates – Ron

#### Clinic Grants -

- Jericho Paddling Club submitted a late Clinic Grant Application on October 2, 2022 <u>after</u> the hosting of the OC6 and OC1 clinics on September 17 and 18, 2022. JPC's error occurred as a result of new people taking on administrative roles at the club.
  - Clinic Grant Applications are required to be submitted well in advance of the proposed clinic so that the clinic can be advertised to all CORA members on the CORA website. No non-JPC paddlers attended the clinics. These Clinics are intended to benefit the general "paddling community". There are "challenges" regarding this Clinic Grant and we recognize that these Clinics usually benefit a smaller audience. However, advertising these Clinics in advance presents a semblance of transparency. This Clinic was not advertised in advance and conferred benefits upon the service provider and the host club.
  - o JPC has requested a grant of \$600.00, with apologies for submitting late.
  - JPC clinic expenses: Coaching cost: \$1,600, Travel for coach: \$486, Rental of extra OC1s: \$150. Total:
     \$2236
  - o JPC clinic revenues received: \$840.00 (42 x \$20).
  - Note that Leanne is excluded from voting as she provided coaching at the clinics.
  - CORA has \$1200.00 (of \$4000.00) unused in the 2022 Clinic Grant budget allocation.
- Erik: FGPC has hosted clinics for only FGPC paddlers and not applied for grants. No brainer that they do not qualify for the grant since it was not advertised externally. No. @ problems submitted after and did not advertise externally.
- Cindy: Would support it if it is in the budget.

- Jonathan: Disappointed that they did not advertise the clinic, as FLCC paddlers would have taken the opportunity to attend an open water clinic. No.
- Rob M.: NoGraeme: No.
- Ron: Doesn't meet the application requirements.

#### Comox CORA Cup Series Championship Event (CORA 2022 AGM Race Committee Place-Holder)

 Many of these observations will be in the CORA 2022 Race Committee Report as these comments apply to all CORA 2022 Races. However, these comments are included in these CORA Board Meeting Minutes as these comments are very specific to the Comox 2022 CORA Cup Series race.

# Attendance at the big-boat and small-boat events was low in comparison to 2021 and previous CORA Cup Series Championship races.

- There are many reasons for this in the post-Pandemic (vaccines available; gathering / travel restrictions removed) times.
- The vast majority of non-Vancouver Island paddlers present were from crews in CORA Cup Division contention and pickup paddlers. There were no VOS, DZPC, Delta, Lotus, FLCC, Harrison, Gibsons, Penticton, Vernon, Kamloops, Calgary, USA crews.
- There was a same-day conflict with Penticton DBF which drew Interior / Alberta / Lower Mainland DB / OC paddlers.
- There was a same-day conflict with War Canoe Races (growing) at Kitsilano Beach which drew Vancouver Island / Lower Mainland / Interior / Alberta First Nations paddlers.
- This event was requested to be moved to early September 2002 to accommodate Team Canada paddlers going to 2022 London IVF Sprints. Yet the number of Team Canada paddlers who attended Comox was not significant.

# Saturday was a very long day with 4 separate races and no post-race party / meal / social.

- There were several food trucks that provided lunch boxes, but the CORA Cup Series Championship Hosting Grant was not used.
- Crews that were not in CORA Cup Series contention used to attend the CORA Cup Series
   Championship event for the competition and the social, but not anymore.
- Recommend paying Comox some of the Food & Entertainment Grant as a gesture of appreciation as although they did not have a "gala" (meals-provided social), they did have live music all-day and put on an organized / class event.
- Kona 2022 Sunday Luau provided boxed meals to minimize participant interaction with a buffet, yet awards and entertainment for all Sunday Kona races happened in one place at the end of day.
- Comox could not consolidate races due to a shortage of OC6s.

- There were only 28 OC6 crews and only 13 OC6s.
- There was only 1 Spec OC6 used by 1 crew for 1 race (CORA Cup Division contenders).
- Island Brave brought 2 Unlimited OC6s but they were both used for only the Men's race and were not shared.
- Powell River has a trailer and Unlimited OC6s and Spec OC6s but borrowed Unlimited OC6s from Comox.
- Recommend some consideration of amending the Travel Grant to provide for trailering via BC Ferries even for short distances.
- Exceptionally low tides meant for a very long time to get OC6s from the launch dock to the start line and back into the dock.
- There were awards / prizes after each of the 4 races which meant the organizers were constantly waiting for paddlers from the prior race to return to the Stage after they had finished their race and helped launch crews for the next race.
- The schedule had the Junior / Novice OC Paddle draw happening after the short course, but most of the OC Paddle draw winners were doing the Men / Women / Mixed Long Course race – so we did the draw prize announcements multiple times.

#### The growing "Unlimited / Traditional OC6 Schism"

- Nobody wants to trailer / race Spec OC6s for long-distance races.
- There were only 3 trailers that brought 6 Unlimited OC6s in total.
- There were 3 truck-toppers (Comox; FGPC; Island Brave) that brought 6 Unlimited OC6s (yet only 1 could utilize the Travel Grant amendments).
- Even crews that had access to Unlimited OC6s (Jericho / Lotus / Powell River) borrowed other Unlimited OC6s.
- This "schism" is deterring many clubs (VOS; DZPC; Delta; FLCC; Harrison; Penticton; Kamloops;
   Nanaimo; Maple Bay; Sproat Lake) without Unlimited OC6s and unable to borrow Unlimited OC6s from doing CORA long-distance races (unless they can do a short-course in Spec OC6).
- o There were no CORA Cup Series 2022 Short-Course contenders.
- There is becoming a "Haves" and "Have-Nots" split. There are 6 Vancouver Island clubs (Latitude 48; Fairway Gorge; Geronimo; Island Brave; Comox; Wolf Pack) that have 10 Unlimiteds, while there are 7 Vancouver Island clubs (Pearson; VIP; VCKC; SLCC; Maple Bay; NOPC; NPC) that have Zero Unlimiteds. There are 4 Lower Mainland clubs (Jericho; Pac Reach; FCRCC (5); Lotus; that have 8

- Unlimiteds, while there are 8 Lower Mainland clubs (VOS; DZPC; Delta; FLCC; Harrison; SNCC; Pemberton; Gibsons) that have Zero Unlimiteds. There are 3 Interior / Calgary clubs (KPC; Vernon; Calgary) that have 6 Unlimiteds, while there are 4 Interior / Calgary clubs (Kamloops; Penticton; Shuswap; Leduc) that have Zero Unlimiteds.
- There is becoming a reality where only clubs / crews with Unlimiteds or who are able to borrow Unlimiteds are doing CORA Distance races, while those clubs / crews without Unlimiteds are doing only the "canoes-provided" races such as IceBreaker V12; FGPC V12; March Madness; FLCC Spring Run; Waterman; Poker Paddle; Bridges; Wet-Dashe).
- Note that this is a PNWORCA "schism" as well with 8 PNWORCA clubs (Silverdale; Rikkole Cree;
   Bellingham; Kai Pana; Sand Point; Seattle Outrigger; Kikaha; Mountain Home; Hood River) that have
   14 Unlimiteds, while there are 10 PNWORCA clubs (Puget Sound; Autumn Rose; Wakinikona; Bridge City; Wasabi; Kai Ikaika; Columbia River; Bend; Tri-Cities; Pacific City) that have Zero Unlimiteds.

#### **BC Ferries Chaos**

- Canceled Sailings (weather-related) and Canceled Sailings (maintenance-related) has led to unreliability and reduced the willingness of some travelers to ride BC Ferries.
- Smaller / older ferries have been used due to BC Ferries staff shortages and this has reduced deck capacity
- BC Ferries Reservation maximum % increased from 40% to 80-90% in 2022 due to removal of travel restrictions leading to higher travel demand leading to more travelers paying the Reservation Fee leading to less deck capacity for "No Rez" travelers leading to many sailings waits for "No Rez" travelers or paying the Reservation Fee.
- BC Ferries is now strongly enforcing "over-length" / "over-height" rules resulting in extra charges for 20+' small-boats.
- Recommend consideration of inclusion of small-boats trailer for BC Ferries Travel Grant to reduce cost of multiple small-boats going to Vancouver Island / Lower Mainland / Sunshine Coast small-boat races.

#### **General Comments / Observations**

- o It was asked why races are not held on Long Weekends to simplify travel to/from races.
- Lotus was scheduled for Canada Day, but was forced to reschedule to July 23 by the City of Burnaby.
   Note that Lotus Iron was in conflict with Bellingham Iron, but Bellingham canceled when Seattle

- Outrigger moved Da Grind from Aug 6 to BC Long weekend forcing PNWORCA paddlers to choose between Bellingham or Da Grind.
- However, PNWORCA paddlers / crews are not coming to BC as they did in the past due to ArriveCAN and border waits (3+ hours since Easter weekend – unless you have Nexus).
- August Long Weekend was open for Comox. This would have given Comox the opportunity to have their race long before London IVF Sprints, but with Lotus on July 23, this would have been 1 week between races.
- CORA race scheduling needs to recognize that it is not just CORA regional races that need to be considered, but also PNWORCA races, DB races, War Canoe races, and Team Canada trials / Championships.
- CORA sent the Membership List to Don Irvine and not the Comox "Race Registrar" and this led to challenges ahead of Registration.
- Recommend that some (#; %) Club Volunteers should be considered for the draw prizes as they are giving huge amounts of free hours. This concern was raised at Lotus Iron as well as Comox Iron.
- Small-boat attendance was lower than in past years. This may have to do with many factors such as paddlers opting to leave ASAP after the Saturday event, or 2021 being a "gathering" year after 2-years of Covid, or overall Saturday attendance being much lower, or BC Ferries creating a situation where getting back to the Lower Mainland sooner rather than later was a priority.
- The Travel Grant enhancements to deal with the 2022 "fuel crisis", although well-intentioned, has done
  little to encourage participation at CORA Long Distance 2002 races due to fewer crews / paddlers
  attending CORA Long Distance races.
- Covid has become an annoyance more so than a threat. Yet vaccinated / boostered paddlers continue to get infected with Covid and this has impacted Lotus Iron, London IVF, Napali, Seattle Change Race, and Kona crews by taking paddlers out of commission before / during / after these races.

# **Concentration at larger clubs**

- Fewer crews from fewer clubs have been doing CORA 2022 races, yet some clubs were able to send a number of crews to several races.
- 2+ Years of the Pandemic has had a negative impact on club leadership and club membership and crew racing.
- Many smaller clubs have not been sending crews to even the "boats provided" events.

 Many of the 2022 "boats provided" planned events fell through (Icebreaker – COVID restrictions; March Madness – Covid concerns; FLCC Spring Run – Leadership turnover) leading to fewer club / crew building opportunities.

#### New Business

- a. Proposed recommendation (Motion) for Event Scheduling (2023 & Going Forward) Every CORA Club to be limited to a maximum of 3 CORA Sanctioned Event <u>Weekends</u> per year (Examples: 1) Lotus Icebreaker; Lotus Iron; Lotus Poker Paddle 2) FCRCC Winter Series; FCRCC March Madness; FCRCC Round Bowen 3) Latitude 48 D'Arcy Cash Dash; Latitude 48 Island Iron; Latitude 48 Bridges 4) Penticton Duel; Penticton Skaha Downwinder; Penticton Length-Of-The-Lake) - Graeme
- b. Proposed that CORA Sanctioned Event Submissions consider a later start from early January to early February to contend with ongoing harsh Winter conditions and likelihood of PHOs in response to ongoing COVID waves
- c. TIOC CORA Membership Day Fees.

i. Do we allow races to roll the CORA Day Fee into a race fee (in future)?

Erik: No, that would complicate matters, because there would be there are permissions when a CORA Member joins CORA and data handling and data submission. Chris made a mistake, but it should never happen again. Ron: Leads to double payments as well.

Cindy: Are Day Fees paid on-line or in person. Agree it should not be rolled into race fees. Chris admitted to his mistake.

Jonathan: Largely on-line now. Consider if others who have paid would be upset by relaxing the fee for this mistake.

Graeme: Last year TIOC had a horrendous event due to weather conditions. This was the only CORA race in the East this year - so he was winging it, so the knowledge surrounding race administration isn't clear to them. Graeme is on board with allowing a relaxation in this case and take measures to see that it does not happen again.

Leanne: Chris did get guidance from Leanne, just not from the Board. She agrees that this is a one-off and the race directors' guide should address it. It is rare that cash is handled at races and we want to avoid having to handle cash at races. Agree that we don't roll into fees.

ii. Do we allow a reduction in the Day Fees to \$5.00 on a one-time basis?

**BE IT RESOLVED THAT**, as a one-time occurrence, the CORA Board reduce the CORA Day Fee to \$5.00 for the approximately 127 participants in the 2022 Toronto International Outrigger Challenge who had not previously purchased either CORA 2022 Annual or Day Fee memberships, and that TSCC Maka Koa pay such reduced fees to CORA, with an acknowledgment that in future, TIOC shall not roll CORA membership fees into their race fees. Moved by Ron; Seconded by Jonathan. **APPROVED**
