- Uniforms Fit Kit went to Jericho for people to try on samples. Will be at Comox as well. Samples are ready to check colours and get approval. Uniforms are very different from previous years; we are making a statement. Brandon Gabrielle is the artist, the story behind the graphics will be sent out to all athletes.

# iii. IVF Board

- We have had one request sent in for the race calendar.
- What criteria do we want to set for being included in the IVF Race Calendar.
- CORA built the platform that IVF now uses.
  - Erik submitted a request into IVF for a test.
- Will CORA races be included on the IVF schedule.
  - The suggestion is that yes, we should submit our races to be listed on the IVF Calendar.
  - Procedure used by IVF is that once we submit a race that approval is sought by the CORA rep.
  - We should at least submit Lotus CORA Cup and an Eastern Race. Erik will ask Grace to submit for IVF and to Foruzan for the TIOC race.
  - We should recognize that the audience for this is both local, national and international. Any races posted should be able to handle guest teams, destinations should also be considered.
  - This is a trial year for the calendar.
  - As we control our CORA race calendar, we can add a button for clubs submitting race requests to choose that the race also be included on the IVF calendar. Can be implemented for 2024.
    - Note Ron will then have the opportunity to put in a reminder that all host clubs need to be able to accommodate guest teams with information about

the race, area, insurance requirements and event itself.

# f. Financials/Treasurer Update - **Jonathan**

i. I am pleased to attach financial statements to the end of May. It is also uploaded to the drive.

#### ii. A couple of things.

- 1. The race fees have been paid to IVF for the Samoa event. To maintain a credit balance in the IVF account at RBC, I have temporarily loaned \$10,000 from the General Account. I have not shown that on the balance sheets, though.
- 2. Yesterday (as I write) was the first day for the paddlers to pay the outstanding items, and over \$5,000 was received. Around \$10,000 is still due, which I am confident will arrive in good time. The 2023 program is still on course to make a small surplus (which will then be carried forward to the 2025 event).
- iii. The Hilo 2024 program will soon be sending out its first invitation to apply. This will attract a small cash flow. A detailed budget is yet to be completed for this.
- iv. My recollection of the rationale for providing a Host & Prize grant opportunity for CORA Cup hosts was that they were to be encouraged to provide a bigger, more 'party-like' atmosphere for paddlers by providing entertainment and high-quality food options. And their reward would be a grant of up to \$800 for their prize fund.
  - At Penticton, there was no 'party'. The food for paddlers was a very nice 'home-made' sandwich, a cookie and a can of soda. CORA was mentioned. The grant was authorized, without discussion. The paddlers' race fee was \$40 - so the club's income was around \$13,000.
  - At Jericho, the food was a modest commercial sandwich, a piece
    of fruit and a cookie. There was no 'party'. There was mention of
    'our sponsors' but not of CORA. The grant had been pre-spent by
    a CORA director without any discussion. The paddlers' race fee
    was \$46 so the club's income was around \$13,000.
  - For Lotus, the grant has been pre-spent by a CORA Director without any discussion or experience of the event.

#### v. My points:

- \* The 'party' is not happening. The paddler experience has not been improved.
- \* The food quality has not been improved we had imagined hog roasts, etc.
- \* The pre-spending of grants, and/or their automatic payment, removes all incentive for their proper application.

- \* The purchase of prizing for multiple events by an unauthorized director not only removes the incentive, but creates a sense of "same prize at each event". The prizing should come from the club in order to reflect their taste, aims and ideals.
- vi. I believe that we need to change things. Our aim was to attract more racers, by increasing the paddler experience, yet all we are doing is throwing our members' money straight into the coffers of the host clubs.
- vii. I mentioned a couple of weeks ago that I have been appointed to the Audit Committee of the IVF. The first meeting was yesterday except the Treasurer didn't turn up, despite prompts, so the rest of us had a simple intro chat. Eh?
- viii. Graeme responded to this There have been many races that have met the criteria for a good party.
- ix. Do we believe that there is an expectation that all clubs running CORA cup races are not providing a good party.
- x. The door prize monies are to be used for door prizes.
- xi. One of the issues that has caused a lack of party is that several teams cannot stay around for the party.
  - 1. It is felt that no this is not the case. Remember that this is to promote CORA not the host clubs.
- xii. Dean Comox makes a point to attract people from all over by providing good swag, food, etc. Agrees that going to an event should be eventful. Continue to promote use of money, etc.
- xiii. Rob M Jericho was not recognized as helping out, no mention of CORA input, etc. This is a concern.
- xiv. Leanne Query are monies given ahead of time or in return for receipts. Race Directors have access to funds, but they need to provide receipts and acknowledge CORA.
  - 1. If CORA is doing, purchasing, is IT at request of race directors or a combination of receipts.
  - 2. As we do not have assets, we should not be purchasing swag.
- xv. Graeme Receipts were sent in when he purchased swag for CORA door prizes, he was trying to meet the rush on wanted items by getting them before the rush.
  - Communications were sent out to clubs regarding CORA monies to assist
  - 2. Happy to post on CORA website the contacts for swag and how to get in contact with them.
- xvi. Jonathan Requests that Graeme receive confirmation from CORA before he purchases Swag in CORA's name.
  - Who? The Board states that ("Agrees" this wording was not an accurate representation of what was said at the Board Meeting) we should not spend CORA money on behalf of a host club. They should apply for the grant.

Xvi Jonathan reminded all Directors of the requirement to request payment using the CORA credit card, unless personal expenses have been authorized in advance.

xvii. Ron - it is up to the race director to decide where the swag prizes are coming from. Some clubs handle their own, some request assistance.

- xviii. Erik governance roles if we are actually in the process for third parties it could intrinsically have benefits to it but could lead to perceptions of self-serving or impropriety. We need to have discipline in place, the Board needs to separate itself from perceptions of impropriety. As such as a governance Board we should leave the spending to the race directors.
  - 1. This is not Graeme's fault; we need to ensure that this grant or use of swag monies is not misinterpreted. As such we need to remove ourselves from actual spending.
- xix. Ron should have a discussion with Rob V on this, as it was his original concept.

The following was a memo attached to the minutes, just before the meeting started. It is not a minute of the meeting. It is a personal opinion and not a statement of the Board. It has not been attributed to Graeme.

# 2023 CORA Cup Series Expectations

- I cannot speak to expectations for the CORA Cup Series events in terms of a more 'party-like' atmosphere. I believe the CORA Cup Series Championship Grants were intended to provide financial incentives to the CORA Cup Series Championship host club to provide entertainment and high-quality food options. I believe that Lotus as the CORA Cup Series Championship host club will do this. I do not believe that there was any expectation that the other CORA Cup Series event hosts would provide anything more than some sort of food / beverage options.
- Please note that the CORA Swag Prize Grant was never intended to provide for an enhanced food / beverage / entertainment experience at the CORA Cup Series events. This Grant was meant only to provide for an assortment of random draw prizes for participants.
- Please note that I had a lengthy discussion with Jericho who was under the mistaken impression that the CORA Swag Prize Grant was available to use for Awards. I was quite clear that Awards for Placing and Prizes for Attendance / Participation are distinct. I was quite clear that Jericho needed to provide for Awards in accordance with CORA Race Rules.
- If there are CORA Board Members who believe that ALL CORA Cup Series event hosts are responsible for providing substantial food / beverage / entertainment for participants, then I highly recommend that this be stated clearly to those clubs who request CORA Cup Series status and be communicated clearly in the CORA Cup Series communique that is distributed each year.
- As to the CORA Cup Series Swag Prize Grant for 2022, I did not attend 2022 Penticton and have no knowledge of how Penticton utilized their Swag Grant. I did not attend 2022 Latitude 48 and have no knowledge of how Latitude 48 utilized their Swag Grant. I did attend Lotus 2022 and I believe that the assortment of 60 Swag draw prizes from 5 local vendors was well received by the attendees. I did attend Comox 2022 and I saw that the host club provided a massive selection of Swag prizes sourced from within their own club and Comox utilized the CORA Swag Prize Grant to acquire some exquisite artwork from local vendors that was well received by the attendees.
- As to the CORA Cup Series Swag Prize Grant for 2023, all 4 Western Canada CORA Cup Series host clubs were notified that the \$800 Swag Prize Grant was available again. Penticton opted to go with their local vendors. Comox has opted to go with their local vendors. Lotus and Jericho communicated that they wished to combine their \$800 Swag Prize Grants and have CORA leverage the wholesale accounts that have been established over the past few years to arrange for wholesale discounts and volume discounts and minimal GST and free shipping. I did not attend 2023 Penticton but I understand that Penticton purchased a variety of local wines / ciders with the CORA Swag Prize Grant. I did not attend 2023 Jericho as I was busy putting everything I own into a portable

storage container that weekend, but I do know that Jericho was provided several boxes of Swag from 5 different local and First Nations vendors. I do not plan to attend 2023 Comox as I am still searching for a home, but I have no doubt that Comox will offer an assortment of Swag Prizes comparable to their 2022 event. I do intend to attend 2023 Lotus and I have several boxes of Swag from 6 different local and First Nations vendors to deliver to Lotus for their CORA Cup Series Championship Event.

- On a personal note, the CORA Chairman and myself have gone to great lengths to communicate expectations for CORA Cup Series events (Swag Grants; OC Paddle Grants; Junior Subsidy; Championship Grants; Race Rules) to the CORA Cup Series host clubs. Penticton complied with the expectations around Grants. Jericho complied with expectations around Grants. I fully expect that Comox and Lotus and VOS will do so as well. I myself have spent much of my own personal time over the past few years establishing long-term relationships with many vendors including Oddball, Predator / XS-Unified, Coast Outdoors, Purdy's, Spirit Bear, St. Jeans, Main Street Brewing, and others. These local and First Nations vendors have provided CORA merchandise / services (banners; decals; jerseys) at reduced cost as well as freebies in exchange for little more than promotion on CORA social media.
- I do what I can when I can to add a bit more "pomp & circumstance" to CORA events. I've ensured the Hugh Town Memorial Trophy went to Penticton in 2022 for presentation to Don Mulhall and Drew Mitchell. I've taken the Hugh Town Memorial Trophy to several Lotus events in 2021/2022 for presentation to Grace Morissette. I've taken the Hugh Town Memorial Trophy and the Peter Forand Trophy and the CORA Hall Of Fame Plaques to Comox in 2022 to recognize the Recipients. I've ensured the Hugh Town Memorial Trophy went to FCRCC in 2023 for presentation to Jan Chavarie. I ensured the Peter Forand Trophy did the Winter Series circuit in 2023 and went to the Championship Event for presentation to Minnie Fontenelle. Please do not give me grief when I am going the extra mile to support CORA events.

#### Email from Patrick Langley, CEO & FOUNDER of VAIKOBI

"From our side, as you mentioned, our Vaikobi PFD's right now are certified to ISO 12402-5 (level 50), however it is important to note that they are not designed to meet Transport Canada/ USCG, the way their standards are right now.

PFDs' that have to meet the USCG/ Transport Canada standard, are designed with a significant amount more buoyancy on the front of the PFD and provide a higher level of buoyancy- 70N.

They are a different product overall and there are some features that are not allowed to be put into a USCG/ Transport Canada approved PFD.

In Canada and the US, race organizers quite commonly allow ISO 12402-5 PFDs because they are far more practical for paddlers in that they are more comfortable to wear and also allow for easier re-mounting of your craft.... ultimately making them safer for this reason.

We certainly could go and design and develop a USCG / Transport Canada approved PFD and we certainly have looked at it a number of times, however we keep coming to the conclusion that we will be developing a product that is inferior in performance when compared to what we have....and potentially would not meet the performance standards that our customers expect from Vaikobi products.

I really think it should come back to CORA and the Canadian Outrigger community to revisit this issue and consider allowing ISO certified PFD's to be used by paddlers on the basis that they are a far more effective design for performance paddling and overall, a better and safer alternative.

Furthermore, the concept of people wearing a PFD (that they like to wear) rather than to not wear one at all (or an impracticable one like the waist belt style), is actually really the goal at the end of the day.

I would be more than happy to try and assist where possible on this matter."
