    - i. Two of the clubs applied for grants to be done, Pearson for wood mill work and VCKC for repairs to their Calmar (concern about VCKC request as they are still pursuing an estimate), recommending that we do not accept. Leduc was late and vague in their request, thus doesn't qualify.
    - ii. Jonathan advised Just over \$22,400 unspent as of this date, proposed that all should be approved.

Races: FLCC - River Run, PRCC - Duel in the Desert, Jericho Iron - Jericho, Lat 48 - Island Iron and Lotus - Lotus Iron.

No applications for Nationals yet. Recommended Nationals should be the 3rd weekend in September, 2024.

The following are notes that Graeme prepared and discussed during the meeting:

- ii. A spreadsheet has been compiled of all known CORA & PNWORCA & Dragon Boat & Away (Hilo; Kona; Catalina; Pailolo; etc.) dates and has been posted to this CORA AGM folder. There are several conflicts and alternatives to consider.
- iii. FLCC Spring River Run is proposed for 1 weekend before Penticton Duel In This could be the "linchpin" event that could shape the 2024 CORA Racing

Season. Based on questions about water levels at Deas Island Regional Park in late-April / early-May, I looked at Government of Canada Monthly Water Level Graph data (2021) for Fraser River at Mission (08MH024) [BC]. See the link below that shows the historical water level just upriver from Fort Langley (Mission) steadily climbing from a low in early-March to a peak in early-June and steadily dropping through June and July. If the preference is for an early May date to avail of the freshet, could we consider a Canada Day FLCC Summer River Run or a BC Day FLCC Summer River Run to provide for 3 BC Lower Mainland CORA Cup Series events and provide for spacing between all 5 proposed CORA Cup Series events? https://wateroffice.ec.gc.ca/report/historical\_e.html?stn=08MH024&dataType =Monthly&parameterType=Level&year=2021&mode=Graph&scale=normal

- iv. In terms of a CORA Cup Series Championship event, Lotus may be reluctant to host the event 2 consecutive years. It may be worthwhile to consider the 3day BC Day August Weekend (2 weeks after Lotus & 1+ week before Hilo 2024 Sprints) as a potential CORA Cup Series Championship weekend. The 2 most likely options are Latitude 48 (giving up their early-June preferred date) or FLCC (giving up their early-May preferred date) and going with BC Day August Weekend. Penticton mid-May date is traditional and avoids Okanagan wildfire risks. Jericho late-May date is traditional and unlikely to change.
- v. FCRCC PNWORCA Winter Series race is proposed for the same Saturday as Kai Ikaika PNWORCA Winter Series race. FCRCC may consider going earlier in the schedule (Mar-2?) as the Mar-23 weekend (March Madness) and the Mar-30 weekend (SPOCC PNWORCA Winter Series race) are taken.
- vi. NOPC Crazy 8's OC6 & FGPC KAN-U-HAKIT OC6 are both proposed for the Mar-9 weekend. FGPC or NOPC may consider going to the Mar-2 weekend as there are no conflicts (yet) on the Mar-2 weekend.
- vii. FCRCC Bowen Island is proposed for the Jun-22 weekend, which is the Concord Pacific DB Festival weekend. If FCRCC wishes to compete with the Concord Pacific DB Festival, then so be it.
- viii. Lotus Iron is proposed for Jul-20 weekend. This may not be the last viable CORA Cup Series weekend, but it would mean another CORA club changing their preferred race dates or another CORA Cub coming forward. Aug 13-24 is Hilo 2024 Sprints. Aug-31 is Kona. Every weekend in Sep is an away race. The BC Day weekend on Aug 3/4/5 would be the next most viable CORA Cup Series finale. Is another CORA Club going to propose a 6th CORA Cup Series Event for the BC Day Long Weekend? Would FLCC or Latitude 48 consider hosting the CORA Cup Series finale on the BC Day Long Weekend?

- ix. If Lotus does host the CORA Cup Series finale, then CORA would need to recruit another CORA Club to host the Sunday Small Boat event as we did in 2023, as Lotus opted not to host the 2023 Sunday Small Boat event.
- Discuss whether CORA would like to host Sprints Nationals or hand back to a Host Club
  - i. See Graeme's proposal for 2024 Sprints Nationals for CORA to host Sprints at Delta. More cost effective, parking, etc., have been addressed. Suggestion of FCRCC being the contractor for this event.
    - If CORA decides to host 2024 Sprints Nationals, then the Apr-27/28 weekend and the May-4/5 weekend are both enviable. If FLCC opts not to host a race on the May-4/5 weekend, then there would be zero conflicts that weekend for a Sprints Championship event at Deas Island, as there would be zero CORA, PNWORCA, or Dragon Boats events on that May-4/5 weekend. If FLCC goes with a race on the May-4/5 weekend, then the Apr-27/28 weekend would be 1 of 3 back-to-back-to-back CORA event weekends (Sprints; FLCC; Penticton), and would conflict with a PNWORCA OC6 event that would take away potential PNWORCA Hilo 2024 Sprints paddlers / customers.
  - ii. Suggestion of arranging for National Sprints on April 27th weekend, be it Delta or any other club.
  - iii. As it is a Sprints year it is expected that there will be a lot of attendance.
  - iv. Ask Graeme to follow up with Delta to determine whether April 20th or 27th is available for the CORA Sprints [AI]. Once we have this confirmed we can set out terms of reference and send it to FCRCC as the contractor [AI]. Will pencil in dates for now [AI].

  - a. Leanne Touched on a few ideas around coaching, regarding club coaches using benefits from mentorship, etc.
  - b. Stuff in the budget for coach to coach regional, coaching education.
    - i. How can we create a pathway for clubs to get coaches, do we need to vet coaches, how does CORA want to support clubs to get coaches.
    - ii. Curriculum for coaches can CORA run one in 2024 via zoom.
      - 1. What parts of the curriculum do we feel is important as a board where we talk to other coaches, where do we fill the gaps in their knowledge, for instance how to set a boat, etc.
      - One of the first things we need to offer is how to start being a coach, and need curriculums for the different stages of coaches' expertise.

      - 3. How does a club develop its coach, it is not necessarily the loudest person in the boat.
      - 4. How do we know whether a coach has its credentials
      - 5. Coach to coach meetings suggestions of how to reinforce what you already know.
      - 6. Look at what is available through other bodies like NCCP and fill in the gaps for outrigger, show where CORA has contributions to make.
      - 7. Take some of the non sport specifics from NCCP and fill with outrigger.
      - 8. Coaching theories apply across the board

- 9. NCCP grounding is useful, CORA is overall not regulated
- 10. Remember being a good paddler does not make you a good coach
- 11. The average paddler does not know where to begin when they are interested in becoming a coach
- 12. We should spend a bit of time building content for paddlers to access when they are interested in coaching. [AI]
  - a. If people don't know where to begin, they don't know how to apply for coaching education grants
  - b. Need a relevant timeline
  - c. What is reasonable to accomplish need to draw up a draft outline for the Town Hall coaches session. Could be a blend of both CORA board and guest speakers for this meeting. [AI]
  - d. Perhaps a how-to manual Part 1 can come out of the discussions.
- 13. Need a session for aspiring coaches which tells people how to learn how to become a coach. Perhaps in a Town Hall.
- iii. Vetting process can include conflict of interest, ensuring coaching credentials, etc.
- iv. Schedule of best practices to set the groundwork for coaches
- v. Alan Carlson did work on coaching manual as did Rick Nu'u
- vi. We need to determine who, through CORA, can be accessed for training.
- vii. You cannot hire anyone without the right credentials to work with Juniors

- 9. General Discussion topics
  - a. Eastern Canada OC Strategy (Foruzan) not discussed Foruzan Absent
    - i. Registration & CORA Membership Package Deal (Erik)
    - ii. Eastern clubs have noted that it is cheaper using OMCKRA.
    - iii. CORA could look into a day package for races requiring the membership data. How can we capture the CORA Individual (Day) memberships but not make participation financially disincentivizing?
    - iv. Need to include a discussion regarding engaging Eastern clubs and getting them involved in CORA at Pre-AGM. (2023-09)
    - v. Based on TIOC & ORPC historical participation, an Eastern Canada Waterway Series involving Ottawa and/or Montreal does not seem viable. Ottawa River Paddle Challenge (ORPC) 2023 had only 3 Mixed OC6 crews & 3 Women OC6 crews. Ottawa has only 2 clubs with 3 OC6s in total (ORCC has 2 Bradleys & Rideau has 1 Unlimited). Montreal has only 3 clubs with 5 OC6s in total (Huanani has 1 Mirage; Onake has 1 Bradley & 1 Unlimited;

Aumakua has 1 Unlimited). Huanani travels but has no OC6 trailer. Aumakua travels and has an OC6 trailer.

- vi. TIOC historically has had many GTA (OC & DB) & Ottawa & Montreal crews. GTA has many OC & DB clubs (Wai Nui; TSCC MKO; TSCC FS; Sunnyside; Outer Harbour Dragon Boat Club (OHDBC); Mississauga Canoe Club (MCC); New Dragons Outrigger Club (NDOC); New Dragons Racing Club (NDRC); Canadian Senior Dragon Boat (CSDC); Rusty Dragon Adventures; Wahnapitae; NPNP?) - This is where the clubs & paddlers are. Wai Nui has 8 OC6s & TSCC MKO has 3 OC6s & TSCC FS has 1 OC6 & MCC has 2 OC6s & Sunnyside has 3 OC6s & OHDBC has 2 OC6s - This is where the canoes are. It is a 4-hours Ottawa-GTA & 5-hours Montreal-GTA drive for the 2-3 competitive Ottawa & Montreal clubs.
- vii. Wai Nui Why Not runs westerly from Port Credit. TIOC runs around/through Toronto Islands; **Recommend a 3rd GTA OC race (to form a GTA OC series)** hosted by CORA Club (Sunnyside?) supported by CORA running easterly possibly round-trip Woodbine Beach-Bluffers Park. CORA had not received 2023-Jul-29 Round Bowen Race Results as of 2023-Nov-15; Round Bowen Race Results were not on WebScorer or PaddleGuru or FCRCC website or FCRCC social media - only on the Jericho website; Round Bowen Race Results did not accurately present Age Divisions (missing; incorrect); FCRCC Race Directors should be aware of the Distance Race Rules and should provide Race Results in a timely / accurate manner.

The spectacular rise of the unlimited canoe at our long course races continued unabated, and was amplified by the IVF World Distance Championships in Samoa, which lead to peak demand for the Are Matahina OC6s among Team Canada crews.

Their tireless training and racing in the Matahinas certainly paid off, as Team Canada placed 4<sup>th</sup> in the medal tally in Samoa, with 5 gold medals, 2 silver medals and 4 bronze medals. Congratulations to the athletes and Leanne, Rob, Cindy, Kamini, Scott and James on the IVF Committee and Area Coordinator Rick for their time and dedication in supporting Team Canada. The IVF Committee is already in high gear with selection for 2024 IVF World Sprint Championships in Hilo.

This Summer, we inducted 7 athletes, coaches and community builders into the Canadian Outrigger Hall of Fame, which recently capped off with a Town Hall videoconference and whose detailed biographies are available on the CORA website.

We salute you, Ruth Matson, Nancy Botting, David Hill, Lynda Roberts, Norman MacDonell, Leanne Stanley and Len Morris Jr.

I'd like to thank each of the CORA directors, officers and volunteers who have donated their time to make the organization run smoothly. Our finances are in check thanks to Jonathan Wilkins. Leanne Stanley and the IVF Committee for our successes abroad as we look forward to Hilo. Graeme Galves for his extensive work in CORA's historical review, the Hall of Fame and other awards. We have an ongoing debt of gratitude to Erik Ages and his team at Fairway Gorge for their work in managing the CORA website, video conferencing and other technical aspects of our operations.

Ronald Chin President Treasurer's Report to CORA AGM November 26, 2023

I am pleased to present the financial report for the Year to December 31, 2022.

Looking first at the Balance sheet for the General Account, you will see that CORA continues to maintain a healthy balance at the bank.

During 2022, CORA took advantage of a 'free' credit card from RBC in order to simplify much of our spending. The proviso was that CORA transfer some funds to a GIC that matches the credit limit on the card. At a rate of 2.8%, we were pleased to do so.

The BS also shows how we transfer the funds available for RME grants to a Reserved Fund, in order to 'protect it' from other discretionary spending. We encourage clubs, especially the smaller clubs, to take up their potential RME Grants.

The IVF programs – for paddlers to represent Canada at the Sprint and Distance World Championships – are maintained in a separate account.

Each cycle of the Sprint or Distance events is operated as separate funds in a second bank account. This is because each program is intended to break even, with the registering and competing paddlers paying all the costs of that program.

And the Income Statements for London 2022 and Samoa 2023 reflect that intention.

The CORA Board has been considering the financing of these programs over the last few months with the intention of making the whole process much clearer to all participants. More on this will be published to the hundreds of paddlers who have registered for Hilo 2024.

The Board has also been working on its Budget for 2024. Again, it shows that we plan to make a modest loss by providing a budget for all the opportunities that we anticipate, especially those that we haven't quite accomplished in 2023.

If you have any questions, do please ask. I prefer emailed questions, as I can no longer keep all these numbers in my head.

Rest assured, we are frugal.

In fact, we are like the bow seat of a Bradley – a tight ship.

# CORA OUTBOUND COMMUNICATIONS REPORT (AGM) 2023

## OVERVIEW

CORA'S board and supporting volunteers worked to manage the provincial, national and international full return (post COVID) as regions, clubs and international races assumed full programming over the 2023 paddling season.

## SOCIAL MEDIA & INTERACTIVE BROADCASTING

CORA engaged with members and non-members, both within and beyond Canada, through a variety of interactive townhall and clinic sessions over the year. These sessions continue to meet a number of objectives, including keeping our members connected and communicating with each other through discussions relevant to our sport.

The CORA board intends to continue with these interactive video-based townhalls and clinics going forward in 2024.

## COMMUNICATIONS INFRASTRUCTURE

The CORA board will continue to invest in improvements to speed, responsiveness and security of our platforms (web, direct email, social media) over the coming year. Our website was rennovated with new security and anti-spam services over the 2023 year



**CORA INBOUND COMMUNICATION REPORT (AGM) 2023** 

## OVERVIEW

There was a time when the CORA Email Inbox necessitated constant monitoring due to the volume of enquiries for CORA Board activity that flowed through this channel.

The adoption of Google Workspace (formerly G Suite) with Gmail, Calendar, Meet, Chat, Drive, Docs, Sheets, Slides, and Forms has simplified internal / external communication. The migration to a new CORA website with many self-service capabilities has also reduced the workload on the CORA Board:

- RME / Trailering / Coaching / Clinic Grant Applications that had previously been submitted to the CORA Email Inbox and then forwarded to the Grants Officer are now sent directly to the Grants Officer via online forms.
- Event Sanctioning Applications that had previously been submitted to the CORA Email Inbox in the weeks
  prior to the AGM and then forwarded to the Race Committee are now managed directly by CORA Club
  Reps through the CORA Website Race Calendar.
- Enquiries for CORA Membership Lists by Race Directors prior to Sanctioned Events are now readily available from the Membership Officer.

There are presently 2 Board Members who receive notifications when messages flow into the CORA general enquiries email address. The COVID Pandemic of 2020/2021/2022 substantially reduced the historical volume of inbound messages. Return To Sport 2022 through 2023 led to a significant reduction in COVID related enquiries and a notable increase in typical COVID pre-Pandemic enquiries.

## **TRENDS / HIGHLIGHTS**

This section is a Summary of Inbound Communication Trends / Highlights:

- Much of the CORA Inbound communication has been consolidated into a CORA General FAQs that will be published shortly with references to the soon-to-be published CORA Insurance Summary and CORA Race Directors Guide.
- Many of the Frequently Asked Questions (FAQs) related to Membership, Clubs, Forums, Resources, Racing, Grants, IVF, Town Halls, and Safety from past years have continued through 2023.
- CORA Inbox SPAM communication has continued to decrease due to more filters introduced by the CORA Website Admins (Thank you Erik & Paul) – This is a good thing.
- CORA Inbox COVID communication has continued to decrease due to vaccines facilitating "Return To Sport" - This is a good thing.
- CORA Inbox Insurance communication has continued to increase due to CORA Sanctioned Events increasing with "Return To Sport" - This is a good thing.
- CORA Inbox Race Results communication has continued to decrease even with CORA Sanctioned Events increasing This is NOT a good thing. This topic may have belonged with the Race Committee Report, but that report has to do with Event participation. This topic has to do with Event responsibilities. The CORA Race Committee goes to great efforts to publish CORA Sanctioned Event Results in a timely manner and in a consistent format for 2 reasons: 1) To provide the paddling community a single source of information on the PNWORCA Small-Boat Racing Winter Series standings & the CORA Cup Series standings & every other OC6 / Small-Boat event so that the racing community can assess their performance in relation to other

clubs / paddlers; 2) To provide the CORA Board with year-over-year data analytics to assess the direction of the sport of outrigger canoeing. The CORA Board provides much support to the outrigger canoeing community including establishing a balanced annual outrigger canoe racing schedule, promotion on CORA social media for CORA Sanctioned Events, CORA insurance for canoeing activities and insurance certificates for CORA Sanctioned Events, Grants for National Hosting events and OC6 Transport and OC Paddle Prizes and Swag Prizes and Junior Subsidies, as well as awards at National Hosting events. In exchange for the efforts by the CORA Race Committee, CORA has certain expectations of the Host Clubs including hosting a safe event, hosting a "quality" event, and submitting event results to the CORA Inbox in a **timely manner** (within 48-96 hours) and in a **manageable format** (website link, TXT, Word, Excel, PDF – not photographs of white-boards or pieces of paper). Far too often in 2022 and even more so in 2023, the CORA Race Committee has not received event results into the CORA Inbox in a timely manner or in a manageable format. Far too often in 2022 and even more so in 2023, the CORA Race Committee has had to visit the **CORA Sanctioned Event Host Club website** or **Webscorer** or **PaddleGuru** or the **Jericho website** to find CORA Sanctioned Event results. Hopefully this oversight will be highlighted in the upcoming 2024 CORA **Sanctioned Event expectations.** 

## **RECOMMENDATIONS (IDEAS CARRIED FORWARD FROM 2021/2022/2023)**

Many of these types of enquiries have been flowing into the CORA Email Inbox for many years. Some of these enquiries do necessitate action by Board Members such as posting Race Results and issuing Insurance Certificates and so on. However, some of these enquiries could be handled by the membership themselves with a certain level of knowledge transfer. Some of these enquiries for information do not necessitate action by Board Members by providing a website page of Frequently Asked Questions (FAQs) to commonly asked questions.

CORA Board had an Action Item from 2021/2022/2023 to add FAQ functionality to the CORA website. The CORA Communications Officers investigated several options for WordPress FAQ capability (plugins) for the CORA website in early 2022. CORA installed a simple WordPress Accordion FAQ plugin on the CORA website in Mar-2022. This WordPress Accordion FAQ plugin was found to be very robust and was used for the 2022 CORA Burnaby Lake Sprints to distribute answers and resources in a timely manner and to a broad audience in response to a huge volume of enquires about this end-of-April 2022 CORA managed 2-day event.

The successful experiment with this WordPress Accordion FAQ plugin has led to these outcomes:

- A review of the 100's of CORA Contact Us emails for the past 12-24 months has resulted in a set of very Frequently Asked Questions - and standard answers / responses provided.
- There will be a new CORA General FAQ published to the CORA website in early December 2023 with FAQs organized by Grants, Membership, Insurance, Safety, Clubs, IVF, Forums, Town Halls, Results, Racing, Resources, Awards, Historical and other categories.
- Most of the FAQ Answers will contain links to pages / sections / forms on the CORA website.

## **CORA BUSINESS CONTINUITY REPORT (AGM) 2023**

## OVERVIEW

The Business Continuity Report for 2021/2022/2023 has been substantially revamped from the Business Continuity Report of previous years. This Business Continuity Report has usually served as a checklist of what the CORA Secretary needs to ensure that the CORA Board does leading up to and moving forward from the AGM signifying the transition from ending of the current year to beginning of the coming year.

There is substantial "institutional knowledge" carried by each of the CORA Board Members with regards to tasks related to their duties such as Grants, Financial, Secretarial, Insurance, Membership, IVF, Town Halls / Education, Event Scheduling, Website Administration, Information Systems Security, Awards, and Racing.

The current CORA Board has gone to great lengths during this COVID Pandemic hiatus to document and record as much as possible of this "institutional knowledge" so as to ensure Business Continuity and smooth transition as CORA Board Members complete their "tour of duty" and hand-off duties to the next generation.

## RECRUITMENT

The CORA Board contingent has varied over the years and presently provides for 12 Board Members with each Board Member asked to commit to a 3-year term. There is a set of CORA Board Members who have served multiple 3-year terms and accumulated a wealth of "institutional knowledge". Serving on the CORA Board as a Director and/or Committee Member is an opportunity to share new ideas and make contributions to the paddling community. The CORA Board has made requests via direct email to CORA Club Reps and CORA website posts for individuals from every club from all across the country to come forward and take on a role with the CORA Board in the coming years. The CORA Board will continue these recruiting efforts to bring on board new voices and provide knowledge transfer to support the membership.

## **KNOWLEDGE TRANSFER (LATEST INITIATIVES)**

- CORA has compiled a <u>Properties Registry</u> to track the whereabouts of all CORA "Properties" such as the Peter Forand Trophy, the Hugh Town Trophy, the CORA Weight Scale, the CORA Feather Banners, 2023 CORA Cup Series Medals, and CORA Small-Boat Number Decals, so that CORA Board Members know exactly where to find each of these Properties.
- CORA has compiled a <u>Contacts Registry</u> for all Vendors / sponsors that have provided goods and services as well as all Authorities (Burnaby; Fortis; Burnaby Lake Rowing Club; etc.) so as to expedite locating contact information for these parties in the future.
- CORA has compiled a <u>Small-Boat Number Decal Registry</u> so that ordering new Small-Boat Number Decals is just a matter of checking for the sequence of the last 100 pairs of small-boat numbers and finding contact information for the vendor.
- CORA has compiled a <u>Burnaby Lake Sprints Registry</u>. The CORA Board has kept a record of every piece of documentation and communication related to hosting the Burnaby Lake Sprints. The intent of this <u>Burnaby</u> <u>Lake Sprints Registry</u> is to provide a step-by step guide for the CORA Board or any CORA Club that might be interested in hosting this event at the Burnaby Lake Rowing Venue in the future. The information that was collected includes documents for: Planning; Contacts; Vendors; Sponsors; Budgets; Applications; Insurance;

Contracts; Communication; Safety; Waivers; Scheduling; Registrations; Refunds; Lessons Learned; Awards; Medals; Banners; Jerseys; Invoices; Receipts; Claims; Course; Rules; Protests; Venue; Visuals.

- CORA has compiled a <u>CORA Secretary Guide</u> in early 2022 to provide each incoming CORA Secretary with an inventory and guidance on every task that the CORA Secretary needs to perform each month as well as before / after the AGM.

- CORA has continued to compile a <u>Club Logo Registry</u> over the course of 2020/2021/2022/2023. This
  catalogue has details for the club and branding of every club in Canada that has participated in outrigger
  canoeing. This is referenced in the CORA Canoe Registry Report (AGM) 2023.
- CORA has continued to compile a <u>Canoe Photo Registry</u> over the course of 2020/2021/2022/2023. This catalogue has 1-2 photos for every "big-boat" (OC6 / OC4) in Canada so as to provide a visual catalogue to support the <u>Canoe Registry</u>. This is noted in the CORA Canoe Registry Report (AGM) 2023.

## **GOOGLE SHARED DRIVE STRUCTURE (ONGOING INITIATIVE)**

## WEBSITE STRUCTURE (ONGOING INITIATIVE)

The CORA Website structure has systematically taken a functional / historical hierarchy where the convention has been high-level topic (Race Results / Minutes) and then year / month (2000-2023) where applicable and then specific pages within that topic / year to a lesser extent, with a focus on the current season.

Conventions have been noted for creating and naming functional / historical levels and adding specific pages within those folders in a Standard Operating Procedures (SOP) spreadsheet.

## STANDARD OPERATING PROCEDURES (SOP) SPREADSHEET (ONGOING INITIATIVE)

Many yearly / monthly / periodic tasks from the CORA Google Shared Drive structure and the CORA website and the Business Continuity Checklist have been captured into a Standard Operating Procedures (SOP) spreadsheet. This Standard Operating Procedures (SOP) spreadsheet does not contain tasks that do not require interaction with any of the CORA information systems (CORA Website; CORA Facebook; Membership DB; Gmail; Calendar; Meet; Chat; Drive; Docs; Sheets; Slides; Forms). This document contains six columns:

- Done (Task completed year or month)
- Topic (Category for the task such as AGM or Financials)
- When / Event (Trigger for the task such as end-of-month or end-of-year)
- Where (Place for the task such as Google Shared Drive or Website)

- Who / Responsible (Owner such as Web Admin or Grants Officer)
- How / Tasks (One or more tasks to be completed by the Owner when the Event happens)

This Standard Operating Procedures (SOP) Google Sheet on the Google Shared Drive should provide CORA Board Members with guidance on yearly / monthly / periodic tasks to be addressed. The Google Sheet can be sorted / searched on any column.

## **INFORMATION SYSTEMS SECURITY (ONGOING INITIATIVE)**

The adoption of Google Workspace (formerly G Suite) with Gmail, Calendar, Meet, Chat, Drive, Docs, Sheets, Slides, and Forms has reduced the CORA Board's reliance on Word / Excel / PDF files being stored on personal computer drives and shared via email. The migration to a new CORA website with many self-service capabilities and distributed access amongst the CORA Board members has also reduced the workload on the CORA Board. However, each of these technology advancements has increased the need for governance and maintenance to minimize disorder and establish best practice protocols.

The CORA Website Administrators conduct periodic and periodic updates to safeguard the CORA information systems and permissions structure:

- A security audit is conducted after each AGM as Board Members are offboarded / onboarded for the coming year to ensure timely provision / removal of permissions and update the Business Continuity Checklist.

### How can CORA assist you

#### Open floor discussion:

**Karen** – super challenging all over since COVID to get juniors on the water. They start off with dragon boating, small numbers right now. Hugh Fisher will be around to coach more, which is exciting and teaching the fundamentals to the kids.

Would like to ask Hugh if we would consider coaching a mini camp, this would be an asset as he is ia former Olympian.

They move the paddlers through the different paddling types to avoid overlap. CKBC has now included SUP and very supportive.

How can we support our clubs by getting spring camps, The weather is beginning to be a factor that can impede paddling.

There is a calendar on the CKBC website for courses for coaches. Most of them courses are virtual. The in person component will

need to be sorted out. ELCC course is the next one up.

They have difficulties getting their OC6 rigged all the time and thus can't always accommodate the need to paddle.

CKBC offers SUP polo, Pemberton bought a kit through CKBC but the kids had a lot of fun. It is a lot of work to set it up and take it down.

Along the lines of Tamlyn's suggestion perhaps someone to write the descriptions of the programs, market, etc., could CORA assist with hiring someone and assist with paying them.

CKBC applies for the Canada Summer Jobs Grants as well and typically hires three people each summer.

<u>**Tamlyn**</u> – Does work with Leanne Stanley when she is available. Most of the focus is on summer camps, a good return from summer camps. Eventually they have continued on to not only paddle but coach within the club. There is a bit of gap between new paddlers and more experienced. Most kids like the variety, thus it can be tough to get a commitment from juniors to one paddling sport as

opposed to all. Introduced a Fun and Fitness program, the kids have not moved up yet. They do not offer a year round program due to scheduling conflicts, during COVID they did very well.

Had a mini camp last year for kids in SUP, not just local but out of town as well, they raced in a local race after the camp. It was a success.

Happy to host a race up at Kelowna, they have four spec boats and three unlimited. A sprint race is always a fun thing to do.

Hawaii is always appealing if we go toward a sprint race. Parents do like the idea of their child being selected to race and represent Canada.

Kelowna has 40 SUP boards and can accommodate. Big park beside the paddling centre, enough boats to accommodate everyone. If we do a week long event, the college has week long bookings and we can rent apartments from them. Monday to a Saturday camp.

Suggestion of communicating with the other paddling groups to ensure that we don't have overlap for races; such as Deep Cove SUP races, to coordinate.

There are paddling opportunities to coordinate with CKBC as well, joining for training camps, etc. They did last year at the Burnaby training camp.

When her kids found out they could get their coaching credentials it motivated them.

Having all the outrigger kids together in person at a clinic learning from each other is a very good way to build relationships and the community.

Tamlyn is happy to host an educational camp.

Suggestion of a "Show Down Race", having all the kids come and race off in their favourite craft.

CKBC had a road show that used to go around to all the clubs that didn't have coaches. Can CORA send around coaches that the clubs to pay a percentage of the wage that they could go around to the different clubs, maybe to assist with marketing as well. The coach to go to the different clubs, this would be a full time position that would be partially paid by CORA and by each club taking advantage of this. They could offer \$8,000.00 for the two months of the summer.

Could CORA apply for Canada Summer Jobs.

<u>Chris</u> – VYPC was open as training was in small boats and it was less restrictive during COVID years, VYPC is also a member of CORA. Has eight SUP boards.

Coach Certification – the best thing to do is still use the CKBC format that is tied into Coaching Canada. When you do it for outrigger you just change the focus.

The lowest level of training is Canoekids which is for community development programs and also requires Safe Sport. For ELCC coaches also need safe sport, NCCP multi-sport training and Making ethical decisions. ELCC also requires continuing education to maintain.

You must have your multi-sport through NCCP and make ethical decisions through NCCP and do continuing education of 25 credits

for the ELCC level. There is trained, which is course work and certified, someone comes in to certify you.

Suggestion of doing multi-sport through NCCP, which can bring in a different concept. There are problems with trying to meet the

needs of all the different levels of paddlers.

<u>Grace</u> – Shut down for three years due to COVID, last year was the first group of juniors. Too many for one dragon boat and for coaches; they have had to restrict to 14 and over, and cannot accommodate the younger paddlers. They have an older group of 18 and over who are going to Hawaii. Grad paddling trip which included an island for the weekend; a lot of grade 11's want to do this as well.

Lotus does Dragon boat, SUP and outrigger. They move the paddlers through the different paddling types to avoid overlap.

Marianne – Not Another Dam Race in Arizona is a good race to encourage juniors to race at. Kids love that.

Kids love getting together to race, but also racing off one another. Getting the interest in this and the buy in will help to keep kids.

Can everyone share their race calendars to help avoid overlap and perhaps assist each other in fielding teams.

Suggestion of having all levels of paddling abilities to attend a summer camp.

CORA has agreed to waive the race registration fees for junior teams and will help get canoes for junior teams when they come down to race.

It has actually been very wonderful to have teams racing with such a mix of ages paddling together - There isn't such large gap in age categories at our club now and many adults and juniors paddle together regularly. Out of 74 total club paddlers, 40% are younger than 40. We have 16 junior paddlers and 14 Open category paddlers; of the 14 Open paddlers, 8 were formerly Lotus juniors. - Many adult paddlers will donate home baked goods to the junior concession - There is extensive support from not only the adults at the Lotus Sports Club, but also through other clubs. Fort Langley and Jericho have been very welcoming and go out of their way to make our youth feel recognized - Some of our juniors have been provided with career and coaching opportunities/mentorship through adults at our club

I am going to add a few others to this chat who also are involved with growing our youth/junior OC6 programming and may have more feedback to add to this conversation.

As of this point in time, we don't have any Junior Outrigger Teams. I know we are starting a team soon, Brendan will have more details on this one. He's also a Program Coordinator at FCRCC but specifically for the Sprint Canoe/Kayak programs.

This past summer we started to introduce Outrigger Canoe (6) in our youth spring and summer camps, which was a big hit and was multi disciplinary! Ages were from 8-15 years old. Next year we are going to build on this and continue to offer Outrigger Canoe (6) in the youth camps, as well as an additional multi-disciplinary camp for ages 10-15, half day in a Dragon Boat and the other half in Outrigger Canoe (6).

Ideally, it would be fantastic to have year-round programs dedicated to youth in Outrigger Canoe(6) and to learn how to compete in races both distance and sprint. This will take a bit of time to build of course as it doesn't exist... yet! All in all, FCRCC definitely wants to promote and get more youth/junior Outrigger paddlers into this fantastic sport! I'm open to listening to what CORA has to offer to help support us getting started, and seeing where this opportunity may end up! I look forward to hearing back from you!



## 2023 IVF Report for CORA AGM

2023 was the most successful Distance campaign for Team Canada to date. With selection camps continuing on from the Fall 2022 trials into Winter/Spring 2023 to finalize some of the crews, the selection committee were confident in their selections going into Samoa. See the Area Coordinator's report below for Rick Papineau's account of our Samoa campaign.

While paddlers were training for and competing in Samoa, registration for World Sprints 2024 Trials opened during the summer for September trials in Calgary. This was one of our largest Sprint Trials to date with paddlers and crews from all across the country coming to race off to earn their ticket to Hilo next summer. For the first time we had to race of club V6 crews as we had more than 6 apply for open men's and open women's age categories.

We still have many vacant club crew V6 spots available in J16MW, J19MW, 40M, 50M, 60M, 70MW, 75MW, and 80MW so if you or your crew are interested, please email <u>ivfsprints@canadianoutrigger.ca</u>. We also have vacancies for V1 in J16W, J19W, 75W, and 80W.

The 2025 IVF Distance 2025 World Championships will be hosted by Niterói, Brazil. Canada's initial trials are scheduled for October 19 &20, 2024 in Vancouver. The selection process will be published on the CORA website in early 2024 and registration will open late spring/early summer.

With the significant growth of the National Team Program, CORA is working on a more sustainable structure that will better distribute the workload and provide improved service to our paddlers. Stay tuned for details in 2024 as there will be calls for paddlers to join committees, sub-committees, and possible job postings and contract positions.

In IVF news, just a few weeks ago, the member countries of IVF voted unanimously to award the 2026 World Sprint Championships to Singapore. The proposed dates are for June 2026.

### **Observations:**

### **Opening Ceremonies:**

Despite the torrential downpour, the organizers put together a fantastic opening ceremonies event. This began with an athletes' parade of about 900m, led by a local marching band. The ceremony itself included a substantial number of students from the local Don Bosco school singing and dancing, plus a brief fire dance, prayers, speeches, and a kava ceremony that included Canadian paddler, Ellashani George, who was chosen to represent the Pacific Northwest region as she was Canada's youngest athlete (each country was not granted a participant, but rather global regions were determined and the selected country from that region selected their participant).

### Cultural Night:

Once again, the contingent from Star Nation performed for Canada during the Cultural Night. Combining dance with singing and storytelling – led by former BC Lt. Governor Stephen Point – while dressed in full

regalia, the multi-generational presentation shared a glimpse into the history and culture of the Sto:lo people of the Fraser Valley region.

\*\*\* AC note to CORA- for two consecutive World Championships, this family has traveled with their regalia – a substantial number of items – to present for Canada. A stipend or reimbursement for checked baggage costs to transport these items may be considered in the future by CORA to support individuals/groups carrying extra luggage for the cultural performance on behalf of Team Canada. \*\*\*

### Equipment Issues:

Canoes were delivered to the race location only slightly prior to the Canoe Familiarization (CF) period and were not assembled until the first CF day.

Although there were older models in use, the Matahina V6s were generally sound; the only restriction being that they were not to be carried from the bow or stern.

The V1s used were constructionally deficient, with roughly half of the fleet failing catastrophically, including hulls or amas breaking while in use. Several canoes sank during races. Most of the canoes that remained in use until the final day were only marginally seaworthy and took on water in both the front and back compartments of the hull and in the amas. As in London, some canoes caused physical injuries to paddlers, including cuts from sharp edges. Due to the hot and humid conditions, paint and other substances transferred from the canoe to paddlers' clothing.

There were significant complaints from most of the contingent nations. The generally accepted theme, though, can be summarized as: "The paddlers on the water should be deciding the outcome, not the luck of the draw regarding the boat being assigned."

**\*\*\*** AC Recommendation to IVF – per IVF Distance rule 8.2, the seaworthiness of the canoes must be ensured. To ensure seaworthiness during future events, the recommendation is that in future, the canoes are built by *recognized* and *respected* builders, well in advance of the event's commencement, with a prototype/first model presented to IVF for testing and certification. A repeat of the disastrous V1s from this year must not happen in the future. **\*\*\*** 

### AC Position recommendations:

The position of Area Coordinator, as it is presently utilized, is more than simply being at the race site during CF periods and racing. The tasks of verifying paddlers for eligibility, collecting the requisite documents for review by IVF, registering individuals and teams, and communicating with participants for each event begins – at the very latest – before the time trials for the event take place. I would assert that some of these tasks begin as soon as the selection process is set and the registration for trials needs to start.

As such, I would suggest that it is imperative that the AC for the event in question be selected PRIOR to Trials for said event. I would also suggest that, as part of the selection process, the candidate being selected agree to a three-year cycle. This cycle should be as follows: training under the current AC during a Distance event year; operating self-sufficiently as AC during a Sprint year; completing the tasks while training the next AC during the subsequent Distance year. Having done this role for a few events, and having seen personally how much of the works was completed by Leanne prior to being appointed as AC myself in each instance, this new practice should be implemented immediately – especially with Sprint Trials being less than a month away (report written in August 2023).

The process for selection must be open and transparent, and equal to all possible candidates – favouritism must not be shown to any potential candidate(s). A formal application process must be created, with a criteria for selection being published for any potential candidates to review.

Additionally, I would recommend that the compensation for performing the responsibilities be based on a budget (submitted by the AC) of expenses, rather than a decision made by the CORA Board. The amount authorized should include: flight expenses, utilizing the best value Economy rates available; accommodations, based on average rates; rental vehicle including event-specific fuel costs, and; a per diem for meal expenses while at the race site.

Most race days while at Samoa Distance (during London Sprints, it was slightly shorter time per day but spread over more racing days) I was on site from no later than 6:30AM until no earlier than 6:00PM. It is expected that ACs be present whenever a paddler/team is on the water. Prize giving occurred after racing was completed for the day, and AC meetings/briefings often happened after that. Including being available after hours to paddlers with questions, plus the nightly communications email to the team, this made for very long days dedicated to Team Canada and precluded any "sight-seeing" or "tourist" activities from happening while the event was going on.

When including the time required to collect all the team paperwork, complete the online registrations, attend the pre-event Zoom meetings, and answering pre-event questions for participants, plus the actual travel time to the various locations, the time commitment for ACs is easily several hundred hours per event. Despite being in a foreign country, performing the role of AC is not a vacation opportunity. These expectations and requirements should also be conveyed to future AC candidates, and should be taken into consideration when establishing the compensation for attending as Canada must have an AC present to participate in IVF events.



# CORA INSURANCE AND SAFETY REPORT (AGM) 2023

There have been no incidents or insurance claims to report.

CORA's insurance broker remains BFL Canada Insurance Services, and the underwriter is Markel Canada.

CORA maintains a Commercial General Liability Policy providing coverage for CORA Member Clubs ("CORA Clubs") and individual members against claims by third parties for bodily injury or damage third party property when participating in "sanctioned events". Coverage is for up to \$5M per occurrence. The interpretation of "sanctioned events" has always been somewhat vague. The scope of coverage for the day-to-day practices and training activities of CORA Clubs, provided that they are "sanctioned", activities may include:

- CORA-sanctioned races
- CORA-hosted practices, training, time trials and races
- CORA Club practices, training, time trials and races
- CORA Club recreational paddling activities
- CORA Club activities at locations other than the club, so you may paddle out from the club or launch from a remote location
- CORA Members training on their own time, but only if the training is sanctioned by their CORA Club. Coverage does not apply if the training is not sanctioned by a CORA Club or by CORA itself (ie. self-directed or independent training by unaffiliated CORA Members is not covered).
- Use of CORA Members' own equipment
- CORA Clubs may invite "guests" to activities (ie drop-in events) without charging a CORA "day fee" but these numbers should be reported to CORA for inclusion in the "day fee" numbers reported to BFL Canada (CORA is charged a premium for each day fee).

CORA Clubs disclose to CORA the nature of their operations and activities in a questionnaire received from CORA following Club Membership registration. This disclosure to CORA and CORA's acceptance thereof, constitutes the "sanctioning" process.

Member Clubs are reminded to inform CORA if any additional insureds need to be added in respect of their insurance coverage and we will request Certificates of Insurance confirming coverage for and naming additional insureds, such as landlords or local municipalities.

Likewise, Race Directors are also reminded to request Certificates of Insurance for their race confirming coverage for their event and naming additional insureds, such as landlords, local municipalities or other governmental authorities.

We have also confirmed with BFL Canada that CORA Members racing in specified international outrigger races (i.e. SCORA or HCRA races) may request Certificates of Insurance evidencing third party liability insurance coverage when racing, provided that race organizers accept such insurance. The Certificate of Insurance would be accompanied by a letter from CORA's Membership's Officer naming the crew and confirming CORA membership.

We continue to plan to develop a "plain language" explanation of the liability coverages.

CORA also maintains Directors' and Officers' Liability insurance



## **CORA CANOE REGISTRY REPORT (AGM) 2023**

## OVERVIEW

This initiative began in 2020 as an effort 1) to capture an inventory / demographics of CORA "big-boats" (much like the SCORA / OHCRA / HCRA Registries) and 2) to capture details (names / IDs / colours / weights) of CORA "big-boats". This initiative continued in 2021/2022/2023 with data quality improvements to the <u>Canoe Registry</u> and a photograph catalogue based on information collected by the Historical Committee and Awards Committee on the movement of OC6s between CORA clubs.

## **TRENDS / HIGHLIGHTS**

This section is a Summary of Canoe Registry Trends / Highlights:

- Acquisition of new Unlimited OC6s has slowed in 2023 after many years of Unlimited OC6 acquisitions.
- Larger clubs have continued to upgrade their OC6 fleets by dealing their older Traditional OC6s to growing clubs.
- FCRCC has continued to be the CORA used OC6 broker having now dealt 5 Traditional OC6s (4 Calmars and 1 Mirage M2) to other clubs over the past 6 years.
- FGPC has continued its growth to become the dominant club in OC6 ownership, now with 8 Traditional OC6s and 4 Unlimited OC6s.
- Western Canoe Kayaking (WCK) has continued its growth to become the dominant provider of Traditional OC6s and has now passed in numbers the Calmar and Bradley Lightning Traditional OC6s.
- Western Canoe Kayaking (WCK) has continued to be the sole provider of made-in-Canada Traditional OC6s with several more on the books for 2024 (expect a 9-month turnaround).
- First Nations clubs have continued to embrace outrigger canoeing with Geronimo (Brentwood Bay) 1 Unlimited, Island Brave (Nanaimo) 1 Lightning and 2 Unlimiteds, Chemainus (Ladysmith) 1 Advantage, Star Nation (Cultus Lake) 2 Calmars and 1 Advantage, River Spirit (Chilliwack) 1 Advantage, Onake (Montreal) 1 Lightning and 1 Unlimited, and Chehalis (Harrison Lake) 2 Fijians from Gibsons.
- The movement in 2022 of **3 Western Canada Traditional OC6s and an OC6 trailer to Eastern Canada** has provided for increased participation in GTA outrigger canoeing training and racing.
- The proportion of OC6 owned by non-CORA clubs has continued to grow as more clubs acquire new / used outrigger canoes to expand their canoeing options to club members.
- Although many clubs have recently acquired OC6s, very few of these clubs have become CORA Member Clubs to avail themselves of CORA Grants.

## SUMMARY

- We have been able to identify **194** "big-boat" canoes within Canada, up from 169 as of Autumn 2021.
- We have been able to capture current pictures of 94% (182/194) of the "big-boat" canoes within Canada.
- There are 7 CORA clubs and 1 ECORA club that each own at least 7 "big-boat" canoes and collectively own 36% (69/194) of all "big-boat" canoes in Canada.
- 26% (50/194) of "big-boat" canoes in Canada (1 in 4) are NOT owned by clubs / teams affiliated with CORA.
- There is a continual pattern of new clubs being formed and joining CORA, existing clubs leaving CORA, and existing clubs rejoining CORA, which leads to addition of new "big-boat" canoes to the <u>Canoe Registry</u> and a rebalancing of the proportion of CORA / Non-CORA "big-boat" canoes in Canada.
- CORA expects to learn of even more OC6s/OC4s in Canada through-out the coming year as clubs and individuals with privately owned canoes attend Canadian canoe racing events.

There continues to be a dearth of OC6s in Eastern Canada to support the demand; Wai Nui has been supporting local clubs / events with their 8 OC6s but the other 7 Eastern Canada clubs have only 33 OC6s between them and the vast majority of these OC6s are NOT owned by CORA clubs.

2023 was a relatively quiet year in terms of big-boat acquisitions / transitions. False Creek (FCRCC) continues to be the top Canadian used canoe broker as they have now transitioned 5 of their older traditional (Spec) OC6s to other clubs. Fairway Gorge (FGPC) has become the dominant big-boat owner as their fleet has now grown to 12 OC6s.

6 new OC6s showed up in Canada and 3 used OC6s changed clubs since Oct-2022 when the previous CORA Registry Report was compiled. New / Used big-boat acquisitions since the previous <u>Canoe Registry</u> update in Oct-2022 included:

- 1 new Clipper Advantage OC6 acquired by River Spirit (First Nations) from Western Canoe Kayaking (WCK).
- 1 new Clipper Advantage OC6 acquired by TBD from Western Canoe Kayaking (WCK).
- 1 new Puakea Malolo OC6 acquired by Fairway Gorge from Ozone Hana Hou.
- 1 new Giblin Vortex OC6 acquired by Fairway Gorge from Ozone Hana Hou.
- 1 existing used white deck Mirage M2 OC6 acquired by Sudden Impact (Cultus Lake) from FCRCC.
- 2 existing used blue deck Fijian OC6s acquired by Chehalis First Nations (Harrison Lake) from Gibsons.
- 2 existing used OC6s owned by Ontario clubs that CORA learned of during 2023.

### INSIGHTS

This ongoing initiative to maintain the <u>Canoe Registry</u> has yielded these insights:

- Canadian clubs have few options for new OC6s with only the Western Canada Ozone distributor (Hana Hou Sports) the Eastern Canada Ozone distributor (Coldwater), the Florida 3-piece Bradley Lightning distributor (Canoa Havaiana), Woo Outrigger (Europe), and a Western Canada Matahina distributor (private).
- Access to used canoes by Canadian clubs from the States has been impacted by the US/Canada exchange rate (72%).
- Access to used canoes between Canadian clubs is a challenge as those Canadian clubs with a large fleet are reluctant to sell older canoes as these canoes are used for all-season training and these large fleets of canoes are used for events where the host club provides the majority of canoes.
- The challenge of canoe availability is even more prevalent in Eastern Canada where the growth of the sport has been constrained by the shortage of canoes and the travel distances between clubs in Toronto, Ottawa, and Montreal.
- WCK continues to be the lone source of Canadian made Traditional OC6s. WCK manufactured 2 Clipper Advantages in 2023 and has 1 Clipper Advantage on the books for 2024.
- There is a huge demand for spare canoe parts and for canoe repairs. CORA has been in contact with a few suppliers
  of iakos / amas. CORA is also locating companies / individuals who do OC6 / OC1 / ama / iako repairs. Should anyone
  know of companies / individuals who do fibreglass / woodworking for OC6s / OC1s / amas / iakos, please contact
  CORA so that we can update our <u>Outrigger Canoeing Resources Registry</u>.
- CORA has been attempting to inventory OC6 trailers among CORA clubs to assist event hosts with coordinating OC6s. OC6 trailers in Eastern Canada have increased as TSCC Maka Koa acquired a trailer from Vernon Racing Canoe Club and Amakua in Quebec has a trailer certified to provincial regulations. Wai Nui (although not a CORA Club in 2022) has an OC6 trailer that is used to support Eastern Canada OC6 events and this makes for 3 known OC6 trailers in Eastern Canada. OC6 trailers in Western Canada (Vancouver Island; Lower Mainland; Okanagan / Interior) are far more prevalent with OC6 trailers at Comox, FGPC, Latitude 48 (2), Wolfpack, Pacific Reach, FCRCC, Dragon Zone, Lotus, Fort Langley, Harrison, Penticton, Kelowna, Vernon, and Kamloops. It is worth nothing that clubs are moving towards OC6 trailers with less capacity and lower weight ratings to transport Unlimited OC6s.
- CORA continues to reach out to unaffiliated Eastern Canada clubs (Onake; Ottawa River; Pickering; Wai Nui) and Western Canada First Nations clubs to become CORA clubs as CORA learns of OC6s at these clubs.

**CORA HISTORICAL COMMITTEE REPORT (AGM) 2023** 

### OVERVIEW

The CORA Historical Committee was officially formed in 2020 and consists of current and ex-Officio Board Members who continue to collect and curate Canadian outrigger canoeing historical records for posterity. The volume of historical material contributed month-after-month by the paddling community will continue to support the ongoing publication of Canadian outrigger canoeing historical documents.

### **TRENDS / HIGHLIGHTS**

This section is a Summary of Historical Trends / Highlights:

- Interviews with many of the Canadian Outrigger Hall Of Fame 2021/2022/2023 Inductees have continued to fill in many gaps in Canadian outrigger canoeing history.
- IPCF / IVF Team Canada Legacy photos / videos / stories have continued to be contributed from the paddling community.
- The original CORA website article on "Cascadia Paddlers Without Borders" has led to the discovery of several other Cascadia (BC / WA / OR / HI) crews that will be incorporated into that ongoing story.
- The untold story of the Molokai Na Wahine 1985 all-Canadian womens crew finally has been captured and documented in the Oct-2023 CORA Town Hall.
- Discussions in 2023 with Annie Boulding and Ruth Matson may have finally filled in the outstanding gaps in the history of "The Burrard – First OC6 In Canada".
- Paddling community members have continued to contribute a wealth of names / dates / events / photos / stories that will be incorporated into Club Legacy Documents for Comox, Pemberton, Kelowna, Nanaimo, Sunshine Coast, and Wai Nui.

### LIVING DOCUMENTS

The 10 reference documents published since 2020 (see below) are all to be revised shortly. All reference documents published on the CORA website were meant to be "living documents" as details continue to surface that result in additions / revisions to these documents.

### **CANADIAN OUTRIGGER HALL OF FAME OUTCOMES**

This topic is covered in detail in the CORA Awards Committee Report. However, it is worth noting that the 31 Canadian Outrigger Hall Of Fame 2021/2022/2023 Inductee Bios posted on the CORA website Hall Of Fame perpetual page contain a wealth of historical knowledge covering Canadian outrigger canoeing history from the 1970s till present day.

IVF has scant records on the early years of IVF Sprints and for these individuals who were there at that time to fill in the gaps on who was with Team Canada "back in the day" and their achievements are priceless. CORA looks forward to working with Comox, Pemberton, Kelowna, Nanaimo, Sunshine Coast, and Wai Nui on these "living documents".

### **CLUB LEGACIES – EASTERN CANADA**

Interviews have been held with many individuals (Sheila Kuyper; Wendy Rae-Perkins, Nancy Botting; Foruzan Veiji) with knowledge of Eastern Canada outrigger canoeing. CORA hopes to publish an Eastern Canada outrigger canoeing legacy document by the end of 2023 that covers the origins of many of the Ontario and Quebec canoe clubs. CORA Board Member Val Simmons of Haunani has researched history on the foundational canoe clubs in Eastern Canada (Wai Nui and Onake) and has collected an extensive set of material on the key individuals / events of these clubs.

### RESOURCES

Fact-checking, grammar-checking, umpteen email exchanges, and endless online searches in 2020 resulted in a very definitive <u>Canoe Registry</u> of the vast majority of big-boats (OC4s / OC6s) throughout Canada as well as a timeline of the travels of those canoes (continuously updated through 2023).

## **CORA AWARDS COMMITTEE REPORT (AGM) 2023**

### OVERVIEW

The CORA Awards Committee was officially formed in 2020 and consists of current and ex-Officio Board Members who have responsibility for coordinating Canadian outrigger canoeing Awards including the *Peter Forand Masters Challenge Trophy* since 2016 and the *Hugh Town Memorial Builder Award* since 2019 and the *Canadian Outrigger Hall Of Fame* since 2021.

### **TRENDS / HIGHLIGHTS**

This section is a Summary of Awards Trends / Highlights:

- Minnie Fontenelle (Sand Point Outrigger Canoe Club) has continued to dominate PNWORCA OC1 Masters racing and has now won the *Peter Forand Masters Challenge* in 2023 and in 4 years of the PNWORCA Small-Boat Racing Winter Series.
- Canadian standings in the *Peter Forand Masters Challenge* have continued to improve with four Canadians in 2023 (Pam Watts Cornall; Bob Stewart; Ken Asano; Doug Thomas) finishing in the Top 14.
- Hugh Town Memorial Builder Award Nominations continue to be submitted and CORA has continued to hold in-person Hugh Town Memorial Builder Award presentations (Grace Morissette; Drew Mitchell; Don Mulhall; Jan Chavarie) with much decorum – many thanks to Ron Chin for his eloquent speeches.
- The Canadian Outrigger Hall Of Fame process (Awards Committee) and presentation (Town Hall Committee) cycle has continued for 3 consecutive years now with another Stellar Seven individuals (Ruth Matson; Nancy Botting; David Hill; Lynda Roberts; Norman MacDonell; Leanne Stanley; Len Morris Jr.) from across Canada Inducted in 2023, with hearltfelt speeches by many Guest Speakers.

### CHAIN-OF-CUSTODY

CORA Board recognizes the challenges in administering trophies based on experience with the CORA Cup Series trophies and various Dragon Boat BC trophies that CORA Board members have found themselves caring for over the years. CORA Board recognizes that trophies are an investment and should be tracked to avoid having to replace quite often irreplaceable mementos. CORA Board continues to maintain Chain-Of-Custody documents for the *Peter Forand Masters Challenge Trophy* and the *Hugh Town Memorial Builder Award* to ensure that the last known whereabouts can be easily determined. These Chain-Of-Custody documents have become part of the <u>Properties Registry</u> as of 2022 (found on the CORA Google Drive in the <u>Resources</u> folder).

### PETER FORAND MASTERS CHALLENGE

Peter Forand left a lasting impression on everybody that he met during his time with Lotus Sports Club and Jericho Paddling Club and Comox Valley Canoe Racing Club (CVCRC). The Canadian Outrigger Racing Association (CORA) website has a perpetual page dedicated to the memory of Peter Forand. https://canadianoutrigger.ca/community-2/peter-forand-masters-challenge-trophy/



Ross Creasy of Open Ocean Outrigger had a friendship with Peter Forand that spanned many years. After the passing of Peter Forand, Ross Creasy petitioned CORA and PNWORCA to commission a trophy to be awarded after the PNWORCA Small-Boat Racing Winter Series Championship race each year, to the top OC1 Masters (40+; 50+; 60+; 70+) paddler (female / male). This *Peter Forand Masters Challenge Trophy* was awarded in the 1st year (2017) to Peter Marcus (Kai Pana Outrigger Canoe Club), in the next 3 years (2018-2020) to Minnie Fontenelle (Sand Point Outrigger Canoe Club), in the 5th year (2021) to Beau Whitehead (Kikaha O Ke Kai), in the sixth year (2022) to Darian Hildreth (Friday Harbor), and in the current year (2023) to Minnie Fontenelle (Sand Point Outrigger Canoe Club). The hand carved wooden fish hook sculpture at the top of the trophy represents the deep connection and reverence that we have with the sea. The trophy does make an occasional appearance at a PNWORCA Winter Series race to honour the memory of Peter Forand.



The 2023 PNWORCA Winter Series proceeded as per the 2023 PNWORCA racing schedule with 7 events (Wasabi; Jericho; Mountain Home; Bellingham; Kai Ikaika; False Creek; Sail Sand Point). See the CORA Race Summary Report (AGM) 2023 for commentary on the 2023 PNWORCA Winter Series. Weather and COVID cooperated to allow all 7 events to happen in-person. Seven Canadians finished in the Top 3 in their Boat / Age / Gender division. Four Canadians (Pam Watts Cornall; Bob Stewart; Ken Asano; Doug Thomas) finished in the Top 14 *Peter Forand Masters Challenge* standings. Discussions between PNWORCA and CORA resulted in agreement that there was indeed an OC1 Masters paddler who dominated OC1 Masters paddling in all events.

The 2023 PNWORCA Winter Series winner for the **Peter Forand Masters Challenge** was Minnie Fontenelle (Sand Point Outrigger Canoe Club). in the Women Masters 50+ OC1 Division. The 2023 PNWORCA Winter Series event organizers recognized Minnie Fontenelle as the **Peter Forand Masters Challenge** winner in accordance with guidelines as the Female or Male Masters (40+ / 50+ / 60+ / 70+) paddler with the highest number of points across all age / gender brackets at the end of the PNWORCA Winter Series. The **Peter Forand Masters Challenge Trophy** was on the road again in 2023 for the Peter Marcus Farewell Tour as it made an appearance at 6 of the 7 of the 2023 PNWORCA Winter Series events, including the Bellingham Bay Outrigger Paddlers (BBOP) event, founded by Peter Marcus himself. And for the first time ever, the **Peter Forand Masters Challenge Trophy** winner was present and acknowledged at the PNWORCA Winter Series Championship event at Sail Sand Point.

### HUGH TOWN MEMORIAL BUILDER AWARD



The purpose of the *Hugh Town Memorial Builder Award* is to recognize volunteers who have made significant and exemplary contributions to the Outrigger Canoe Racing Discipline of Canadian Outrigger Racing Association (CORA) within Canada in the Builder Category.

She has made contributions to support Canadian paddlers at the international, national, provincial, and club level. Jan and web designer / developer Colleen McCarthy collaborated to build the Jericho Paddling Club website as well as the first and second generations of the CORA website. She has been part of the Jericho Paddling Club that has hosted the popular PNWORCA Jericho Small-Boat Racing Winter Series event and Jericho Classic Iron, as well as volunteered to assist with the Jericho Oceanman and the JSCA Wavechaser Paddle Series for many years. However, several outrigger canoeing scheduling changes in recent years have made this impractical. The Gorge OC6 race has moved to mid-July from early-July and the Gorge Downwind Championships now follows the Gorge OC6 race 1 week later, and these 2 events are well attended by Canadian paddlers. IVF World Sprints / Distance Championships are now occurring every year in mid-August, meaning that Team Canada paddlers are away for most of the end of August every year. These scheduling changes have led the Awards Committee to make best efforts to present the trophy to the most recent Recipient at a mutually convenient time / place. A small ceremony was held on a stormy morning in March 2023 at Vanier Park at the conclusion of the 2023 FCRCC Winter Series event with CORA Chairman (Ron Chin) making the presentation to Jan Chavarie (2022 Recipient) with the FCRCC palm trees as a backdrop. The Hugh Town Memorial Builder Award 2023 Recipient is to be announced at the 2023 CORA AGM.

### **CANADIAN OUTRIGGER HALL OF FAME**

CORA gave this proposal serious consideration. CORA evaluated the policies / processes of the Major League Baseball Hall Of Fame, BC Sports Hall Of Fame, Ontario Sports Hall Of Fame, NHL Hall Of Fame, and Dragon

Boat Canada Hall Of Fame to arrive at a policy / process that would make this *Canadian Outrigger Hall Of Fame* a meaningful endeavour and that those individuals inducted in the inaugural year would set the bar for nominees in future years. It took the CORA Board four months to arrive at a vision that was unanimously approved via a CORA Board Meeting Motion.

#### This *Canadian Outrigger Hall Of Fame* has a mandate that can be summarized as follows:

Canadian Outrigger Racing Association (CORA) recognized that there were many individuals who had made "Significant and Exemplary Contributions" to Canadian outrigger canoeing, but their stories had never been captured, and they had never been formally recognized. CORA spent early 2021 tracking down this history, and fact-checking as best as possible the exploits of those individuals who founded CORA, who founded CORA clubs, who were coaches / builders with CORA clubs, who inaugurated races, who excelled at IVF / Molokai / Catalina / Queen Liliuokalani events, and who designed / built / imported / distributed canoes to grow the sport.

The CORA website has a perpetual page dedicated to the *Canadian Outrigger Hall Of Fame* where one can view the Bios of the 2021 Inductees (Jackie Webber; Rick Nu'u; Peter Forand; Hugh Fisher; Sheila Kuyper; James Van Nostrand; Don Irvine; David Boulding; Mel Whittall; Heather Taylor; Drew Mitchell; Garry Mancell; Bob Disbrow; Cheryl Skribe; Alan Carlsson; Jim Mancell; Ron Kaschula; Annie Boulding) and the 2022 Inductees (Andrea Dillon; Wendy Rae-Perkins; Rosemary Henry; Grace Morissette; Don Mulhall; Kamini Jain) and the 2023 Inductees (Ruth Matson; Nancy Botting; David Hill; Lynda Roberts; Norman MacDonell; Leanne Stanley; Len Morris Jr.) that should provide the level of credentials CORA takes into consideration for nominees. https://www.canadianoutrigger.ca/community-2/canadian-outrigger-hall-of-fame/

Lotus had graciously offered to host a Canadian Outrigger Hall Of Fame presentation at their 2023 CORA Cup Series Championship event. Unfortunately, all of the 2023 Inductees were already committed to other activities on that weekend. However, CORA did arrange for in-person presentations of the **Canadian Outrigger Hall Of Fame** plaques by local speakers for Ruth Matson and Nancy Botting and David Hill and Lynda Roberts and Norman MacDonell and Leanne Stanley and Len Morris Jr. at close to home venues.

CORA hosted an online Town Hall session in Nov-2023 for the Inductees spread across Canada and the rest of the world. The Inductees and Guest Speakers included Ruth Matson, Nancy Botting, David Hill, Lynda Roberts, Norman MacDonell, Leanne Stanley, Len Morris Jr., Heather Taylor, Andrea Dillon, Ron Williams, Wendy Rae-Perkins, Janet Davis, Alan Thompson, Donna Harrison, Kristine Malmqvist, "Uncle" Leonard Kimokeo Kapahulehua, Mhairi MacDonell, James Hill, Zoe Norcross, Melanie Conard, Rita Morris, Gordon Martinez and several other luminaries. ### PETER FORAND MASTERS CHALLENGE ADMINISTRATION

PNWORCA Executive is responsible for administering the PNWORCA Winter Series Race Results and communicating standings in each boat / gender / age division. It is important that CORA and PNWORCA Race Directors communicate PNWORCA Winter Series Race Results in a timely manner and consistent format to the PNWORCA Race Chairman. Administration of the *Peter Forand Masters Challenge* standings adds a level of complexity due to the consolidation of all female / male OC1 Masters (40+ / 50+ / 60+ / 70+) into a single division. CORA Board has taken the lead on PNWORCA Winter Series Race Points for the *Peter Forand Masters Challenge* standings and collaboration with the PNWORCA Race Chairman since 2017. There is a Series Points Template to assist with this process. There should be a knowledge transfer for this process.

### HUGH TOWN MEMORIAL BUILDER ADMINISTRATION

The procedure for administration and bestowing is well-documented. This is still a novel process and is steadily becoming ingrained in CORA Board business-as-usual with an expectation that this should happen on an annual basis. An individual should be tasked with ensuring that the procedures are followed going forward.

### CORA AWARDS VENDORS

Note that Kerr Recognition Services Inc. in Vancouver BC has provided trophies and glass awards and medals for CORA for many years. There are many recognition services vendors that provide comparable products / services. However, the proprietor (Sae Kerr) and the designer (Ross Lawton) have collaborated with CORA for many years and provide exceptional service and maintain records of design work and invoices going back to the 1990s. A recent change in business operations for Kerr Recognition Services means that when plates / shields on trophies require engraving to commemorate the current year Recipient, these plates / shields are now outsourced to a third-party vendor and CORA must replace the existing plates / shields that are affixed with double-sided tape.



## **CORA RACE REVIEW REPORT (AGM) 2023**

### OVERVIEW

The CORA Board never lost sight during the COVID Pandemic of the CORA Mandate to "*foster and develop the sport of outrigger racing in Canada*". The CORA Race Committee and the CORA Board had collectively strived to keep the membership engaged with virtual racing options, establish vendor / sponsor relationships for prizing, and pursue initiatives to grow the sport once "Return To Sport" became more tangible. This downtime to plan for the future has resulted in the 2023 CORA racing season having participation vastly exceed previous years.

### **TRENDS / HIGHLIGHTS**

This section is a Summary of Racing Trends / Highlights:

- Race participation in 2023 has now returned to & exceeded COVID Pre-Pandemic race participation levels.
- There have been concerns raised that there has been <u>limited inter-regional travel (Vancouver Island; Sunshine Coast; Lower Mainland; Okanagan / Interior) for races</u>, but empirical analysis from 2022 & 2023 has shown that inter-regional travel has actually increased, but there are several other trends taking place:
  - Crews have continued to hugely support gender & mixed mid-distance host-club-provided-OC6 events.
  - CORA Clubs have continued opting out of trailering Traditional OC6s to distance races and instead have trailered / truck-topped their own Unlimited OC6s or have paddled their own OC6s to events at neighboring clubs when possible or have relied on borrowing / sharing Traditional OC6s and/or Unlimited OC6s from the host club or other attending clubs. This has become a concerning trend given that CORA has increased the annual Travel Grant budget only to have many clubs with their own OC6s and OC6 trailers rely on other clubs to provide OC6s for them to race with.
- Support for and participation in the Junior / Novice OC Paddle Initiative was strong once again in 2023 with <u>85</u> participants and another 8 Junior / Novice winners receiving OC Paddle Gift Certificates.
- Support for the CORA Cup Series Event Prizing (Swag) Initiative was strong once again in 2023 with CORA Cup Series Host clubs spending the budgeted amount (and more) on random draw prizes purchased from their own vendors / sponsors or from a set of CORA vetted vendors / sponsors.
- CORA Board continues to support small-boat racing by providing subsidized Small-Boat Racing Number Decals at zero cost to host clubs.
- CORA has continued to engage with many Canadian vendors / sponsors to provide merchandise / services to the Canadian outrigger canoeing community at discounted pricing.
- Inconsistent event registration systems / rules across the 2 BC & 5 Washington / Oregon Winter Series event host clubs has continued to cause issues in tracking PNWORCA Small-Boat Winter Series standings (See table).
- V1 ownership & race entries have continued to grow as more paddlers embrace V1 for IVF Sprints / Distance.
- The CORA OC6 distance racing window has continued to be boxed into May & early-June & late-July due to several factors including, prime-time dragon boat racing season running early-May to late-June, The Gorge and the Gorge Downwind Champs now held on back-to-back weekends in early-July, and IVF Sprints / Distance now held every year sending Team Canada paddlers away from early-Aug to late-Aug.
- Eastern Canada CORA clubs have continued to travel long-distances (Parry Sound-GTA; Ottawa-GTA; Montreal-GTA) to participate in Eastern Canada outrigger canoeing events (Oakville; Toronto).
- Eastern Canada outrigger canoeing events (Wai Nui; Ottawa; Toronto) have continued to see increased participation by non-CORA club paddlers: Mississauga Canoe Club (MCC), Outer Harbour Dragon Boat Club (OHDBC), Canadian Senior Dragon Boat Club (CSDC), New Dragons Outrigger Club (NDOC), New Dragons Racing Club (NDRC), Wahnapitae, NPNP?.

### JUNIOR / NOVICE OC PADDLE INITIATIVE

CORA Board introduced a new initiative for 2022 at the 2021 CORA Pre-AGM. To encourage participation by new paddlers at 2022/2023 CORA events, a new Junior / Novice OC Paddle Draw Grant was funded. Every Junior / Novice participant at each 2022/2023 CORA Cup Series event was given 1 entry for the end-of-season draw. It was possible for each Junior / Novice participant to have up to a maximum of 4 entries for the end-of-season draw. The response was impressive with 85 entries in total from 7 Western Canada OC clubs. There were at least 8 entries in each of the Junior Women, Junior Men, Novice Women, and Novice Men divisions such that 2 winners were drawn from each of these 4 divisions.

CORA Board wishes to extend a round of appreciation to Oddball Workshop, our generous sponsor, for contributing Gift Certificates for each of the 8 Junior / Novice winners to redeem for a paddle of a length and design of their choosing within 1 year from the end-of-season draw date (23-Jul-2023).

CORA Board wishes to extend a round of appreciation to the Race Coordinators (Don Mulhall; Jackie Bell; Carole Fullerton; Grace Morissette) from CORA Cup Series host clubs Penticton, Comox, Jericho, and Lotus, as well as all the club reps who collected the names of Junior / Novice participants at these 4 events, and forwarded these entries onto the CORA Board for the draw at the Comox Awards presentation. https://www.canadianoutrigger.ca/cora-2023-junior-novice-oc-paddle-draw/

## CORA CUP SERIES EVENT PRIZING (SWAG) INITIATIVE

CORA Board introduced a new initiative for 2022 at the 2021 CORA Pre-AGM. To improve the "event quality experience", a new CORA Cup Series Event Prizing (Swag) Grant was funded. This initiative involved a budget for each of the 4 Western Canada 2022/2023 CORA Cup Series events. Each event host had a budget of \$800 to spend on random draw prizes purchased from their own vendors / sponsors or from a set of CORA vetted vendors / sponsors and to conduct one or more random draws throughout the OC6 distance event. The type and number of random draw prizes varied for each of the Penticton, Comox, Jericho, and Lotus events. However, the event participants communicated that they believed this was a worthwhile initiative.

### CORA FLAG BANNER PUBLIC RELATIONS INITIATIVE

CORA Board embarked on an initiative for 2022 to improve our presence at local and international events. CORA purchased high-quality flag banners with signage in English / French. These flag banners were acquired in mid-April 2022 and have been displayed at many CORA Sanctioned Events in 2022/2023.

### SMALL-BOAT RACING SUPPORT

CORA Board continues to support small-boat racing by providing subsidized Small-Boat Racing Number Decals at zero cost to host clubs. At each AGM, CORA distributes blocks of CORA Small-Boat Number decals to those Club Representatives and Board Members in attendance from Vancouver Island, Lower Mainland, Okanagan / Interior clubs. The goal is to have an inventory of CORA Small-Boat Number Decals in the hands of clubs hosting small-boat events in the coming year. The process for acquiring new CORA Small-Boat Racing Numbers from the long-term vendor has been documented and saved to the CORA Google Drive for Business Continuity.

### FIRST NATIONS REPRESENTATION

First Nations clubs / paddlers participation with CORA was very notable in 2023. First Nations paddlers from Star Nation, Geronimo, Island Brave, Proud Mary, Wahnapitae, and several other clubs attended and did very well at 2023 CORA sanctioned events including many of the gender & mixed mid-distance host-club-provided-OC6 events,

Penticton Iron, Jericho Iron, Comox Iron, Lotus Iron, and TIOC. CORA continues to reach out to First Nations clubs to become CORA clubs and be part of Team Canada for IVF World Sprints / Distance events.

### EASTERN CANADA OUTRIGGER CANOE RACING SUPPORT

CORA Board had discussions with several Ontario / Quebec clubs to restore the Eastern Canada Waterway Series for 2023. Ottawa River Canoe Club (ORCC) had intended to host the Ottawa River Paddling Challenge (ORPC) as a CORA Sanctioned Event, but opted to go with their own insurance provider. Toronto International Outrigger Challenge (TIOC) did return in 2023, but not as a CORA Sanctioned Event. CORA continues to reach out to unaffiliated Eastern Canada clubs (Onake; Ottawa River; Mississauga Canoe Club; Pickering; Wai Nui) to join with CORA and host CORA Sanctioned Events to support the growth of Eastern Canada outrigger canoe racing. https://www.tioc.ca/2023-results

### **PNWORCA SMALL-BOAT RACING WINTER SERIES**

The 2023 PNWORCA Small-Boat Racing Winter Series proceeded as per the 2023 PNWORCA racing schedule with 7 events (Wasabi; Jericho; Mountain Home; Bellingham; Kai Ikaika; False Creek; Sail Sand Point). The 2023 PNWORCA Small-Boat Racing Winter Series was able to have all 7 events in-person as per the posted schedule despite many extreme weather events.

Inconsistent event registration systems / rules across the 2 Canadian and 5 Washington / Oregon Winter Series event host clubs has continued to cause issues in tracking Winter Series standings. Host clubs are using Webscorer or PaddleGuru or Pacific Multisports or Google Sheets for event registration. CORA and PNWORCA have different **nomenclature** (Golden Master; Kapuna) and **ranges** (50-54; 55-59; 50-59; 60-65; 60-69) and **cut-offs** (birthday; birthyear) for Age Divisions. The result has been participants registering in different Age Divisions across the Winter Series and impacting Division standings. This situation has been prevalent for many years and will continue going forward with each of the host clubs using different event registration systems.

The PNWORCA Race Committee no longer tracks Small-Boat Racing Winter Series points and the Small-Boat Racing Winter Series Championship event host no longer recognizes Division Top 3 Finishers. However, the CORA Race Committee continues to track Small-Boat Racing Winter Series points so as to recognize Canadians who are among the Top 3 Finishers in a Boat / Gender / Age Division and to continue the tradition of the *Peter Forand Masters Challenge Trophy*.

The PNWORCA Small-Boat Racing Winter Series is not only about putting in miles on the water, but also about putting in miles on the highway, as the 2023 season saw 7 races contend with Winter storms in Vancouver BC, Portland OR, Bellingham WA, and Seattle WA. There were 417 entries across a7 races. There was one individual who dominated OC1 Masters paddling in all 2023 PNWORCA Small-Boat Racing Winter Series events. Minnie Fontenelle of Sand Point Outrigger Canoe Club (SPOCC) was recognized as the 2023 **Peter Forand Masters Challenge Trophy** recipient and once again joins Peter Marcus, Beau Whitehead, and Darian Hildreth as recipients of this award. https://www.canadianoutrigger.ca/mignon-fontenelle-sand-point-outrigger-canoe-club-wins-2023-peter-forand-masters-challenge/

## **VENDOR / SPONSOR RELATIONSHIPS**

CORA has continued to engage with many Canadian vendors / sponsors such as Oddball Workshop, Coast Outdoors, Predator / XS Unified, St. Jean's Cannery, Spirit Bear Coffee, Waterfront Outfitters, Main Street Brewing, Purdy's Chocolates, Perfectly Nuts, Kerr Recognition, and North Water to provide merchandise / services to the Canadian outrigger canoeing community at discounted pricing. CORA also strives to support Indigenous businesses as well, including St. Jean's Cannery and Spirit Bear Coffee. CORA has also established relationships with many licensed food / coffee wagon vendors who are able to provide catering at CORA Sanctioned Event venues around the BC Lower Mainland. These local vendors / sponsors provide merchandise / services to CORA in exchange for promotion on CORA social media and an opportunity to showcase their merchandise / services to the paddling community as CORA vetted vendors / sponsors.

### **RACE RESULTS**

- Clubs are encouraged to submit Race Results in formats that are <u>conducive to ease of reformatting for data /</u> <u>trend analysis</u> (CSV; XLS; TXT; WORD), with the confidence that these Race Results will be posted to the CORA website in PDF format.
- Race Results continue to be collected and reported in various formats including PDFs and Google Sheets and WebScorer and Images and unformatted emails.
- CORA hopes to address this concern by introducing a standardized Race Results template that will facilitate CORA Cup Series Points tracking and reporting.
- With the new CORA website and a reorganization of content, for 2020/2021/2022/2023 and going forward, Race Results PDFs are now named as YEAR Club Event (2023 FGPC Wet-Dashe):

## **TRADITIONAL / UNLIMITED OC6 SCHISM TREND**

There has continued to be a growing "Traditional / Unlimited OC6 Schism" whereby CORA Sanctioned OC6 Distance Event host clubs should plan for participation based on the number of Unlimited OC6s that are available. This assertion is supported by empirical analysis as per the table of 2023 participation at all big-boat events. Hosting Traditional OC6 Mid-Distance "canoes-provided" races is proving to be a winning formula.

- There is a continued reluctance to trailer / race Traditional OC6s for long-distance races.
- This "schism" is deterring many clubs (VOS; DZPC; Delta; FLCC; Harrison; Penticton; Kamloops; Nanaimo; Maple Bay; Sproat Lake) without Unlimited OC6s and unable to borrow Unlimited OC6s from doing CORA long-distance races (unless they can do a short-course in Traditional OC6).
- There were no 2023 CORA Cup Series Short-Course contenders.
- There is becoming a "Haves" and "Have-Nots" split. There are 6 Vancouver Island clubs (Latitude 48; Fairway Gorge; Geronimo; Island Brave; Comox; Wolf Pack) that have 12 Unlimited OC6s, while there are 7 Vancouver Island clubs (Pearson; VIP; VCKC; SLCC; Maple Bay; NOPC; NPC) that have Zero Unlimited OC6s. There are 4 Lower Mainland clubs (Jericho; Pac Reach; FCRCC (5); Lotus; that have 8 Unlimited OC6s, while there are 8 Lower Mainland clubs (VOS; DZPC; Delta; FLCC; Harrison; SNCC; Pemberton; Gibsons) that have Zero Unlimited OC6s. There are 4 Interior / Calgary clubs (KPC; Vernon; Calgary) that have 6 Unlimited OC6s.
- There is becoming a reality where only clubs / crews with Unlimited OC6s or who are able to borrow Unlimited OC6s are doing CORA Distance Long Course races, while those clubs / crews without Unlimited OC6s are doing only the "canoes-provided" races such as IceBreaker V12; FGPC V12; March Madness; FLCC Spring Run; Waterman; Poker Paddle; Bridges; Wet-Dashe.
- Note that this is a PNWORCA "schism" as well with 8 PNWORCA clubs (Silverdale; Rikkole Cree; Bellingham; Kai Pana; Sand Point; Seattle Outrigger; Kikaha; Mountain Home; Hood River) that have 14 Unlimited OC6s, while there are 10 PNWORCA clubs (Puget Sound; Autumn Rose; Wakinikona; Bridge City; Wasabi; Kai Ikaika; Columbia River; Bend; Tri-Cities; Pacific City) that have Zero Unlimited OC6s.

### INTER-REGIONAL RACING TRAVEL CONCERNS

There have been concerns raised that there has been limited travel for races between Regions:

- Vancouver Island to Lower Mainland and Interior / Okanagan and Sunshine Coast
- Lower Mainland to Vancouver Island and Interior / Okanagan and Sunshine Coast
- Interior / Okanagan to Vancouver Island and Sunshine Coast and Lower Mainland
- Sunshine Coast to Lower Mainland and Vancouver Island and Interior / Okanagan

However, any perception that clubs from any one region are doing more or less inter-regional travel than clubs from another region does not appear to be substantiated. This assertion is supported by empirical analysis as per the table of 2023 participation at all big-boat and small-boat events.

### 2024 PLANNING

CORA Event Sanctioning requests will continue to be accepted until April 2024. However, CORA Board recognizes that clubs should be able to submit Event Sanctioning requests up to 2-3 weeks prior to their proposed event date as long as the proposed event date does not conflict with other prioritized CORA Sanctioned Events. CORA will be actively pursuing an Eastern Canada CORA Cup Series to engage Ontario / Quebec clubs and paddlers. CORA may be actively pursuing a BC Lower Mainland Sprints Regatta event this coming year at a BC Lower Mainland venue subject to interest by the paddling community.
